You may have heard of a Mt Wellington doctor's surgery being involved in community transmission of Covid 19. I visited that surgery on July 28th and was seen by that doctor who is an eczema specialist.

Thank you for getting in touch. I'm aware of the very serious issues surrounding this proposed apartment block and really appreciate you emailing me with greater detail. I have been discussing this matter with the local MP Erica Stanford who is also well across the matter, and has had a few meetings with <sup>s7(2)(a): Privacy of natural persons</sup> [\[redacted\]](#). I have copied both Erica and <sup>s7(2)(a) Privacy of natu</sup> [\[redacted\]](#) into this email.

I am aware that the developers have purchased one piece of land and are seeking approval to purchase two other sections of land, the application (for both) is being investigated by the Overseas Investment Office. Erica has been in touch with the OIO and the most recent update from them is that they are continuing their assessment of the application, which they have some concerns about. I understand that last year Erica gathered support from 50+ neighbours in the area who shared concerns about the proposed development. As a result, Council staff apparently gave their assurances that any meetings or applications about the proposal would be discussed with the local neighbourhood and her office. I am therefore concerned about the pre-application meetings between Council and the developer that you mention in your email – if you have any further details about when these meetings occurred that would be useful to know.

I will contact Council for further information about the meetings. From my perspective, I think the most important and constructive thing to do at this stage would be to facilitate a meeting with the local neighbours, relevant Council staff. I will speak to staff about this and come back to you and others.

Thank you again for the information you've shared, I will be in touch soon.

Hello Victoria and Alexis.

I hope the new year has started well for you.

Victoria, you may recall that we met at the sod turning for the Silverdale

park and ride just before Christmas in my role as s7(2)(a): Privacy of natural persons

My brother-in-law s7(2)(a) Privacy of natur mentioned he had talked to you both about mutual

concerns with the Council consenting processes without public notification

and particularly in relation to the Terrace Housing and Apartment Block

zoning (THAB)- Chapter 6 in the Auckland Unitary Plan (AUP).

I am writing to you to make you aware that my wife and I are too, very concerned about this and currently face the threat of inappropriate develop

under this zoning undermining our own amenity and property value.

First the recent history.

In 2012 we finished a major renovation of the home for our retirement at [redacted] P [redacted]

In 2013, s7(2)(a): Privacy of natural persons and the coast) was put on the market as [redacted] s7(2)(a) Privacy of natural persons. Because of the new THAB zoning looked imminent under the proposed AUP and development would have wrecked the outlook from our property we invested our retirement savings in purchasing [redacted] s7(2)(a) Browns Bay Road.

We could not afford to also purchase [redacted] s7(2)(a) as well. We were not too concerned about that because it is a very constrained site with a net site area of only 332 square metres and the AUP also required that there be a transition to the single dwelling zone [redacted] s7(2)(a) Privacy Browns Bay Road. Further we expected the 4m wide public walkway ( which has previously been referred to as a plantation reserve) to further reinforce the AUP policy of a transition between intense and low density zones in the interest of public amenity. We saw the combination of these two controls making a 4 or 5 story development impracticable if not impossible on [redacted] s7(2)(a) Browns Bay Road thus avoiding the worst ravages of the THAB zone. ( The attached aerial photo shows [redacted] s7(2)(a) in yellow marking).

On that basis we undertook a major renovation of [redacted] s7(2)(a) Browns Bay Road and it now provides much of our retirement income as a rental property. This elevated property is rather unique as it enjoys close views of the Taiaotea Stream, views North down Browns Bay beach and reserve as well as views out to the Hauraki Gulf although these are partial because of the large trees on the reserve at [redacted] s7(2)(a) Browns Bay Road. The views North are very important feature and amenity of this property.

What the AUP says.

I now refer you to the attached diagram of the building control profile for  
[redacted] Browns Bay Road looking North from [redacted] Browns Bay Road.

The green profile is the standard HIRB ( height in relation to boundary) for side yards in the THAB zone. This is the maximum profile that we thought would apply because of the transition policy and that any complying development would only obscure part of the close view of the Taiaotea Stream.

The AUP, however, now defines the 4m wide public walkway separating [redacted] Browns Bay Road as a road giving it the same status as a standard 20m wide road reserve. This is a lazy one size fits all definition that has no foundation under the RMA but has enormous consequences. Under the AUP any road frontage is regarded as a front yard and this makes the East boundary of [redacted] Browns Bay Road a front yard rather than a side yard.

This means that the pink profile would have applied to this boundary allowing a full 16m height 1.5m in from that boundary. Fortunately for us this is mitigated because the transition requirements of the AUP kick in and the blue profile governs along the walkway boundary.

Regardless, the lazy definition of the walkway as a road in the AUP means that any new building will obscure much more of the close view enjoyed by [redacted] Browns Bay Road for no good planning reasons- please see notes on the impact on views and amenity at top RHS of the profile diagram. This situation is a windfall for the developer, a disservice to the many people who use this walkway and a negative impact on the amenity of [redacted] Browns Bay Road.

The AUP also has what is called an alternative standard for HIRB for

side  
yards within 20m of a front yard and this is shown as the orange  
profile for  
the Western side of the property. There is a double whammy for <sup>s7(2)(a)</sup>  
Browns Bay  
Road because it now has two front yards allowing the alternative  
standard to  
be applied to the common boundary between <sup>s7(2)(a) Privacy of natural p</sup> browns Bay  
Road bringing  
any tall building on <sup>s7(2)(a)</sup> closer to the latter. There is a very big  
difference  
between the standard and the alternative standard with very  
significant  
consequences for neighbouring properties.

Council may apply the alternative standard to "enable better design"  
without  
any notification to affected neighbours. The question is better design  
for  
whom - the developer or the neighbourhood? There is no clarity in  
the AUP as  
to guidance on how the alternative standard should be applied.

What has been going on.

As you would expect we have been writing to Council over the last  
two and a  
half years trying to confirm what rules do apply to this site and to urge  
the Council to stick to them because we are entitled to rely on them  
to  
preserve our amenity and property value.

Our letters have been placed on the relevant property files but it has  
been  
up to us to regularly contact Council to see if any resource consent or  
building consent applications have been made for a development on  
<sup>s7(2)(a)</sup> Browns  
Bay Road.

In July 2019 we found out that the developer had held a pre-  
application  
meeting with Council in regard to a 5 storey apartment block on the  
site,  
but of course Council could not reveal what was discussed.

Fortunately for us the developer had given a set of plans to the

owners of <sup>s7(2)</sup>  
Browns Bay Road (who are also very concerned about what could happen on <sup>s7(2)(a)</sup>  
Browns Bay Road). Those plans showed a proposal that was slightly over height but generally complied with the blue and orange HIRB controls.

This proposal, however, did involve site coverage 20% higher than the maximum designated for this zone - which is 50% of net site area being the gross site area less any ROWs over the site. The 4th and 5th storeys of the proposal rely on the alternative standard applying to the west boundary and 20% excess site coverage being permitted by Council.

We understand that neither of these conditions trigger a notified consent process under the AUP but the impact on us and our neighbours is far from minor in our view. Of course we wrote again to Council pointing out our concerns.

We also continued to regularly check with Council to see if any applications had been made.

In December we were learnt that the developer had again had a pre-application meeting with Council. At the same time the owners of <sup>s7(2)</sup>  
Browns Bay Road approached us because they had received a set plans of the new proposal about which they were very concerned. The developer was also pushing them hard to formally agree with the proposal and advise Council. They gave us a copy of the plans of the latest proposal.

That proposal seeks Council to allow a development to the pink profile on the East boundary, an overall over-height of 1m and a 40% excess site coverage. This is indicated by the purple profile on the attached diagram.

Our interpretation of what is going on is that:

1) The council apparently sees merit in the full 5 storey proposal and at the July pre-application meeting has encouraged the developer to redevelop their plans into a more extensive development well outside the rules.

2) Council has advised the developer that as owners of <sup>s7(2)(a) Privacy of nat</sup> Browns Bay Road we are not affected and have advised the developer to seek the approval of the owners of <sup>s7(2)</sup> Browns Bay Road only. ( Council's reasoning is probably that allowing the pink profile only offends the blue profile which is in place for the protection of the lower zoned <sup>s7(2)</sup> Browns Bay Road).

3) The alternative standard on the western boundary is being applied to enable a completely different scale of development not just "better design".

4) The site coverage rule is being abandoned to facilitate a much greater development than should be allowed on such a small site.

5) The rules we rely on to protect our amenity and property value are being put to one side on the untested value judgement of a council Planner under pressure from the developer.

We did ask Council whether such an application would be publicly notified and they said that decision would be made when and if a formal application was made which has only escalated our concerns - hence this email to you.

We need to be able to have our say on this through a formal notified process in regard to any resource consent for <sup>s7(2)(b)</sup> Browns Bay Road.

Anything you can do to get Council to favour the notified application path



would be much appreciated.

We are well aware there are many concerned property owners grappling with the potential impacts of the THAB zone in East Coast Bays and we certainly supported the petition initiated by our MP Erica Stamford at the end of last year to have resource consent applications in the THAB zoning publicly notified.

We are hopeful that our specific example provides a very good demonstration of how the rules of the THAB zone can be manipulated to the severe detriment of neighbours. We would be pleased to discuss this with you if that is helpful.

This agent is representing a developer who has agreed to buy [redacted] Browns Bay Road (however [redacted] is with the OIO). See attached diagram/map

The project is probably only economically viable with Beechwood as an access due to the steep terrain off Browns Bay Road to the properties, so they have been trying to buy up surrounding properties using scare/intimidation tactics against two Beechwood properties.

When negotiations fell through with [redacted] Beechwood they put up the sign which we think doesn't conform with the REA guidelines – ie misleading advertising, I am having an architect check this. The point is to scare that property into selling due to the impact the building work and final building will have on their property which she had described to me as her forever home. The sign shows a property that will tower probably almost 10 stories over the Browns Bay CBD. They have also removed carparks from the roadside in this picture.

However I believe that the project as shown is not viable/ won't get consented – so I believe they used the advertisement to scare the owner of [redacted] to sell.

The owner of [redacted] Beechwood has been approached by the agent, [redacted] described [redacted] as intimidating in [redacted] approach. [redacted] will be available for comment.

We already have a group of at least 20 local residents against this development in our area which I believe has been misappropriately rezoned in the unitary plan – see attached information. Our group will expand considerably as we have only begun hastily organising.

I think the council has almost no idea about town planning. Browns Bay is being heavily developed due to its “town centre status” but its not connected with proper infrastructure to deliver high speed public transport to compete with cars. Therefore congestion in this area is going to dramatically increase. Parking etc for local dog walkers and users of one of Aucklands most popular beach is going to become extremely difficult.

Local people clearly did not understand the implications of the unitary plan which seems to have bamboozled most of Auckland and that’s why they didn’t fight it at the time.

More housing in Auckland needs to be built intensively around high speed transport hubs – not around random urban sprawl locations.

Our local MP Erica Stanford is going to be supporting us in this fight and I believe she would be happy to comment / be part of the story. Erica suggested that we offer this story to you exclusively as a starter.

Just to close the loop I am aware Barbara Heise sent an email update yesterday, extract below detailing the reasons for the delay in getting the light turned on and have been chasing Vector almost daily for the last month and have yet to have a confirmed date for the upgrade of the power supply.

“Community Facilities had a project added to their work programme in financial year 2018/2019 for the renewal of two footbridges and the relocation of lights.

With Healthy Water delivering the “Taiaotea Reserve Environmental Enhancement” project at the same time at Sherwood Reserve, a decision was made that delivery of all work would be aligned and that the work is led by Healthy Waters. Key contacts at Healthy Waters are Peter Brooks and Leighton Gillespie.

Healthy Waters has been working with Vector to have those lights connected and a contract is being finalised at the moment and should be signed later this week (just pending some queries on easement).

Vector will schedule and deliver the works usually 4-5 weeks after the contract was signed. We will urge Vector to schedule the works sooner but ultimately it is up to them when they deliver the works.

If you continue to receive queries about the lights, please contact Leighton Gillespie in the first instance for further updates.”

Can you please advise me who I should contact in regards to their questions? I wasn't sure if it was Council, Neil (who is investigating the three lights in front of the block of shops), or you.

I have been meaning to email you about the work at Sherwood Reserve, Browns Bay. It has possibly been unfinished with the lighting for about 3 years now?  
I appreciate there has been Covid lockdowns etc and it's been tough times for lots of people.

My husband and I walk at s7(2)(a) Priv down Walnut Lane and then by the stream, turning left to head up for Glencoe Road, passed Redwing etc.  
We have noticed for a while now that there are approximately 10 lights that have still not been connected yet. (I'm not sure if there are further down to the right of the reserve – they were the only ones I could see walking)  
It is dark in a morning and they are actually needed. Also, the protective steel fencing left around them will be rented to the Council and costing rate payers an incredible amount!! The contractors who hire out to the Council must be so happy as they have been there so long!  
Do you know why it has just been abandoned that project? It's actually getting ridiculous to be

honest and a total waste of rate payers' money! Whoever is in charge of Sherwood has done an incredibly bad job at project management! It must be way over the budget by now!

I heard that contractors on that project would finish early on a Friday and then do overtime on a Saturday – more waste of rate payers' money!

Unfortunately, no one cares in the Council – no wonder rates are so high, so many projects around Auckland really badly managed and public money wasted!

Look forward to hearing back from you.

Hope you can investigate with the Council and get this job finished - what is the hold up after 3 years?

## **Recovery Budget proposal focused on COVID rebuild**

Mayor Phil Goff today released the Mayoral Proposal for Auckland Council's 10-year Budget.

The Recovery Budget, which will shape spending for the next decade in the city, prioritises:

- Auckland's recovery from the impacts of COVID-19
- Maintaining and renewing community assets
- Protecting the environment and responding to climate change.

"This Recovery Budget aims to meet the challenges posed by COVID-19 and the massive financial impact it has had on the city, while ensuring that the burden on ratepayers is kept as low and fair as possible," said Mayor Goff.

"This not a slash and burn budget

but it's also not the budget we had hoped to put out at the start of the year. We have to accept that COVID has changed our financial landscape and change our plans accordingly.

“However, we will strive to deliver the essential services that Aucklanders rely on and maintain the critical investments in the infrastructure our city needs, and which will play a vital role in stimulating economic recovery.”

"The Recovery Budget I am proposing responds to the unprecedented \$1 billion loss in revenue caused by COVID-19 by:

- Locking in savings of at least \$90 million each year for the next 3 years
- Selling surplus properties to invest in critical infrastructure
- Temporarily increasing borrowing for the first three years, thereafter, returning to the current level
- Retaining the long-term commitment to a 3.5 per cent rates increase. To respond to the COVID-19 crisis, this proposal includes a one-off rates increase of 5 per cent to be introduced for the next financial year only, as an interim measure, before returning to 3.5 per cent the following year

“Without a suite of measures to counter the \$1 billion financial hole caused by COVID, our city will



go backwards,” said Mayor Goff.

“We don’t want a city full of potholes and unkept parks, so we need to take more urgent action now.

“While not all Aucklanders will be thrilled with a one-off rates bump of \$36, it is a one-off measure that amounts to less than 70 cents a week for the average property. This increase will allow us to do more in transport infrastructure including addressing road safety, further drought proof our city, continuing our response to climate change, protect our kauri trees and maintain our parks and sports fields.

“The extra \$36 per household for one year will mean we maintain a spend of \$31 billion in our capital infrastructure programme. That is compared to the \$26 billion we had put aside in the 2018 10-year budget.

“Now is not the time to cut back on fixing our city’s infrastructure. We have been catching up on decades of underinvestment through our previous 10-year Budget and were making significant progress on our infrastructure deficit. We cannot allow that momentum to be wasted.

“While the immediate focus of the first three years of the Recovery Budget is responding to the COVID crisis, we are well aware of the increasing threats posed by

climate change.

“In response, we are immediately stopping the purchase of diesel buses, enhancing tree planting and reducing black carbon in our city centre.

“While this is by no means the end of the work Council will do to combat climate change, it is a critical step on the issue that will be our biggest legacy to future generations.

“I acknowledge that this budget will not be all things to all people. Many people would have liked to see us do more or, conversely, cut more. However, I believe we have found the right balance between ensuring our city is making the quickest possible recovery from COVID but also recognising that many Aucklanders are going through some incredibly tough times.

“We are all navigating uncharted waters but what we do now is vital to the progress of our city.”

Finance and Performance Committee chair, Councillor Desley Simpson, says, “We will continue to focus on providing value for money to Aucklanders. With our emergency budget, we committed a record \$120 million in savings, and across the next three years we will increase that amount to \$270 million. We know we must continue to do more with less.

“It is important that we strike the right balance between providing adequate investment into our aging infrastructure, while continuing to focus on finding efficiencies and further savings across our business. This means making hard decisions, like cutting staff numbers, but our

bottom line will always be to provide stability and manage our finances prudently.”

Deputy Mayor Bill Cashmore agrees: “This budget proposal is the most difficult ever developed in Auckland’s history, but with COVID-19 continuing to run rampant globally and border closures set to continue for some time, we have no choice but to make hard calls to protect critical services, maintain community assets and plan for the future.”

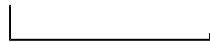

## **Auckland Transport Media Release**

### **Two major transport projects move forward**

Auckland Transport (AT) has announced significant milestones on two major projects taking them a step closer to potentially gaining funding.

The Lake Road and Glenvar Road transport improvement projects will both deliver improved safety, increased transport choices through public transport and walking and cycling, increase the capacity to move people and goods along the roads more efficiently and support the response to climate change.

The board of AT has approved the recently completed detailed business case for improvements to the transport network in the Devonport peninsula.

The board has also approved the business case for the Glenvar Road-East Coast Road project in Long Bay. Both projects are funded by the regional fuel tax and although there is currently insufficient funding to commence construction, there is an allocation of \$500,000 to start the detailed design phase of the Glenvar Road project.

Planning Committee chair Councillor Chris Darby says these two roads are vital transport links to the local communities.

“Safety and network productivity on Lake Road need to be dealt with. Our proposal also includes safer pedestrian crossings and intersections and targeted transit lanes, physically protected cycle lanes. We will back that up with better travel information, greater bus and ferry integration and support for school cycle improvements.

“Auckland Transport Board’s approval of the business case enables this highly anticipated project to recommence, subject to funding being confirmed in the forthcoming RLTP. Improving connections for people and addressing safety is long overdue on the peninsula. While council’s financial constraints are considerable I’ll be relentlessly championing the need to see the improvements funded in the RLTP, with a staged but certain implementation plan to ease the financial impact.”

Auckland Transport chief executive Shane Ellison says says Glenvar Road-East Coast Road also needs safety improvements. “The Glamorgan Drive-East Coast Road intersection is a high safety risk and we need to provide better walking and cycling options along the road. Once completed the improvements will also deliver better travel times for buses and private vehicles as well as reducing greenhouse gas emissions by 1,000 tonnes of per annum.

“Long Bay is a growth area and if something isn’t done to improve transport choices for the people in those communities, the road will continue to be used mainly by low occupancy private vehicles which means more traffic delays as well as other undesirable outcomes.”

Public consultation on the draft concept design was carried out in November-December 2019, with more than 90 per cent of respondents liking the proposal.

More information on the timing of funding for the construction of both these two projects will be known following the outcome of the Long Term Plan and Regional Land Transport Plan processes which will be finalised in the first half of 2021.

If funding is available, it's hoped the Glenvar Road-East Coast Road project would be delivered in three sections starting in 2022/23 with a total budget of \$52.2 million.

The Lake Road improvements will be considered for priority in the 2021-2031 RLTP. If sufficient budget becomes available, Auckland Transport will be able to confirm the timing for the recommencement of the \$47 million project.

There have been up to 15 vehicles at one time I have witnessed myself.

I spoke to Council about it and they advised that there is hardly any parking staff on at weekends to supervise the Shore.

Already mentioned on the Browns Bay Community page, people have noticed that vehicles are once again beginning to park on the beach.

It is critical that signage be erected on the boat ramp, urgently, before Christmas close down, making it clear that it is an offence to park on the beach as people are scared to confront others doing it as they get abused.

It is only a matter of time before there is an accident involving children, which nobody wants to see.

Can you please advise asap if you will be able to make this request happen.

There are children around all the time and I have witnessed many near misses. The worst part of the grass where people park is opposite Tides/Movenpick near the gas BBQ and here I have witnessed some near tragic events as well. Happy New Year to you both.

Over the Christmas period I have had the following issues arise and wonder if you can help chase these for me

1) Cleaning - When Ventia took over we were assured Browns Bay would get more regular cleaning, however, this hasn't happened. <sup>S7(2)(a) Privacy</sup> saw the cleaner last week and when talking to him, he said that Browns Bay were on a once a week cleaning schedule, whereas Takapuna and Devonport were both on a once a day cleaning cycle. BB being the main hub in East Coast Bays should be a once a Day cycle also? How do we go about changing this - I have attached some photos around the bus stops - this is filthy and really lets our Town Centre down. On this the Bus Stop seats need to be repaired and painted - they are rusty and awful also. Are you able to follow up on this issue and get Browns Bay Cleaned, and on a regular cycle?

2) Mr Whippy has been parking (illegally) on the boat ramp most afternoons, rego CPT741. By laws are that they cannot operate within 300 meters of a Business District, which he is also disregarding. When questioned, he also could not produce his Health and Safety Certificates either. 

Good morning S7(2)(a) Privacy

I pushed for Glenvar Road to be included as a 'shovel ready project' to the Industry Reference Group. It was not eligible sadly (as we kind of expected.. but we tried our very best). It isn't ready to go (hence why construction won't start until 2022/23). Even Penlink which we also pushed hard for and I helped with the submission for, has apparently been knocked back by the IRG. Penlink was actually much further down the track and 'shovel ready' than Glenvar Road, so this was really disappointing not to have one project in our Local Board area included.

You may have noticed a bit of activity happening on Glenvar Road recently. The team working on Glenvar Road – East Coast Road project was using a digger last week to remove and replace the concrete barrier that stops people driving up the hill at the top of Glenvar Road. They are working on the preliminary geotechnical investigations for the project and needed access up there. This was a key area of concern in the feedback I provided, on behalf of the Hibiscus and bays Local Board, in the recent public consultation on the project – I voice my concerns that they did not undertake geotechnical assessments before going out to consult on a design that may/may not be feasible. I am crossing my fingers that the assessments conclude that the area is stable and things move ahead as planned. We can't afford for this project to be delayed even further.

In my feedback I also pushed hard on the fact that AT had reneged on their earlier commitment to a 2021/22 construction start date, and described how long this area had been in a poor and dangerous state. We also pushed them hard on this when they came to visit us at a Board meeting – they were apologetic for the mistake and have worked hard to trim timings where they can, but they can not move the process along any faster unfortunately.

I recently received your newsletter after being out the country for a few weeks as well as read an article in a newsletter from Auckland council "The road to Zero" dated November 2018 on their commitment to reduce roads accidents and deaths with...investing \$700 million over the next 10 years,partially funded by rates and regional fuel tax,....". This motivated me to pen the letter below which I emailed to the council enquiry email address. I await their response!

With over 1000 new homes in new Long bay sub division in the last 7 or so years with average rates, I would guess at over \$3000/yr , would account for over \$21 million . Most of these residents would use this intersection daily.

I then noticed a diagram on the Glenvar Road upgrade in your news letter, Great news!

The diagram indicated public consultation started in January 2019. Surely if given the priority mentioned in ACC news letter it can be actioned and completed in less than 3 years. If the intersection is a state road is this portion a separate project funded by state roads ?.

I have recently witnessed a far larger (and possibly busier) intersection upgrade completed in about 6 mths.

Well it is nearly June and have seen nothing in the post! and I live a few hundred metres away only.

Has there been any design options put to the public?

Is there anything that can be viewed on line?

Your help on answers to the above questions and any pressure that you can add to get things moving faster would be appreciated.

With slope failures (land slide head scarps) cresting along the side of this portion of the road could this not be giving emergency status? to shorten planning and approval stages particularly with the onset of the wet season it is possible that Glenvar Rd may be reduced to a single lane this winter!

My best friend's brother, who was in his last week of school after getting 7 As in his final year and excelling in most sports, was hit by a car at a school crossing.In a spit second he was reduced to

vegetable status for over a year and took several years to walk and talk again and never fully recovered!! My friend (his brother) a few years later died hitting a tree on the side of dangerous road curve! about 100 m from my door.

I don't want to ever hear this happen to a Long Bay student.

I recently received your newsletter after being out the country for a few weeks as well as read an article in a newsletter from Auckland council "The road to Zero" dated November 2018 on their commitment to reduce roads accidents and deaths with...investing \$700 million over the next 10 years, partially funded by rates and regional fuel tax,....". This motivated me to pen the letter below which I emailed to the council enquiry email address. I await their response!

With over 1000 new homes in new Long bay sub division in the last 7 or so years with average rates, I would guess at over \$3000/yr , would account for over \$21 million . Most of these residents would use this intersection daily.

I then noticed a diagram on the Glenvar Road upgrade in your news letter, Great news!

The diagram indicated public consultation started in January 2019. Surely if given the priority mentioned in ACC news letter it can be actioned and completed in less than 3 years. If the intersection is a state road is this portion a separate project funded by state roads ?.

I have recently witnessed a far larger (and possibly busier) intersection upgrade completed in about 6 mths.

Well it is nearly June and have seen nothing in the post! and I live a few hundred metres away only.

Has there been any design options put to the public?

Is there anything that can be viewed on line?

Your help on answers to the above questions and any pressure that you can add to get things moving faster would be appreciated.

With slope failures (land slide head scarps) cresting along the side of this portion of the road could this not be giving emergency status? to shorten planning and approval stages particularly with the onset of the wet season it is possible that Glenvar Rd may be reduced to a single lane this winter!

My best friend's brother, who was in his last week of school after getting 7 As in his final year and excelling in most sports, was hit by a car at a school crossing. In a split second he was reduced to vegetable status for over a year and took several years to walk and talk again and never fully recovered!! My friend (his brother) a few years later died hitting a tree on the side of dangerous road curve! about 100 m from my door.

I don't want to ever hear this happen to a Long Bay student.

Traffic backs up for over 1km daily towards Okura along EC Road and back up along Glenvar Rd past the top of the intersection with Fitzwilliamn drive. I returned to NZ after working away for 10 years and see there had been a accident through the flimsy wooden barrier and a slip scarp extending along parts of this road waiting for the next big storm to loose part of the west bound lane.

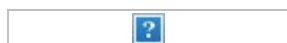
If it hasn't already occurred in the last 10 years it only a matter of time before a serious accident results from this lack of action from Council and blood will be on your hands!!.



I understand your frustration and it's something I got a lot of feedback about from dog owners back in 2019 when I stood for the Local Board. There is a clear need and desire for a specific dog exercise park in the Bays and I'm really pleased to say that is now something that is on our work programme for funding and delivery in the next year or two. The location is still to be determined. Next time it is discussed I'll raise the Long Bay option around Ashley Reserve as you've suggested.

The management and rules of regional parks is largely out of our influence as a Local Board. Dogs are prohibited at all Auckland Council regional parks' bookable sites and accommodation and dogs must be on leash at all times in all other areas of Council parks unless otherwise stated in the dog walking section.

Here's a good link on the Council website where you can search for off-leash areas by suburb:

In our area there are a few off-leash areas (select it online to check the details): Awaruku Reserve, Aicken Reserve (Waiake), Browns Bay (Beach Reserve, Creek and Village Green, Bayside Drive Reserve (Browns Bay). There's lots around in Fairview Heights, Albany and Redvale too which would be a shorter drive for you than Paremoremo.

I hope that is helpful information and thanks for raising your concerns about this- it's always helpful to know and understand how we can better serve the needs of the community.

Tuesday 8th June, 2021

Hi Erica,

I hope this email finds you well. Whilst was taking my two dogs to Ashley Reserve at 9am this morning (a quiet time at the park) just down from Long Bay College, there was an Auckland Council Animal Control officer talking to a gentleman with a dog.

I walk my dogs off leash around the outside grass area of Ashley Reserve at least once daily, and have done for 15+ years. Many other local dog owners take their dogs there too. This area is behind a 6m chain link fence. The Animal Control Officer told me he was informing people about Auckland Council dog rules around parks. He said he was not issuing any infringements today as the rules were not posted anywhere at the park. He told me that dogs are not allowed on or around council parks. This includes the grassy area surrounding the back and sides of Ashley Reserve, which is behind the fore mentioned 6m chain link fence.

After pointing out that there were no other off leash areas to go for the local Long Bay dog owners like myself, he said I could go to Long Bay beach, which I do often. But I reminded him that after rainfall, like over the last few days, the beach is unsafe due to the Auckland Council's neglect of the stormwater and sewage system, and that there is currently a warning about the toxic sea slugs in the Bays beaches so I could not go to the beach on all occasions especially today to which he had no answer for that.

He also mentioned other areas for off leash dog walking like Sanders Reserve, which is a 20 minute drive away at Paremoremo. I do take my dogs there sometimes, but cannot always afford the travel time there and back. He said that he too sometimes finds it difficult to find off leash areas for his dogs. He then took my name and dog's registration tag numbers so he could let his boss know he was talking to people.

I told the officer to inform his boss that I was very unhappy, and that as a rate payer whose rates have more than doubled in recent years, plus the money I pay in dog registration fees, I felt I was getting little value for money. We said goodbye and then he went off to tell three other dog walkers that had arrived the same thing.

So basically there is now no off leash, non beach areas to exercise a dog in Long Bay without driving somewhere. I feel the area outside the 6m fence of Ashley Reserve now being off limits is a bit unfair, its a tiny area really and well away from the sports field. Ideally a dedicated dog park close by would be great, but probably very unlikely in the near future at least.

As a responsible dog owner, I have always exercised my dogs twice daily, and off leash time is essential. The beach is not always an option, and transport by car to a place outside the area is also not always an option. On leash only exercise is not sufficient either, which is kind of what myself and others might be stuck with unless the council gives us some space somewhere. I don't know If you can do anything about this, but thought I would let you know the frustration of myself and other dog owners around here.
