Thanks very much for all that! I think I can rely on whatever feedback you get from the flood protection team, rather than commission any further peer reviews around hydrology and flood mitigation. Would you mind sending me the comments when received?

I had a chat with Frances at Wildlands and she noted the person who designed the wetland and picked the species doesn't have an ecology or horticultural background. In any respect, she suggested I touch base with Malcolm Birch at PCC whose team does have in-house capability to review the species which is great. If you're interested I can provide you with the feedback when it's received.
