Official Information Request: Kahukura rehabilitation scheme

Thank you for your email of 12 July 2021, requesting information under the Official Information Act 1982 (the Act), relating to the Kahukura rehabilitation scheme. Specifically, you requested:

- (1) Correspondences between the Panel and its members with the Prime Minister, the Deputy Prime Minister, and the Minister of Justice in relation to funding for the Kahukura rehabilitation programme.
- (2) Correspondences between the Mongrel Mob, its associates, members and/or spokespeople, as well as the agency eligible to apply for the funding to the relevant people responsible for making decisions on the Proceeds of Crime funding in relation to the Kahukura rehabilitation programme.

On 16 July 2021, the Ministry of Justice contacted you to advise that the response to your request would need to be extended by 20 working days. This is because your request required significant consultation.

In response to your requests, these are partially refused under section 18(d) of the Act as some of the information is publicly available on our website here: www.justice.govt.nz/about/news-and-media/news/kahukura-proactive-release.

The remainder of the information in scope is being released to you – see Appendix A for details. Copies of the documents are enclosed. Please note some information has been withheld from the documents under the follow sections of the Act:

- section 9(2)(a) to protect the privacy of natural persons
- section 9(2)(g)(ii) to maintain the effective conduct of public affairs through the protection of Ministers, members of organisations, officers and employees from improper pressure or harassment
- section 9(2)(j) to allow the continuation of negotiations without prejudice or disadvantage.

If you are not satisfied with my response, you have the right to complain to the Ombudsman under section 28(3) of the Act. The Ombudsman may be contacted by email at: info@ombudsman.parliament.nz.


- The Panel reviewed and confirmed they are comfortable with the shortlisting process.

1. Opening

Opening Karakia

s9(2)(g)(ii) welcomed and thanked Panel members for their continued work on the Proceeds of Crime Fund and particularly around input into the briefing on the strategic direction of the Fund to the Minister of Justice.

s9(2)(g)(ii)noted the timing for applicant presentations – 10 minutes for presentation, 10 minutes for questions from the Panel. Agreed that to manage any potential conflicts, Panel members may contribute to clarifications on initiatives supported by their agency, however, won't have a vote in the decision making on that initiative.

s9(2)(g)(ii) (Education) noted that he would need to leave the meeting at 1:45pm for half an hour.

Funding available

Noted that there is \$6.5 million available in the Fund in this funding round. The total funding requested in the detailed proposals is \$8.2 million.

- Pro-social development, whānau development, empowering people to develop solutions for themselves to grow.
- Help and support to assist people to influence others in their community.
- Led by people with long-term involvement in gangs.

Questions

Q: Is there a particular area in the greater Wellington region you want to focus on?

A: Hard to do geographical boundaries as populations move, but Eastern Wellington, Strathmore, Hutt Valley would be starting points. Whānau influence senior members across New Zealand, so the intention is to pool influence through social media.

Q: How will you evaluate?

A: Through a network of evaluators. These would be contracted out and have been built into the costings.

Q: What role will Wesley have in providing governance and oversight?

A: Initiative will be whanau led and community led but needs a professional backbone to enable that to form. Will provide a stable base and infrastructure for people working in the field. Supervision and development are important.

Q: How will whanau workers work with whanau to come up with action plans?

A: Through a diverse approach. Holding whānau camps, working alongside whānau, community hui, kai, exposing whānau to other ways of thinking and doing things. It just takes one person to step up and lead in a community and people will follow.

Panel discussion

- Good people working to build relationships can make a difference. Comes down to the quality of the workers.
- The short trial of this program is showing success. Ready for investment to further develop potential.

- The initiative is innovative and aligns with the purpose of the Fund.
- Evaluation is weak only \$15,000 provided in budget. Oranga Tamariki could provide some support but would still need someone external.
- Request that they come back to the Panel asking for additional funding to allow for better evaluation for this initiative.
- Recommendation: The initiative is supported in-principle. Recommend for funding, subject to the applicant providing more evaluation of the program with potential oversight and support in this area from Oranga Tamariki.

- Initiative has come from a journey over five years.
- Consistent with Te Puni Kökiri, Māori co-design.
- Trial has been un over the last month. Feedback has been received that participants have not participated in crime.
- Has resulted in a step-up of leadership in the community.

Questions

Q: What have you learnt from the trial run and what changes would you make?

A: Noted a positive change in the people – they are looking fresh, whānau are happy, staying connected. Would like to improve on the relationship with Corrections.

Q: Do you have a relationship with Oranga Tamariki?

A: Going forward would like to have one and would welcome input from all government agencies.

Q: Is there an opportunity to do some evaluation after 6, 12, and 24 months?

A: Would like to do this but would need to revisit the budget. Panel noted that the cost that had been included for van hire in the detailed proposal could go towards evaluation if a van was purchased, rather than hired.

Panel discussion

- · Panel noted the financials in the budget didn't add up correctly.
- This initiative has a lot of value in terms of impact.
- Recommend for funding. If funded, it is recommended that Ministry of Heal h work with them on incorporating additional evaluation for the program.

321 – Enhanced Wastewater Analysis - \$0.263m

s9(2)(g)(ii) (Police) and s9(2)(g)(ii) (Health) noted they have conflicts of interest with this initiative.

- Evidence based model
- Use intelligence to reduce recidivism
- How to target programmes to inform prioritisation of drug intervention services and identify communities where information is needed.
- Use funding to employ a senior analyst.

Questions

Q: Is there room for others to request the data outputs for evidence?

A: Open to working with other agencies who want to partner and work together. Access to data/analysis will be accessible and raw data can be provided to agencies if requested.

Q: What is the long-term plan to embed this capability within Police?

A: Two years will allow the development of products. Once materialised, will enable argument for a salary of further resource.

Q: Is there any evidence overseas that results in a reduction of drug use?

A: This is a new area of research. The testing won't necessarily reduce drug use but will allow decision makers to make policy decisions on interventions.

Panel discussion

- Will give insights and is collaborative and cost effective.
- Two years of funding will enable agencies to find a way to support this in the long-term.
- Insights can be used for intelligence, trends, effectiveness of interventions.
- Need to be careful with outputs and how they land. Deficit-based reporting can do more harm than good if not managed sensitively.
- Recommendation: Recommend for funding.

318 - Upgrade of Focus Paihia CCTV System - \$0.154m

olice)

- Upgrade to existing system which is seven years old and obsolete.
- Area is prone to robberies, alcohol-fueled harm. This will reduce disorder, assault and dishonest behavior.
- Supported by Mayor, councilors, Māori wardens, volunteer groups, business association.
- Volunteers to monitor the CCTV footage.

Questions

Q: What is different about new system to the existing?

A Existing system can only be accessed from three sites. New system can be used in real-time and retrospectively on mobile devices. Better quality cameras.

Q: What is meant by volunteers monitoring the footage?

A: Community will have a part in this initiative. There is no community patrol based in Paihia. A group of volunteers are prepared to watch footage as part of the patrolling.

Q: What are the privacy risks around this?

A: A robust process is in place on who views footage, along with training and vetting of volunteers

Q: What is the likelihood of crime moving to another area?

A: Not likely. These are the areas where people go and frequent.

Panel discussion

- Small amount of money that will make a difference for the community.
- Many volunteers supporting the initiative.
- Need to report on privacy concerns.
- Recommend for funding but initiative should report on the Panel's privacy concerns.

319 - Matau mō te Huringa Hooks for Change - \$0.500m

Presentation ^{s9(2)(g)(ii)}

Police, s6(d) New Zealand Blue Light Ventures)

- Aligned to youth crime action plan. Government agencies working more closely with parents, youth and communities.
- Wrap around support to young people and their whānau. Get youth off the prison pipeline, turn life around and head into employment.
- Evidence based approach collaborating with key agencies.

Questions

Q: Is one year's funding enough to get sufficient evidence for further expansion?

A: Have already done 12 months, within 6 months they will have sufficient evidence to head towards a budget bid.

Q: To what extent are you involved with local wi and other diverse communities (e.g. Pasifika)?

A: Already have staff and connections doing work in the area. For example, Pasifika staff member used personal network to connect young person to their father for the first time.

Q: Is there a plan around benefits realisation and assessment?

A: A lot of the evaluation is unders ood through storytelling, but there are things that can be measured such as no breach of bail, engagement with bail conditions, getting employment.

Panel discussion

- Specifically targets young people. Encourage targeting younger siblings.
- Concern raised around a possible funding cliff and recommend they resubmit budget with another 6 months of funding and an extra \$0.25m. Further evidence would be useful.
- Could move towards a kaupapa Māori approach.
- Recommendation: Recommend for funding but request that they resubmit budget with another 6 months funding for an extra \$0.25m, with a commitment to making a kaupapa Māori approach.

3. Conclusion

Next steps

- Panel to provide feedback on draft minutes by 14 January 2021.
- Secretariat will aim to have decisions back from Ministers by end of February 2021.
- (Chair) to send email to applicants thanking them for their application and updating them on the process from here.
- Secretariat will seek feedback on how the application process has worked and how this can be improved.
