Thank you for your email dated 23 April 2014, which Auckland Transport received on the same date requesting daily patronage or daily boarding data for each of Auckland's railway stations for 2013 and 2014 (if available).

Auckland Transport conducts periodic "snap-shot" surveys primarily for internal use to monitor train loadings, long-term patronage trend analysis and contract management purposes. As a "snap-shot" there may be significant margin for error when comparing one year to another. The data is not adjusted for variances in the observed station usage as a result of service disruptions that may have occurred on the day of the survey.

Attached are the boarding counts for 2013 together with the counts for 2012 and 2011 for comparison. Please note that in 2012 and 2011, there were service disruptions on the day the counts were taken that would have affected normal patronage demands on parts of the network. This data should not be reproduced or otherwise used in any way without acknowledgement of its source and inclusion of the disclaimer appearing at the top of that page.

The 2014 survey has not yet been undertaken and this portion of your request is therefore refused in accordance with section 17(g) of the LGOIMA in that the information requested is not held by Auckland Transport. However, the introduction of AT HOP across all modes of public transport will provide additional data and we are currently working towards full analysis capability.

We trust the above information has addressed the matters raised however, should you believe that we have not responded appropriately to your request, you have the right in accordance with section 27(3) of the LGOIMA to make a complaint to the Office of the Ombudsmen to seek an investigation and review in regard to this matter.
