## Official Information Act request

Thank you for your Official Information Act request of 6 May 2014, for the number of Cervical Spine surgical procedures funded by ACC over the last five year, under the Core Item ID codes SPN211, SPN212, SPN213, SPN214, SPN215 and SPN216.

In my email to you on 8 May 2014, I advised that ACC could only provide you with information recorded from 1 July 2013 using the core item codes you specified.

I further advised you that ACC could provide data in relation to a number of other codes with similar descriptions used prior to 1 July 2013, but could not confirm if these older codes were used for the exact same (cervical spine surgical) procedures or not. You agreed to ACC providing you with this data.

The table below shows the number of claims that received the relevant spinal surgery by calendar year.
