APPLICATION FACILITATION ARRANGEMENT FOR AIR CHINA LIMITED GOLD AND PLATINUM CARD HOLDERS

ELIGIBILITY

Applicants for visitors' visas who are current holders of Air China Limited (hereinafter referred to as "Air China") PhoenixMiles Gold and Platinum (including lifetime Platinum) cards (and their partner and dependent children¹ if travelling with them) are able to avail themselves of the application facilitation arrangement between Immigration New Zealand (INZ) and Air China if they:

- Are intending travel to New Zealand for the purpose of:
 - tourism, or
 - visiting friends or relatives, or
 - discussing and negotiating business arrangements (if their intended stay is for no longer than three months in any one year).
- 2. Provide the documents required by INZ's Air China Limited PhoenixMiles Gold and Platinum Airpoints Card Holder' Visitor's Visa Checklist.
- 3. Submit their completed application at a New Zealand Visa Application Centre (NZ VAC) in China Mainland or Hong Kong Special Administrative Region.
- 4. Hold a current standard People's Republic of China passport.

Where applications for visitors' visas submitted under this Arrangement are fully completed and include all required documents, INZ will endeavour to process such applications within five working days of receipt at a NZVAC in China or Hong Kong.

Air China will provide the facility for validation by INZ staff to confirm that applicants are current Gold and Platinum card holders. This validation will be by means of email. Air China offers no guarantee for the authenticity of application materials submitted by PhoenixMiles elite members.

INZ does not guarantee the outcome of any application submitted under this Arrangement, and may ask for further documents in support of such an application where these are necessary to the decision making process on the application.

Immigration New Zealand may revoke, or suspend, the Arrangement if, at any future point, it considers that the operation of the Arrangement potentially creates an unacceptable risk to the integrity of New Zealand's immigration laws or policies.

Should INZ have cause to revoke the Arrangement, notice of this revocation will be provided to Air China up to three months prior to the effective date of the revocation. Any suspension of the Arrangement will have immediate effect.

CONFIDENTIALITY

Air China are deemed to be fully informed that INZ is subject to the Official Information Act 1982, and that INZ may be required to release information supplied by Air China in accordance with the provisions of that Act.

TERMINATION

This arrangement comes into effect on the day both parties sign and stamp their seals on it and will remain effective for **3 years**. Unless one participant submits a written notice to the other participant at least 60 days before this arrangement expires indicating its intention not to renew this arrangement, this arrangement will be automatically extended year by year.

Any participant will give two (2) months' notice indicating its intention to terminate this
