Hi Fang,

Thank you for your email.

Coastal Permit WGN180286 [35365] Was granted on 04 May 2018 to and allows the continued occupation of the coastal marine area with the existing boatshed (Boatshed X57, Onepoto)

Coastal permit [35365] contains a number of conditions of consent which require to maintain the structure. The proposed works outlined in the building consent to install new bearers over existing piles will help to achieve the requirements of maintenance conditions 6 and 8 of Coastal permit [35365].

However, technically the building works trigger a requirement for a resource consent as it sounds as if the total height of the boatshed is to be raised. Therefore, I need to know how high the proposed works will raise the total height of the boatshed. Do you have any plans which show the proposed works?

Under the Proposed Natural Resources Plan (PNRP), the Onepoto Boatsheds are given some status as heritage structures (they are listed in schedule E2 of the PNRP).

An increase in the height of a boatshed does not fit within the permitted activity rule R168 of the PNRP and so the consideration of the proposal then defaults to rule 169 of the PNRP (which is a restricted discretionary consent). This is why an additional coastal permit resource consent is required.

However, this is a slightly unique case as the boatshed has required maintenance for some time (the works are achieving this) the proposed works are likely permitted under the operative Regional Coastal Plan; and GWRC have just recently re issued a new resource consent to occupy the coastal marine area with his boatshed. The ideal time to consider the proposal to raise the boatshed would have been when we processed coastal permit WGN180286 [35365] (granted on 04 May 2018).

We may still be able to approve the proposed building works without a resource consent as the Resource Legislation Amendment Act (RLAA) 2017 introduced a mechanism for consent authorities to exempt certain activities as permitted where there is a marginal or temporary breach of a rule in a plan. Deemed permitted activities (DPA's) are now provided for in s87BB of the RMA.

However, in order to determine whether we can issue a DPA for the proposed building work we first need to understand how the proposed building work will modify the boatshed structure. For example how much higher will the boatshed be after the installation of the new bearers over existing piles?
