Your Official Information Act request, reference OIA2122-0413

Thank you for your email of 16 November 2021 to the Department of Internal Affairs (the Department) requesting the following documents under the Official Information Act 1982 (the Act).

"I request the following information related to your consultation this year about Maori wards and constituencies (July to August 2021, not the earlier legislative change):

A copy of all submissions

A copy of any summary of submissions

A copy of any policy paper already considered by the Minister of Local Government."

We have interpreted this request as policy papers about stage two of the Local Electoral (Māori Wards and Māori Constituencies) Amendment Bill. I am refusing your request for copies of all submissions and a summary of submissions, under section 18(d) of the Official Information Act 1982 (the Act), as this information will soon be publicly available.

Please find the documents that fall within scope of your request attached and listed at **Appendix A**. I am releasing to you in full the briefing titled *Local Electoral Amendment Bill – revised scope and Māori wards engagement approach*.

The remaining four documents have either been withheld in full or in part under the following section of the Act:

9(2)(f)(iv) – to maintain the constitutional conventions for the time being which
protect the confidentiality of advice tendered by Ministers of the Crown and officials.

Document three is being released as an excerpt document under section 16(1)(e) of the Act. These extracts are portions of status reports to the Minister between the period of 1 July 2021 and 11 November 2021 that are within scope of the request.

In this instance, I do not consider that to be the case.

We intend to publish our response to your request on www.dia.govt.nz. This letter, with your personal details removed, will be published in its entirety. Publishing responses increases the availability of information to the public and is consistent with the Act's purpose of enabling more effective participation in the making and administration of laws and policies and promoting the accountability of Ministers and officials.
