We acknowledge receipt of your Official Information Act request dated 26 June 2014 which was transferred by the Auckland Council to Land Information New Zealand (LINZ) on 24 July 2014.

You requested to see the Sale and Purchase Agreement between the relevant public body and the purchasers relating to the sale of the old Carrington Psychiatric Hospital in Mt Albert, Auckland, now known as Unitec.

The Hospital land was transferred by the former Auckland Area Health Board as follows:

On 24 August 1993, Lot 1 DP 156226 and being part Allotments 30, 31 and 32
Parish of Titirangi comprising 17.8889 hectares and held in Certificate of Title
93B/539 (North Auckland Registry) was sold to the Carrington Polytechnic. On 22
July 1966 the Polytechnic had a change of name to Unitec Institute of Technology
(Unitec).

Please find enclosed for your reference a copy of the Transfer Instrument that effected the above sale to Unitec.

LINZ does not hold a copy or have access to the Agreement for Sale and Purchase requested. In the event that you still want to pursue this matter the Auckland District Health Board or Unitec may hold this information.
