Attached is the Climate Change paper with my revisions – I’ve basically rewritten the modelling & emissions outcomes, with reporting on a hourly basis for both CAST & Paramics for CO2, and daily for the other harmful pollutants. Outputs from both models have been calibrated against VEPM 6.1 using “adjustment factors” – as we discussed on Tuesday – so are consistent between model platforms and based on the predicted 2028 fleet composition.

I’ve also attached the spreadsheet I’ve used for this calibration and to consolidate the results – it’s a bit messy as it has evolved as I’ve updated the paper, but happy to talk you through it if you’re interested.

I’ve included ^{Out of Scope} so he can check that I haven’t misinterpreted any of the Paramics outputs or outcomes.
