Official Information Act request relating to COVID-19 Public Health Response (Protection Framework) Order 2021

Thank you for your Official Information Act 1982 (the Act) request received on 12 January 2022. You requested:

"Can I see any and all correspondence, emails, meeting minutes, memos and or govt legal advice that show it is legal for a non-regulated business (as defined under the COVID-19 Public Health Response (Protection Framework) Order 2021) to use the CVC scheme/system/rules (as defined under the COVID-19 Public Health Response (Protection Framework) Order 2021) for their customers."

On 20 January 2022, you corresponded further with the Minister's office, as below:

"I would just like to add COVID-19 Public Health Response (Protection Framework) Order 2021 31 Person must not be denied access to certain premises on vaccination grounds 32 Person must not be denied access to goods or services from certain premises on vaccination grounds

Certain Premises is not defined in the act so it can only be assumed it is any thing other than a regulated business or service or anything that isn't in part 4."

The information you are seeking is publicly available at the locations listed below, therefore I am refusing your request under section18(d) of the Official Information Act.

You are also seeking a legal interpretation of the relevant provisions, which the Department is not in a position to provide by way of an Official Information Act response.
