Calmness in the city

The situation in Honiara remains calm, due in large part to the Royal Solomon Islands Police Force (RSIPF) having its presence bolstered by the various international contingents now in Honiara. s6(a), s6(c)

2. The NZDF advance party and New Zealand Police has had constructive engagement with RSIPF Commissioner **Mostyn Mangau**, and with ADF and AFP leads. New Zealand's participation has been welcomed by Solomon Islands and Australian stakeholders alike and our focus – particularly that of Police - on supporting RSIPF to engage with communities is a credible and useful role. The response on social media has been overwhelmingly positive (notwithstanding some quarters opining the deployment will serve $^{s6(a)}$, $^{s9(2)(g)(i)}$

Costs continue to mount

- 3. The fallout from last week's violence continues. The Central Bank of Solomon Islands has revised upwards its damage assessment. They now report 63 buildings burnt and/or looted; forecast an economic depression; and report a SBD534 million hit to the economy. They report some 1,000 job losses, anticipate a loss of SBD80 million tax revenue over the next three months, expect increased loan defaulters, and predict a rise in inflation. RSIPF have reported that they have apprehended 217 suspects from the violence last week, of whom 33 were juveniles, but have not yet arrested any of the instigators. Some communities have returned looted goods to the Chinese Association, and police have advised that they will be checking those travelling to the provinces for evidence that cargo was legitimately sourced. Maritime traffic between Honiara and Auki has been paused, and we are starting to hear of potential food shortages in Malaita as a result.

Meanwhile the Chinese Embassy has broken its silence to release a statement condemning last week's violence as a "dark moment" noting the significant loss caused to the Chinese community in Solomon Islands. It acknowledged the support received by Solomon Islanders since the violence and devoted most of the statement to applauding individual groups within the Chinese community. It reminded readers that the establishment of diplomatic ties between China and Solomon Islands had "achieved more fruitful and tangible outcomes, and benefit the people of Solomon Islands in many ways." It stated its support for the government and people of Solomon Islands to restore "social order, and stability, and economic recovery." And, it warned that "any attempt to sabotage the relationship is doomed to failure ... dark clouds cannot block the sun."

Following the ^{s6(a)} phone call between Minister Mahuta and Foreign Minister **Jeremiah Manele** last night, Prime Minister **Manasseh Sogavare** announced that New Zealand will be joining Australia, Papua New Guinea, and Fiji to assist Solomon Islands. He has expressed his gratitude to New Zealand for "answering the call to get Solomon Islands back on its feet." ^{s6(b)(i)}

continue to engage closely with the National Disaster Management Office on other needs. The risk of a COVID-19 outbreak is front of mind for senior officials, and the Prime Minister devoted much of his address last night to emphasising that deployed personnel were fully vaccinated and would need to undergo a comprehensive testing regime. He condemned social media speculation yesterday about a possible positive case, explaining that while some initial tests had returned inconclusive results, follow-up tests had returned negative results. Honiara's vaccine rollout is on pause following the unrest, but plans are under way to recommence it.

The statement also notes the corrupting influence of foreigners, particularly those in the natural resource area, and weakening of democracy. It calls for an urgent dialogue, requesting that the Pacific Islands Forum facilitate and mediate this dialogue under the auspices of the Biketawa Declaration.

Following the arrival of deployed Australian and Papua New Guinean personnel in Honiara, a calm has descended across the city although tension remains. With 56 buildings razed and serious looting, Central Bank has indicated that the loss to the economy of the riots will be at least SBD227 million (NZD50 million), of which \$36 million would be lost in tobacco tax takings alone. Over 100 people have been arrested, and four MPs have resigned from the Government. A curfew has been imposed on Honiara and its maritime zone from 7pm to 5am until further notice.

2. There has been a focus this weekend on taking stock of the damage and commencing clean-up of those neighbours most affected by the violence. New Zealand company **Fletchers** was out yesterday using its heavy machinery to clear the Kukum Highway of burned out vehicles and debris and groups have been busy cleaning up Chinatown. Recent unrest in Honiara, Solomon Islands, has caused significant damage, and poses s6(a) risks to the ongoing security and development of the country (formal messages from HON refer; thanks also CBA's reporting). In response, personnel from the Australian, Papua New Guinean, and Fijian defence and police forces are currently deployed in Honiara to support the Royal Solomon Islands Police Force.

3 This evening 1 December, Ministers with Power to Act (Prime Minister, Deputy Prime Minister, Minister of Foreign Affairs, Minister of Police, and Minister of Defence) authorised a New Zealand deployment for up to 30 days. It will aim to assist in stabilising the situation and rebuilding community trust, which will assist businesses and communities to begin the process of rebuilding from the unrest. This deployment

will complement New Zealand Aid Programme activities, including ongoing support to the RSIPF, and humanitarian assistance as needed.

- 4 The New Zealand deployment will include both New Zealand Police and New Zealand Defence Force personnel:
 - The NZDF deployment will include a national command element of up to 20 personnel, which will provide interagency and multinational coordination at the local level, communications and logistics support, and command over deployed NZDF elements. If needed, a platoon group of up to 40 personnel can assist the RSIPF and partner nations to maintain stability, community engagement, and to provide public reassurance. The NZDF is liaising with agencies and the Australian Defence Force to confirm the composition of this group.

The curfew is posing food security challenges on families who lack sufficient means to maintain additional supplies. The High Commission is closed and \$9(2)(a), \$9(2)(c)\$
- · We will continue to monitor the situation and provide regular security updates.

Situation

Pockets of unrest erupted midday on Wednesday 24 November in a number of sites around Honiara City centre (Sitrep 24 Nov, 20.00, refers). Overnight, the unrest continued to move into eastern Honiara with several businesses around Chinatown and Henderson attacked and looted, other buildings torched, and a police station and high school set ablaze. s6(a)

There were ongoing reports of small explosions/shots during the night audible from Panatina and Henderson (eastern Honiara) but at this stage there is no evidence of the use of weapons beyond the deployment of teargas and rubber bullets by the Police Response Team (PRT).

2. The situation remains highly dynamic with scope to change rapidly $^{s6(a)}$ The atmosphere today is starkly different to that of yesterday. $^{s6(a)}$. We have confirmed with the CEO of

the Port that all port facilities are closed, including the domestic ferry terminal, and fuel stocks are being protected.

- 4. To date there are no confirmed reports of deaths or serious injuries. Parts of the city are now experiencing power outages and mobile internet in extremely slow/patchy. Water supply outages have been experienced in some locations.
- 5. A group claiming to represent 'Honiara Based Malaitans' has issued a statement calling for the Prime Minister to step down and has outlined a list of grievances. Leader of the Opposition Matthew Wale has also requested the Prime Minister resign, citing his cultural insensitivity against Malaitans. Additionally, Malaitan Premier Suidani has urged the Prime Minister to come to the table to negotiate.
- 6. It has been confirmed that tomorrow's weekly Solomon Airlines flight to Brisbane the sole passenger service currently operating out of Honiara has been cancelled. We envisage that this will create requests for consular assistance both in Honiara and Wellington.

Solomon Islands Government (SIG) Response

7. RSIPF has maintained an active and visible presence across Honiara, s6(a), s6(b)(i)

Police have deployed rubber bullets and teargas to break up crowds but to our knowledge there have been limited violent interactions between police and crowds. s6(a)

8. SIG imposed a curfew (effectively a lockdown) from 19:00 on Wednesday 24 November to 07:00 on Friday 26 November. This curfew was enacted under the powers of the pre-existing COVID-19 State of Public Emergency. $^{s6(a)}$

We understand that RSIPF is working to assist with the establishment of small food stores to alleviate shortages.

9. The Prime Minister addressed the public in a short televised statement last night. He lamented the sad events saying he had thought 'we had gone past our darkest days but this is a painful reminder that we have a long way to go.' He noted the Government remained strong and investigative officers

were tracking down those responsible. 'They will face the full force of our justice system.' No further statements have been released yet today.

10. At midday on Wednesday 24 November, s6(b)(i)

13. New Zealand's priority at this time is ensuring the safety of our staff and our consular responsibilities. There is no indication of targeting of New Zealanders. However, there is the risk of New Zealanders getting caught up in the unrest.

- 15. At this time, all seconded staff, dependants and NZ High Commission employees are safely accounted for and our Post security measures have been activated. We are in touch with $^{\rm s9(2)(a)}$, $^{\rm s9(2)(c)}$ so $^{\rm s9(2)(a)}$, $^{\rm s9(2)(c)}$ and checking in with them regularly. NZ Inc colleagues and contractors are also accounted for. Two consular enquiries have been received but we have no active consular cases.
- 16. On Thursday 25 November, the New Zealand High Commission is closed to public. This is in line with the requirements of the SIG curfew.
- 17. Safe Travel updates and public Facebook messaging have alerted New Zealanders to the requirements of the curfew, and advised people to adhere to the advice of local authorities.

Crowds of anti-Government protestors have today breached the grounds of Parliament, burning down a grass hut adjacent to the main building. Buildings in Chinatown are being attacked and the police station in Kukum set alight. Police are responding with riot teams and tear gas and have established some check-points throughout the city. Many schools and businesses have closed down, and police have instructed people to stay out of the city for now. We are not aware of any reports of deaths or serious injury. With the situation remaining dynamic, we report on the latest developments.

Our High Commission remains open, but we have cancelled all external meetings and secured the compound. All our staff are accounted for: s9(2)(c)
