## Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to the Ministry of Health (the Ministry) on 21 December 2021 for:

"All documentation: minute meetings, scientific articles or research used to inform the decision to inject 5-11 year olds with comirnaty considering they have a 99.995% chance of surviving should they get covid."

Six documents have been found within scope of your request. The table in Appendix 1 lists the specific grounds under which I have decided to withhold information. Where information is withheld under section 9 of the Act, please note I have considered the countervailing public interest in release in making this decision and consider that it does not outweigh the need to withhold at this time.

Please note, the COVID-19 Vaccine Technical Advisory Group were able to consider the clinical information in December 2021, rather than 2022. This allowed the Ministry of Health to operationalise ahead of the 2022 school year, launching 17 January 2022.

At the time of drafting the first memo, there was no timeline for the potential supply of the paediatric product. In November, the clinical trials were completed, and information was collated to support the regulatory processes. This created greater certainty as to the real implementation timeframes became more certain.
