### Request for information

Thank you for your Official Information Act 1982 (OIA) request of 8 February 2022.

You requested:

- *How many times this company has been used by the New Zealand Police*
- *The total amount of money spent by the New Zealand Police*
- *Any invoices from the company to the New Zealand Police*
- *The dates and locations the company has been contracted to.*

Please find attached copies of payments made by New Zealand Police to Crime Scene Cleaners since 2010, when the business was established. Please note, there are two invoices numbered 170229; both relate to the same cleaning job, but they come from different sources. One comes from the Cost Centre, the other was provided by Constable Kieran Palmer.

Police has withheld some of the information you have requested in accordance with:

- Section 9(2)(a) of the OIA as the withholding of the information is necessary to protect the privacy of natural persons, including that of deceased natural persons;
- Section 9(2)(b)(ii) of the OIA as the withholding of the information is necessary to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information;
- Section 9(2)(k) of the OIA as the withholding of the information is necessary to prevent the disclosure or use of official information for improper gain or improper advantage.

Police considers the interests requiring protection by withholding the information are not outweighed by any public interest in release of the information.
