Officer Notes:

Stolen vehicle [REDACTED] observed by police travelling on Stan Heather Drive near Deanwell Avenue. Attempt made to stop the vehicle by activating lights and sirens. Vehicle failed to stop and accelerated, turning onto Deanwell Avenue towards Joanna Place. Vehicle then turned onto Joanna Place before turning into Anderson road. Continued for a short distance on Anderson road before attempting to negotiate a sharp left hand corner. Vehicle crossed the centreline, colliding with vehicle [REDACTED] parked on the opposite side of the road outside number [REDACTED]. Offending vehicle [REDACTED] then struck a concrete retaining wall at the front of the property at number [REDACTED] before travelling approximately a further 10 metres and colliding with a power pole and coming to a stop. Extensive damage to both vehicles as a result of the crash. Very minor damage to the power pole. No persons in vehicle [REDACTED] at the time of the crash and both the driver and passenger of vehicle [REDACTED] located and arrested by police.
