

SSC may not be responsible for Councils and their refusal to talk to people but police are not supposed to act like their personal thugs to:

- 1. Stop councillors speaking out about illegal behaviour within Council And human rights abuses
- 2. Rich people like John Harrison with a direct relationship with the Minister of Police who has acted like a thug towards me using FTAC to try to shut me down and push me into MENTAL HEALTH to avoid fixing anything.

IPCA have supported these actions by hiding my complaints to them. They protect their own and not the people being attacked.

There is an incredible level of human rights abuse being used in the legal system and the labelling of people to avoid dealing with them.

This situation is no different to the type of behaviour exhibited by Palmerston North police in the killing of a person in their care. It shows the escalation of aggression which is now common place in police.

I am a ratepayer who is having her home damaged by the actions of Napier City Council and this council uses police to shut people down. This is human rights abuse and I reported this abuse to IPCA. My home was broken into by JOHN HARRISON and numerous people have been privy to watching me and my husband in our home And Sharon Coulam who lives in Hastings (her sister is a cop) visited John Harrison during COVID 19 and I heard her voice Passing comment about me. She used his technology to watch me using infrared lighting in appliances. Why does he have this? Why isn't the police sorting him out? He breaks the law and I get labelled as mental for complaining!! Nash and his Maori mafia cronies are acting outside the law and Napier City Council are trying to hide Serious EQC issues on Hospital Hill.

He takes full advantage of his technological ability (he has millions and can do whatever he likes and will break the law and use police for his own gain) and he has watched us in our home for over a year.

These police here in Napier (and Hastings) have no hesitation in bugging and I am sure our car has a tracking device installed.

We are not criminals. The criminals are police and IPCA cherry pick on who they protect and their approach has been very political to protect Napier City Council and Napier Police and that prick Nash who introduced FTAC who abused my human rights by forcing me into MENTAL HEALTH. These Napier police came to my home at 8.00pm banging on my windows and calling out my name to get us to open the door And let them in to take me. We freaked out at the aggression these scumbag police used and We went to the Mental Health unit next day. We did this to make them stop attacking us. I am glad I never let them into our home because I could not guarantee my safety while these thugs are attacking me in every other way.

Michael Bott has been engaged because the police acted outside their mandate and SSC need to take action to resolve the abuse against us.

This is a human rights abuse issue as police have acted illegally against us on a wide basis and Eastern Police are aggressive thugs.

Your website states you are there to ensure the agencies under your control are acting legally and IPCA are being manipulated to refuse to give a formal response to my complaint and to hide information because the actions taken by police for Napier City Council shows police cross the line to protect a rich thug linked to council and acting for council (through Ex Cop Tanya Wright and ex CEO Wayne Jack and that thug Bill Dalton who as the Mayor at the time and a close associate with John Harrison). In addition, John Harrison received protection from Nash as police minister as he also had a close association with council and used police to hide information.

This must be dealt with. You must respond to me and tell me what you intend to do. I will never give up so don't think you can ignore me after all the abuse I have suffered.

I have every right to expect answers and to have Napier City Council step up and fix their screw ups. The police have no place in bullying me and trying to Section 8 me for seeking a resolution because they screwed up and acted like thugs.

This will never end for me because my home(s) are being bugged and I am being threatened all the time.

Eastern Police need to be sorted out because this Maori Mafia aggression can be aligned to the aggression all people want to see and end to. I will go public again and again and again and Napier CityCouncil and Napier Police will be mud and justifiably so.
