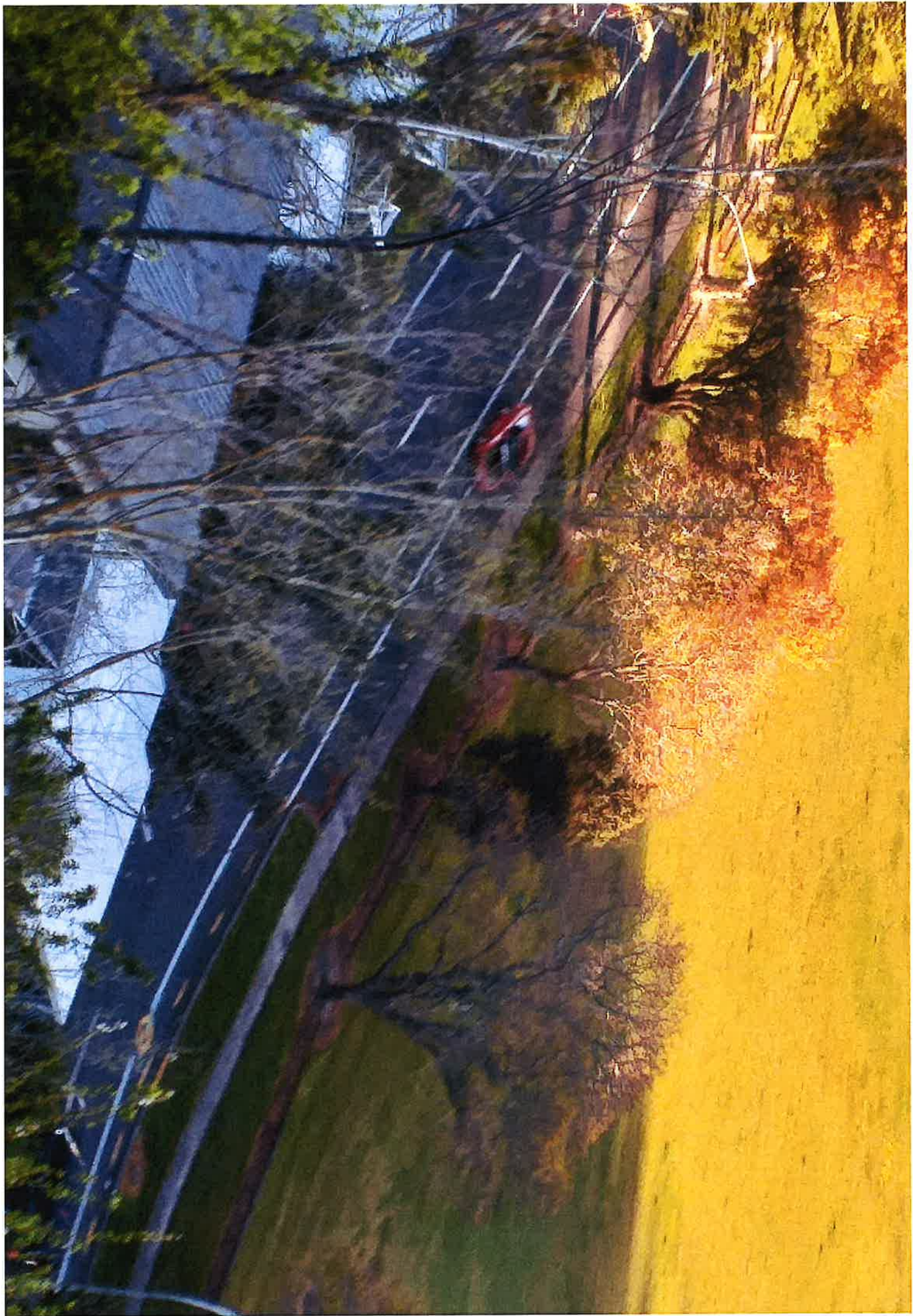

You have taken photos of the subsidence in the corner on the boundary to us. That was retaining using large coarse grade interlocking stones which aren't supposed to move. Well that didnt stop the subsidence. That area you took a photo of is failed retaining. It has slumped at least a metre and gets worse all the time.

The people in 28 had the same problem and I understand theirs has failed also and needs redoing but they are in their late 80s and it us unlikely to be fixed in their life time. Both owners of these properties did their retaining around the same time and both have equally failed because the land wont hold it and the water causes subsidence under it.

Both these subsidences are linked to the events on our property. It is the same passage of water being redirected by the two sets of apartments.

This council going to great lengths to hide this water and yet there is evidence of it everywhere including the land above little burke st and the top of main st. The council deforested that area to try to dry it out. It was sodden with water and you wouldn't have to go down far to strike wet dirt not too dissimilar to the water found on our property.

It really frustrates me that people are so desperate to hide this water on their properties to keep their values when they could force this council to manage the water and stop ignoring it and redirecting it or forcing new homeowners to build on it.

No homeowner is legally allowed to knowingly sell bad housing or land and yet this council does it with reckless abandon.

I want this council to finally be held accountable not only for the damage caused by their development with no due diligence but to also be held accountable for the gross illegal behaviour of governance breaking and e tearing our home multiple times and introducing police into a civil matter turning me into a criminal when I am the victim..

At the end of the day, all I ever wanted was for this Council to engage with us over the water and movement of our house(s) being 28 & 30 Hospital Tce. This Council has a reputation for acting illegally as the Friends of the Onekawa Swimming Pool proved.

Why is it so difficult to have a Council engage with a ratepayer in a decent manner? Why do they have to be so aggressive towards ratepayers? BECAUSE THIS IS A GOVERNMENT DRIVEN SUBDIVISION AND MANY RICH INVESTORS ARE WANTING THEIR PAYDAY. THEY WANT THIS SUBDIVISION TO GO AHEAD REGARDLESS OF **NO DUE DILIGENCE**. They engaged with ratepayers BUT the whole nature of this subdivision has changed and there is a reason behind this....NOT the height of the building....the water beneath with I told TODD DEVELOPMENT about.

We are the recipients of all rogue water through the top of the hill and our home has been here since 1910...long before NCC even built the road. It has historical significance. It still has the old roof line of the original house and a lot of the old native timber survives. It is the house of a Ship's Captain whose ship harboured in Ahuriri.

My engagement with Tanya Wright ended with accusations by the Strategy Team that we had done damage to my own home and they were definitely unwilling to look at water issues coming through from Clint Rickards property (because he wanted to build a 30 ft cardeck on water damaged land – which will definitely cause more land damage on our property) which upon further investigation has been found to come through their property from the hill and made worse by the redirection of water by poor due diligence resulting in the building of the North Ridge Apartments across a drainage point. In the last 15 years significant damage has been done to the land and the recent developments at the subdivision has increased this.

My discussions with Wayne Jack about water being pumped out on the subdivision (long after the building had been removed so it was NOT BUILDING RELATED) ended with him pulling the pumps at the top of the subdivision and actively hiding the water's existence.

Not one of you will talk to me or respond to anything I have told you. THAT IS ABUSE AT MANY LEVELS. I am not certifiable as John Harrison suggests. I have done my homework – unlike others. How Todd Land Developments got talked into this dodgy development is something they need to look at seriously. Someone brokered a deal on false information.

I'm sure you are all waiting for the Engineering report to return your attacks (I have kept all emails!) and try to bury me .....but you have all let me down by not talking to me about the issues (Tanya Wright refused to



give me the email addresses for the Strategy Team as well) and forcing all costs to resolve it on to us. We spent \$50,000 in total to stabilise our home and it still moves – not as fast – but it is still happening – WATER HAS NO MASTER.

Lets just hope that after the 20 day privacy act period (enforced by NCC) has elapsed, that no more illegal behaviour is entered into – such as - withholding documentation sought by Tower Insurance who are completing an engineering report.

1. We know the Hospital Hill area leaks like a sieve (like the Guys Hill road house that was washed off its foundations).
2. We all know that there were pumps working for decades under the Hospital so you can't say they didn't exist – even if you do pull them out.
3. We all know there were leaking issues into the apartments at North Ridge Apartments when they were first built – that is common knowledge as people couldn't sell their apartments until it was fixed
4. Whilst people will lie about it to keep their property values, WE know that the Oliver's house at 28 and ours at 30 Hospital Hill BOTH MOVED and two days later theirs was on the market.

We have a high water table and Hospital Hill has pumas stone sections and water rises up. Then it flows down using the networks of pipes and soil and the boulders used to build the road.

This is being forwarded to Tower. After what I have been through I have very little faith in anything to do with Council or Government. None of this should be happening and yet it is.

I am making a formal complaint to you about a cover up of police breaking the law in Hawkes Bay and this information not properly recorded on personnel records and abuses by police continued as undercover monitoring of Velma Farquhar.

I also want to bring a complaint about Stuart Nash MP and head of police in his actions to support a cover up and to allow John Harrison and Tanya Wright to go free after committing abuses against Velma Farquhar in her home bug placing recording devices and cameras (cyber attack). I have made numerous complaints to the Independent Police Conduct Authority about the invasive cyber crime used and no one has ever responded because Police are involved, committing crimes against someone to shut down freedom of speech and human rights using invasive techniques like I was some terrorist or major criminal. There is no way I should have been treated like this and all costs to find a resolution have been pushed into my purse. Fortunately my insurer is meeting costs for a report but this is just the start of a very long battle with a council who acts illegally. Recent events with the Onekawa Pool has shown this Councils propensity to not abide by constitutional law. WAYNE JACK CEO has acted illegally and bullied councillors and all councillors have been forced to hide this illegal behaviour committed against us at 30 Hospital Tce. This Council should never have the power to act illegally against a ratepayer and then force all council members to hide it.

I have sought information through the proper channels about the invasive cyber attack against me and the constant monitoring. Shortly, after complaining about the monitoring, most of it stopped but there is still one guy who STILL monitors me and I am sure my home is still being WIFI attacked. I call this WIFI RAPE.

The connection between Eastern Police and Napier City Council is not lawful. Napier Councillors Tanya Wright and Keith Price are EX POLICE from the era when CLINT RICKARDS was in charge and now Rickards owns the house next door.

I have major issues with water not being properly managed by NCC during consent process causing the redirection of water and NCC Governance have used Police to intimidate me by saying I am on a watch list. I went to the IPCA to report this and for them to confirm this statement. They advised this was incorrect.

A builder was engaged and this was addressed by a concrete footing with drainage pipes and a network of reinforcing rods etc. It has made a big difference to the stability of the property on the sea side. However, the water has continued to seep through under the new concrete and we believe this water is coming through from the hillside, both under the structure of the road, the foundations of our house (which looks dry on top when investigated) and through from No 28 Hospital Tce as their roadside wall is not complete to the ground and as our house is downhill from them the water flow through our property to the lowest point.

We have retained our property into levels so we can deal with the a) the water washing our land away b) unwillingness of Napier City Council to provide us with access to stormwater connection which they took away from all houses affected by the current water issues back in 1930 when the built Hospital Tce.

(No stormwater access/ redirection of water into our land by the building of North Ridge Apartments – no water consents issued and nothing done to deal with water passing directly through and under the apartments foundations / the creation of a new subdivision which used to have pumps draining water to the road but now drains into the covering soil and by easiest access of the Road structure of boulders and pipes – water flows down from the apex of the road into the land of three properties)

Dear Ms Mahuta

You should be aware of the need for full transparency by local authorities. We expect your office to ensure that all local authorities are acting in accordance with the law and that they are not misusing their position and creating human rights violations. The action of issuing its own resource consent, knowing there are rogue fissures all over Napier Hill and that 100 - 200 metres away there is water pouring out from under a house at 22 Guys Hill road (which council had not found the source of and is believed to be coming from the Hospital Hill area) is a violation of our local bi-laws and probably several other general bi-laws implemented all over New Zealand.

Simply by taking a walk all around the Hospital Hill area of a radius of 100 - 200 metres you will see roadside walls nearly falling down and the ground is always wet. The water is draining through peoples properties all over the Hospital Hill area. This is all year round and not just in winter. You have to remember I have been complaining about water emanating from higher up the hill for three years as this water has always been tracking through 3 roadside properties just down from this subdivision. Water is a destructive force which

cannot be ignored. It has no master and will be more precious than gold in years to come. This council abuses it and drains it for selling overseas.

The resource consent should have been issued by an external party such as the regional council to ensure maximum transparency. This agreement may have been before the council current structures were put in place but the resource consent should still have had an external party assessing it to ensure all matters are included in the consent application and approval process. If this land was being developed by an external party I am certain council would have looked at the potential water issues. This whole situation smacks of misuse of power and a process that is so flawed it has to be corrupt. If you are the developer you should not be issuing consents for your own work. You most certainly should not be doing it when your main purchaser of your work is a high profile Corporation who also has powers to bend the rules in its favour!

Council must acknowledge the fissure problems and stop hiding behind some veil to stop communicating with residents affected as if no one is allowed to be made aware of a) their acknowledgement and b) how they are going to fix it. If they don't do this the whole situation is a farce and unlawful.

The fact that this business deal the Napier City council has done with Todd Corporation is bent in favour of Todd Corporation and at the cost of all residents is gross mismanagement and they way this was done behind closed doors with no opportunity for input by surrounding residents is an abuse of power.

This council has to be made accountable for its behaviour. The gutlessness of councillors to stand up and declare that this is a infringement of residents rights and a misuse of council power as a local authority does not indicate there is no guilt. It states that Mayor Dalton behaves in a threatening manner so that frank open discussion can not take place. This is 20 years of his tyranny and it has damaged Napier City council management and its relationship with the Napier People and Napier as a City has suffered because this miser has refused to spend money on facilities this City very much needs!!

The only thing he has spent money on is a white elephant that doesn't pay its way on the Marine Parade and support Napier Port by providing numerous facilities for them at the expense of residents. Hi Greg and Peter Boshier

I have just driven past the subdivision. It is pouring with rain still and has been for most of the day. There is a pump functioning on the side of the road pumping water off the subdivision. It is below ground. This is what I have been telling everyone. There is a huge catchment of water on that site and it is not being managed. We are being affected by the Container Parks surrounding the hill. The Containers are dropped from a height which, for us in Napier with a high water table this is nothing short of FRACKING.

The water beneath the soil level is not too dissimilar to a water bed. If you punch the waterbed - *anywhere* in the waterbed - you get a disruption of the water into crevasses where it wouldn't normally go. It weakens the fragile eco system of both Napier Hill (by way of fissures) and the precious water reservoirs which service Napier.

We have an ancient fissure at the top of the hill which was used by the infantry and the make-shift hospital. It was used before the earthquake - before the land rose sufficiently to stop the fissure from breaking cleanly through the ground at a level that it could be utilised as fresh water.

This water has been leaking through the substructure of the land for a long time but with recent pounding of our ecosystem the water has been pushing up through the fissure again in greater volumes and leaking underneath the hospital so it had to be pumped out regularly. We all saw water being pumped out as it reached a level that the pumped kicked in – in all types of weather.

This pumping has stopped because the fissure is being ignored and is now just pouring into the landscape and under people's homes but in greater volumes. Fracking increases the water being pushed up through the hill rock and up into the soft top soil. COUNCIL WILL NOT ACCEPT RESPONSIBILITY FOR DAMAGE DONE TO LAND BY FISSURES AND INSURANCE WONT COVER IT SO.....sit on your hand and you pay the price of damage done to the Napier Hill.

We have a prick of a Council here and unless you act in unison to fight and stop the vibration to the hill and the damage to our water the Council and Napier Port will continue to damage our lives and our futures. I am tired of acting on my own. I am tired of being treated like a nutty bitch. There are loads of stories about how people are forced to go to court against the council. *Lambs to slaughter is all we are .....Animal Farm.*

You don't have to have a science degree to see what is happening. We have a new fault line off Hawkes Bay and these things don't happen in isolation. No one told us about the new fault line. That was a big secret that the insurance companies unveiled ON TV so they can up their rates. Council never told us!!

Having water force its way up through the hill doesn't happen on its own. No earthquakes are causing this....it is man-made daily damage to our drinking water and the Napier Hill.

THIS IS THE COUNCIL AND NAPIER PORT DRIVING THIS. It wont happen and it certainly won't happen at 11.00pm when you can hardly see what you are doing!!!
