1. What exactly has been done since 4 August to fregress The Expats application?

The Commission first matched the forms to the spreadsheet provided to ensure that over 500 members had been provided. This took some time as it in tolded obtaining forms from different sources provided at different dates and then matching to the preadsheet. Once this task was completed, each form was checked to make sure each form was valid. As part of the checking process, the Commission identified that there was a whole set of missing forms recorded in the spreadsheets. We contacted Grant Chessman who indicated that he had failed to send them issing PDF in an e-mail on 7 August 2014.

Following this, enrolment checks were undertaken. On 8 August 2014, the enrolment checks of 50 randomly selected members resulted in 31 members not being found on the electoral roll. On 8 August, these 31 members were sent to our Enrolment Services team who have a more sophisticated search functions. On 1 August, Enrolment Services advised that they had located a further 4 members on the electoral roll. Contate, we are unable to determine whether 27 out of 50 are eligible to be enrolled. However, we will contract with these enrolments checks after 9 October 2014.

On 2 and 13 August, 2014 we began contacting members via telephone to verify whether they were ek be to be an elector. We spoke with 6 members who verified they were eligible. We left messages with a further 5 members and two members could not be contacted via telephone.

It should be noted that these tasks were undertaken at a time when the Commission had a large number of other tasks to complete in light of the 20 September 2014 General Election.

2. How long does it usually take for The Commission to run a spreadsheet test against its database?

This will vary depending on the quality of the application, but usually about 1-2 days.

3. Why is the check done against an enrolments database when it is not a requirement that a party member be enrolled, only that they be 'eligible to enrol'?
This is the quickest and most efficient means of checking a member's eligibility to be enrolled.
4. The process that is to be followed by the Commission is detailed on its website and reproduced below. Having regard to that process:
4.1. Have checks are carried out on a random selection of valid forms to establish whether the members are eligible to enrol. If so, on what date?

4.2. If a member did not appear to be enrolled did the Electoral Commission try to contact him or her to be satisfied the member is eligible to enrol? How many members were contacted and when?

4.3. Have the checks been completed? If so, on what date?
The checks have not been completed. The Commission stopped processing the application on 20 August 2014 (writ day) because the Electoral Act bars the Commission from processing an application for registration between writ day and the return of the writ (Thursday 9 October 2014).
4.4. If they were completed, what was the error rate, the sample size and the number of errors in the sample? See response to question 1.

For those members that have signed a form that does not confirm eligibility, the best way to remedy their form is to get them to add in the information regarding when they were last in New Zealand and then initial and that the change.

You could then resubmit all of the forms you want considered as part of the application and the one spreadsheet which can be easily matched to the forms submitted. Ideally the order in which the forms are provided matches the order of members in the spreadsheet.

Yesterday in Kristina's email the Commission advised us that, the '301 forms where the member has confirmed that he or steps a New Zealand citizen and confirmed the date they were last in New Zealand' ... 'appear to provide sufficient evidence for the Commission to be satisfied those members are eligible to enrol in New Zealand'

As to the balance of the forms (244), you advised that 'the member has only confirmed that he or she is a New Zealand citizen and has not provided information about when they were last in New Zealand' and that as a result of this 'the Commission is unable to accept these 244 forms as evidence of eligible memberships for the purposes of registration'.

We took from your email that obtaining written confirmation that the members were last in New Zealand would satisfy the Commission of this detail.

As we have now obtained this information, we seek specific guidance from the Commission as to how it wishes for us to present the information, for example should we resubmit the 244 forms in question with:

- the last year (or month and year) the relevant members were in New Zealand notated on the form; or
- the emails filed behind the enrolment form; or
- a combination of 1 and 2 above; or
- some other means.

We accept that you would like one spreadsheet. That is easily remedied.

Please contact me to discuss urgently as we want to make sure that there are no miture erstandings and that this is completed today if possible. I will also conference in the party secretary.

The information that you have now provided does not meet the Electoral Commission's requirements. The membership form signed by the member must demonstrate that the person is a financial member that is eligible to enrol.

You have provided as part of your application:

- membership forms in which the member does not say that they are eligible to enrol or confirm that they are a New Zealand citizen that has been in New Zealand within the last 3 years, and
- then separate e-mails (just received) in which members state when they were last in New Zealand which the Electoral Commission will have to cross reference to the corresponding membership form, and
- effectively four separate spreadsheets that the Commission also has to cross reference.

You need to provide

- a complete set of membership forms in which each member has signed a form including:
 - the member's name and residential address,
 - confirmation that the person is eligible to enrol as an elector,
 - the amount of membership fee paid to the party,
 - authorisation for the party to record them as a financial member of the party, and
 - authorisation for the party to release their membership data is to the Commission for the purposes of the application to register the party, and
- one spreadsheet which can be easily matched to the forms submitted (ideally the order in which the forms are provided matches the order of members in the spreadsheet).

Section 64 of the Electoral Act provides that at the time in the period commencing on writ day (which is Wednesday 20 August for the 2014 general election) and enting with the day appointed as the latest day for the return of the writ (which is Thursday 9 October 2014) shartion be taken by the Electoral Commission in relation to any application for the registration of a political party.

Given how close it is to write day, and the fact that we still do not have an application from you that meets the Commission's requirement, time is running very short to get your revised membership evidence in and for us to complete the checking of the membership evidence and the two week public consultation prior to write day.

Please take time to carefully check that revised membership evidence meets the requirements before resubmitting it.

We would be happy to review any proposed approach you intend to take to compile the evidence before you proceed.

Tab 1 is the original spreadsheet. Of the original 249 in red, 11 have become ineligible (see tab 4 for reference), we have received confirmation from 164 and awaiting responses from 74 members.

Email date confirmations will be sent via another email/s.

Tab 2 is an additional spreadsheet of new names for submission to make up for this shortfall. These forms were provided in Feb 2012 to Dean in 5 emails. All of these forms were date stamp as per requirements.

Tab 3 is a group of additional new members that we have received recently. We have attached their forms below (see New Expat Party Members No 1 & 2). If their form isn't date stamp and there is a date marked in the column provided we have received an email with their date confirmation and t will be provided in the separate emails.

Tab 4 is the ineligible list. We thought best to keep this just in case you come across a form provided previously that has now been removed from the spreadsheet.

In total we calculated the following:

We have completed the first step of processing your registration application, which involves making sure we have 500+ signed membership forms. This has taken some time as it has involved cross checking the pdf forms or images from the drop box with the two spreadsheets you have provided which are not in any sequential order.

The Commission has been unable to find a number of forms for members included on spreadsheet A. We have attached this spreadsheet – highlighted in green are the members we have found actual forms for. Those not highlighted, we have been unable to match to a form provided. This means we have only found 192 members

with matching forms in spreadsheet A. In spreadsheet B, we were able to match 298 forms.

Based on our initial checks, this appears to bring the total forms supplied to the Commission to 490. As this is less than 500, you will need to supply the additional membership evidence to continue to process the application. If these are new members not included on spreadsheet A or B, you should also submit an updated spreadsheet. MOCHENHA We refer to your email dated 23 July 2014 which asks that the Board consider amending its registration process so that enrolment and authentication chacks can be run concurrently with the public consultation phase. This reply has been prepared in consultation with the three Electoral Commission Board members.

The Board has considered your request and will no be making any amendments to the party registration process.

The Commission's internal process for the legistration of political parties is approved by the Board. The process applies equally to all applicants. The process includes a number of quantitative and qualitative steps to ensure that a party applying for registration meets the evidential criteria set out under the Electoral Act 1993. The Board considers that a robust process is required for the egistration of political parties as registered parties are:

- entitled to submit a party list and contest the party vote at a general election; entitled to have their logo on the ballot paper; and
- eligible to be considered for an allocation of public funds under the Broadcasting Act 1989 for the proadcast of election programmes.

The enrolment and authentication checks are conducted to ensure that a party applying for registration has 500 financial members who are eligible to be enrolled as electors. If the Compression is satisfied that this is the case, the application is publically notified in five newspapers and on the Commission's website.

મુંદ્રેમાask that the public consultation phase be run concurrently with the enrolment and whentication checks. The Board considers that it would be inappropriate to seek public comment on a party's name and logo before the Commission has verified the membership evidence required for the applicant to even qualify for registration.

The Board also considers that all applicants for registration as political parties must be treated consistently. It would contravene the statutory scheme to have different requirements for applicants because applicants have applied close to the date of dissolution for the purposes of the broadcasting allocation or writ day for the purposes of contesting the party vote. We did advise that it can take 6 to 8 weeks to process an application for registration. The Commission has a number of other current applications

to process and has applied the same procedures, for example, to the 9 other applications for party and party logo registration that it has been considering in June and July of this year.





It is important that New Zealanders are given clear positive accurate advice on where they should enrol and the advice on the elections website - 'Your electorate will be the one in which you last lived for a month or more' is simply not correct.

However, if you have permanently moved away from that address, it is open for you to another an address in another electorate provided that:

- you lived at the address you intend to enrol at in that electorate for media than one month; and
- you consider that place to be your home by reason of family or personal relations, or for other domestic or personal reasons.

It is not open for you to enrol in an electorate, other than the electorate where you last lived for a month, if:

- you are only temporarily absent from New Zealand, or
- you are doing so for reasons other than family of personal relations, or other domestic or personal reasons.

An elector must know their New Zealand address in order to enrol. You can seek help to find that information by e-mailing enquiries@elections.org.nz OF phoning the Electoral Commission +64 9 909 4182

Further to our telephone conversation earlier this week and your email below, please find our responses to your questions below.

Electorate test

The opening sentence starting 'Your electorate is where you consider to makehome " may mislead electors. It could suggest that a person's electorate is where they might make their home or see as their home even if they have never lived there. The test does require a person to have resided at the address for more than a month prior to leaving New Zealand.

The legislation does clarify that a person's home for enrolment purposes does not change just because they were temporarily absent from that place, for example, a student who regards their home as their parent's house but was absent studying.

The Commission would not advise electors that the place that a person made their home prior to leaving real and can change because they decide that they now prefer one of their earlier addresses.

An elector must know their New Zealand address in order to enrol. A person who has previously been enrolled at that address can seek help to find that information by phoning the Electoral Commission +64 0 08 4182 or emailing enquiries@elections.org.nz.

As discussed, the Expats understand the formal guidance that should be given to offshore voters who have permanently left their former New Zealand residence is that

Your electorate is where you consider to make his or her home by reason of family or personal relations, or for other domestic or personal reasons.

In some, but not all cases this will be where you last resided in New Zealand (per the official guidance) but this will no always be the case.

For example:

Jack went to Otago University for 4 years and shortly thereafter left for overseas. Before leaving Jack stayed with his parents in Christchurch East. Jack's parents house was destroyed in the Christchurch earthquake and his parents moved to Nelson. As Jack has permanently left his former home if Ohristchurch he is deemed to no longer reside at that place. Jack no longer feels connected to Christianurch and feels most personally attached to his Hyde Street flat in the Dunedin North electorate. Jack a Electorate is therefore Dunedin North, not Christchurch East.

Please confirm the above is correct. If taking the above guidance into account, electors feel they have incorrectly enrolled, please also confirm that they can they update their enrolment details.

Also, please confirm what electors should do that have forgotten their old Dew Zealand address?

As discussed by phone today, here is the advisory that we recently sent to all party secretaries on the issue of treating.

Dear party secretary,

There has been considerable recent interest about the offence of treating under section 217 of the Electoral Act 1993, and the implications this has for the provision of food, drink, entertainment or other provision at political party events. Given that this matter is of general interest, this advisory has been sent to all party secretaries.

Section 217 is broadly phrased in the persons to whom it applies: it covers:

- Actions by "any person" and extends both to their actions and actions "wany other person on his or her behalf"; and
- Actions whether taken "directly or indirectly"; and
- Actions "to or for any person".

Section 217 is broadly phrased as to the period during which it applies: it covers actions "before, during, or after an election" i.e. it is always applicable.

Section 217 is broadly phrased as to the actions it covers it makes anyone who:

- "gives";
- "provides"; or
- "pays wholly or in part the expense of hing or providing";
- "anv food"; or
- "drink"; or
- "entertainment"; or
- "provision" a word of ພາເຂົ້າຕໍ່ain application

liable for prosecution for the corrupt practice of treating, if done "for the purpose of corruptly" influencing that person to, generally put, a ler heir voting behaviour or procure the defendant's election.

It also makes the person corruptly accepting the food, drink, entertainment or provision liable for treating.

The consequences of a conviction for treating are major, including imprisonment, loss of a Parliamentary seat or disqualification as a voter for 3 years.

Although the ambit is broad, the threshold for establishing treating is also high - a corrupt intention is required. The Courts have previously held that the offence of "treating" requires an intention on the part of the person treating to influence the votes of the persons treated.

The question of intention is an inference of fact which the Court has to draw. If in any case, looking at all the circumstances, the reasonable and probable effect of the alleged treating would be to influence the result of the election, or to influence the votes of individual voters, it might well be inferred that it was the intention of the persons treating that this effect would follow. This means that the scale of what is being provided is relevant to whether the provision would be likely to influence and whether the intention of the provider was to influence a voter.

The Electoral Act states that the provision of a light supper after an election meeting does not constitute the offence of treating. The provision of a cup of tea or coffee and a light snack after a campaign meeting, therefore is not treating.

There are very few Court cases on the offence which makes it difficult to be definitive about what will constitute treating. However, in the Commission's view these are some of the factors that we believe are relevant considerations:

- the scale and commercial value of the food, drink, entertainment or other provision are relevant. In our view this is key: treating requires a corrupt intent and a likelihood of influence- it does not apply to ordinary hospitality that is incidental to a political meeting,
- the target audience of the provision providing food, drink, and entertainment at an AGM, campaign aunch or annual party conference where the primary audience is party members is unlikely to be treating, but providing food, drink and entertainment at a public meeting carries more risk, and
- the extent to which the provision is accompanied by other political material.

In the Commission's view, to avoid complaints it is prudent for parties and candidates and their supporters to act cautiously and with restraint in providing food, drink – especially alcohol - and entertainment as part of their political activities.

Any person who is concerned that what they are proposing could constitute treating can seek the view of the Electoral Commission on particular proposals and the Commission will provide its view. The opinion of the Electoral Commission is not legally binding. A Court of law may reach a different view. Parties and candidates who have concerns about compliance can also seek their own legal advice.
