13. *Please release all correspondence between senior NZ On Air staff regarding the choice to fund this documentary. If there are any relevant board minutes, then release those too.*

This has been answered in our 20 May information release. All correspondence between senior NZ On Air staff regarding the choice to fund this documentary took place at our 15 November 2021 Staff Investment Committee meeting and was recorded in the corresponding minutes.
