Thank you for your email of 24 May 2022, in which you requested, pursuant to the Official Information Act 1982 (the Act), 15 reports that had been provided to me.

On 2 June 2022 I notified you that your request for item 8 – 01/04/2022 "DPMC - Aide Memoire: Russia-Ukraine - a long term problem for the international community" – was transferred to Department of Prime Minister and Cabinet pursuant to section 14 of the Act.

- section 9(2)(g)(i) of the Act, to enable the continued effective conduct of their duties through the free and frank expression of opinion
- the name and contact details of point of contacts are withheld, respectively, in accordance with section 9(2)(g)(i) of the Act as described above, and section 9(2)(a) of the Act, to protect privacy.

Your also requested the following two documents:

The matters in these documents are addressed in the Ukraine material that will be released on the Ministry's website. These particular documents were draft and therefore are withheld in full under section 9(2)(g)(i) and section 6(a) of the Act. Where information has been withheld under section 9(2), it is not considered that the public interest in this information outweighs the need to protect it.

Under section 28(3) of the Act you have the right to request the Ombudsman investigate and review this response.
