Thank you for your letter of 9 November 2020 requesting that I review, and reconsider, a decline decision made in July 2020 by the previous Minister of Conservation. This involved a reserve revocation proposal for part of the Marine Park Recreation Reserve, Sulphur Point, Tauranga.

In considering your request, it was necessary to determine whether the Reserves Act 1977 includes any appropriate reconsideration powers. The advice provided to me by the Department of Conservation is that there are no provisions under the Reserves Act 1977 that provide for the reconsideration of a decision once made.

I am sorry that this will not be the answer that would have been hoped for, but I would strongly suggest that you contact David Griffin, Manager – Statutory Land Management, (dgriffin@doc.govt.nz) to discuss what the next steps might be.
