Thank you for your email.

We have commissioned an updated study of the ramps and use of the wider area, to confirm the earlier study done by Xyst. It confirms the position that there is very little recreational use of the area subject to revocation and that the observed use is mostly associated with vehicles in adjoining zones. An excerpt of the executive summary: "There appears to be little active recreational use of the grassed area at Marine Park considering its size. Most people observed were associated with vehicles in Zones 2, 3 and 4".
