In accordance with Clause 5 of Schedule 1 of the Resource Management Act 1991, NPDC hereby notifies the Proposed District Plan on Monday 23 September 2019.

Intent of Proposed District Plan

The District Plan is the key document controlling where activities can locate in the district and how land can be used and developed. The Proposed District Plan addresses the key issues identified in NPDC's Operative District Plan review. It provides direction on what can be built and where, with provisions that:

- Provide land for housing, industry and business in the right location.
- · Support successful and vibrant city and town centres.
- · Cares for the coast and coastal communities.
- Protect the natural and cultural features our communities' value.

They will also have the right to appeal any decision the Council makes in respect of their submission, to the Environment Court.
