The relevant council experts have been extremely busy preparing the council's response to the National Policy Statement on Urban Development and have just managed to respond to your request. The specific details of your request and our response are below.

Please send me all reports, presentations, and attachments that are referred to in the confidential minutes for the Planning Committee meeting that was held on Thursday 2nd June 2022.

Two items were considered in the confidential section of the Planning Committee meeting on 2 June 2022.
