I refer to your correspondence of 3 September 2014 requesting under the Official Information Act 1982(OIA) information held by the Minister of Justice. Specifically you requested "...a list of the subjects of requests to the Minister of Justice, made under the Official Information Act within the last 5 years, that were not refused."

On 15 September 2014, after a discussion with a Ministry staff member, you refined this request to the preceding 3 years.

Attached to this response is a list of all OIA requests processed by the Ministry of Justice in the last three years, including the date of receipt and date of compliance.

You further requested if it was possible to "indicate the volume of the response."

I have been advised that it is possible to provide volume sizes of responses, but due to the number of requests this would require substantial collation and research and take considerable time, and therefore I have declined that part of your request under section 18(f).
