Resource Efficiency and Emissions Policy

Statement of intent

In alignment with our Climate Action Framework and Zero Waste 2040 vision, we are committed to being resource efficient and reducing our emissions.

Purpose

This policy is to guide staff when making decisions that impact on our resource use and/or emissions in relation to council operations. It is intended that this policy will encourage comprehensive thinking, including the consideration of potential trade-offs between different environmental benefits and implications when making decisions.

Objective

Under this policy we seek to provide leadership within the Taranaki community in the areas of energy and water efficiency, management of emissions and progress towards Zero Waste.

Targets

We have set the following targets to be supported by subsequent plans:

- a. Continuously improve Council energy and resource efficiency.
- b. Council produces nett zero emissions within a calendar year by 2050.
- c. Achieve the zero waste targets set out in the Council's Waste Management Minimisation Plan
- d. Achieve the water consumption/efficiency targets in the Council's Water Conservation Plan.

We will

- 1. Support and align with efforts made within the Climate Action Framework.
- Support and align with Tapuae Roa and the Taranaki 2050 Roadmap. This policy will enable Council to contribute towards the objectives of these strategies as a key stakeholder in the region.
- 3. Monitor and publically report on energy and water use, emissions, resource recovery and waste generation from Council and future projects.

- 4. Identify and capitalise on opportunities to reduce energy and water use, greenhouse gas emissions and waste generated from Council operations and future projects.
- 5. Promote a culture of awareness and responsibility amongst staff with regard to the requirements of this policy.
- 6. Develop plans to deliver the targets and goal set within this policy.

This policy is effective from 1 July 2020 and reviewed every 2 years.
