Please find the requested documents attached to this letter as Documents 1-8. All documents are itemised in Appendix 1 and copies of the documents are enclosed. Where information is withheld under section 9 of the Act, I have considered the countervailing public interest in release in making this decision and consider that it does not outweigh the need to withhold at this time.

Please note, Document 6 titled "Memo: Aotearoa New Zealand's COVID-19 Variants of Concern plan: Initial version" refers to a draft version of the variants of concern framework. I have provided the updated version of the framework, which is attached to this letter as Document 9.

If the minister received any other Briefings to the Incoming Minister upon taking up the COVID-19 Response portfolio in June 2022, for instance from DPMC or any other agency besides the Ministry of Health, then I would like to request copies of these as well.

If the minister received any Briefings to the Incoming Minister upon taking up the role of Associate Minister for the COVID-19 Response in February 2022, from any agency, then I would like to request copies of these.

These parts of your request are refused under section 18(e) of the Act, as the information does not exist. At the time of my appointment to the role of Associate Minister for COVID-19 Response, I was the Associate Minister of Health involved in the COVID-19 pandemic. As such, no briefing was necessary upon my appointment in February 2022.

However, I received Briefings to the Incoming Minister (BIMs) from the Border Executive Board, Department of the Prime Minister and Cabinet, Ministry of Business, Innovation and Employment and Ministry of Health in June 2022, which are itemised as Document 8 in Appendix 1.

Finally, I would like to request copies of all other reports, briefings, memos, or aides memoire received by the minister dated since 21 May 2022 on the topic of COVID-19 Variants of Concern planning and/or the Ministry of Health Strategic Framework for COVID-19 Variants of Concern (i.e. on the same topic as parts FOUR, SIX and SEVEN of my request above, but dated since 21 May 2022).

Two documents have been identified within scope of this part of your request and are attached to this letter as Documents 9 and 10. This includes the full variants of concern strategic framework as well as the covering memorandum. Please note, Document 9 is the updated version of the variants of concern framework. This document accompanies Documents 6 and 10.
