This issue has been raised by somebody in your industry within the last week.

i have spoken to our planners & policy team and it seems that the rules come from our Election signage rules which in turn are based off the act <u>Electoral (Advertisements of a Specified Kind)</u>
Regulations 2005 (SR 2005/147) (as at 23 June 2017) — New Zealand Legislation

The rules do not provide a differential for upper and lower case lettering and only provide a broad over-arching rule that 120mm lettering height must be used on election signage.

Because of this I must advise that all lettering regardless of Upper or Lower case must be 120mm in height.

I thought it might be helpful to provide Craig's sign with the 120mm height marked so you can see all the elements within and their relative heights.

We are just after clarification on if the height is based on the uppercase characters, or lowercase as it has a big impact on how text can be used.

It would make sense that the height restriction is based on the uppercase letter of a sentence. As you see with the 'Taranaki Regional Council' this line is in all uppercase, and set in a condensed font, which looks a lot smaller than the "World Class Care for Land, Water & Air" below it, — yet is the same height.

Statements in 'title style capitalisation' are easier for people to read and interpret due to the non parallel forms of a word, as opposed to a parallel word (uppercase).

We look forward to your input so we can get these printed.

I have spoken to our Principal Planner, Senior policy advisors & current planner who is in charge of the proposed district plans rules on signage.

I've found that our election signage rules stem from <u>Electoral (Advertisements of a Specified Kind) Regulations 2005 (SR 2005/147) (as at 23 June 2017) – New Zealand Legislation and while they reference roads directly controlled by Waka Kotahi it's the closest I could find from a governance perspective.</u>

These rules were set some years before the document you have provided & our district plan was also in place before both of these. To find where the reasoning for these rules and the definitions is quite challenging as most people involved have left the council.

It's for these reasons NPDC has decided to uphold the word for word rule that lettering size on election sizes must be 120mm within a regardless of upper/lower case.

Moving forward I suggest using the proposed district plans rules (Slightly different to the election signage rules we have now) for any advertising signage work you may do. If these specifications are followed we will consider them compliant under the proposed district plan so will fall outside the scope of the compliance under the current rules.

While I understand this is not the answer you would be hoping for I appreciate the time and thought you have put into this.



We did speak last month about some Section 7(2)(b)(ii) that didn't comply with either font size and physical size of the sign being too big for a permanent sign on a residential road frontage.

I probably didn't specifically mention Dinnie's signs but we did clarify that these temporary election signs had different rules and as long as we had the font size larger than 120mm we were all good.

Where I am confused about the issue with Dinnie's signs is where the 85mm measurement has been taken. In printers terms, the height of lettering is measured from the top of a capital letter to the bottom of the decender and this is the size of the lettering across the line of type.

All modern software still uses points as a font size measure and 120mm in points = 340 pt type which is a very specific font size.

And we understand this size lettering is the minimum size for readability and safety of road signs.

If these rules were compiled with any consultation with the industry that it is aimed at, this has to be the meaning behind the size of the wording.

The smallest we have used on these signs is 500 pt type and all of the uppercase letters are larger than 120mm and the actual height of the lettering used in the word "Mayor" is 160mm.

If an individual character, and not the top and bottom of the whole line is going to be used as the measure, then would that mean we also need to worry about punctuation too?

From an industry perspective, we believe we are making signs that comply with the intent of the rules (easy to read signs that can be read at a glance).

I have attached a scaled visual of Dinnie's signs showing measurements and page 3 shows how large the wording needs to be if you measure the punctuation.

Moving forward our industry is going to need to get clarity from your perspective so we can make signs that do comply.







I didn't think you would be too interested in history that goes back that far.


Moving forward with the new plan, if no one at council knows the history or reasons for them, how have the new rules come about and why are they being changed?

NPDC has received a complaint regarding compliance of your election sign with the District Plan rules. We have since investigated this complaint and your signage at 8 Northgate, (Photo attached) has been identified as non-compliant with one of our election signage rules & of Operative district plan signage rules:

Lettering size on signs in areas where speed limits are 70kph or less; lettering should be 120mm or greater.

Currently your measurements of the smallest lettering size stands at 100mm.

Could you please contact me with your response as to how you can modify or remove the sign so that it complies.
