Thank you for your emails of 3 October 2022, requesting the following information under the Official Information Act 1982 (the Act):

In the following article you mention that you have access to 'modelling' around future use of hydrogen in NZ. For the sake of being thorough I am also requesting all policy advice, reports and modelling you have access to, relating to Hydrogen and Green Hydrogen. Including, but not limited to the following:

Data, Results and methods for Energy and Financial modelling relating to use of hydrogen in transport, energy and fertiliser production.

Internal or external Reports, Advice and policy recommendations relating to hydrogen and Green hydrogen.

(OIA22-159)

All communications to and from your office relating to green hydrogen and hydrogen. The types of data I am requesting are as follows:

Meeting minutes and electronic communications (text, email, private message etc) mentioning or relating to hydrogen and green Hydrogen during your tenure as Minister of Energy and Resources.

Please note that these two requests have been combined for ease of reply.

A records search undertaken by my offficials has resulted in a very large number of email chains potentially falling in scope of your request OIA 22-159 (*All communications to and from your office relating to green hydrogen and hydrogen*), totally over 300,000 emails. Therefore, I am refusing this part of your request under section 18(f) of the Act, that the information requested cannot be made available without substantial collation or research.

One document that falls in scope of your requests, entitled *New Zealand Hydrogen Scenarios: Report to MBIE* is publicly available. Therefore, I am refusing this part of your request under section 18(d) of the Act. Another document that falls in scope of your requests, entitled *Briefing: Potential hydrogen* export development with Korea is withheld in full under section 6(a) of the Act, that the making available of that information would be likely to prejudice the security or defence of New Zealand or the international relations of the Government of New Zealand.

Please note that some information from within these documents has been withheld under the following sections of the Act, as detailed in the below Document Schedule:

9(2)(g)(i)	to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty;
9(2)(h)	to maintain legal professional privilege;
9(2)(j)	to enable a Minister of the Crown or any public service agency or organisation holding the information to carry on, without prejudice or

disadvantage, negotiations (including commercial and industrial negotiations); and

18(d) that the information requested is or will soon be publicly available.
