Hi Gretchen

We can certainly summarise the position in 2017 in the two relevant MECAS and the changes that occurred at each iteration.

It is not so easy to measure the increases – and certainly my intermittent data collections would not be able to provide.

For example, in 2017 there were five steps in the standard Midwives scale, and then there were 2 additional Steps introduced. Difficult to model this.

In 2021 there was a 'flat rate' increase to pay scales rather than a percentage, so variable increases could be argued.

One way of measuring the increases could be to take the total of the Base Salaries and divide by the FTE at various points in time.

I would think that to make a consistent source and trend line we would need to use HWIP data for this – it consistently groups "Midwifery" employees and has a quarterly collection, and does collect Base Salary and FTE.

The usual caveats would apply (e.g. excludes casual employees).

But a table like this might fit the bill:







The data showed a "decrease" of 0.2% in average salary (a drop of about \$150 on almost \$97,000 average salary) which we tried to explain by saying the following - (as we all know it isn't a real decrease):

Percentage change is dependent upon both the MECA rates and the mix of midwives on each MECA step. The change is the average change across the workforce and does not imply that this change applies to each individual midwife.

Looking at steps, it isn't easy as despite the MECAs we see 232 different annual salaries for midwives in 2021 and 2022 !!

However, just looking at those earning \$150k or more in 2021 and 2022, there are 7 less FTE in 2022. If you put them back into the calculation (at \$150k average which is low) it changes the calculation to show overall salary up by 0.2% - that is how tiny this difference is.....

If someone can say that in words not numbers, that should explain it o

This will almost certainly be to do with the FTE distribution – fewer Senior Midwives in proportion to other Midwives in the current data set when compared with previous years.


