Thank you for your email of 20 October 2014 requesting the number of people subject to compulsory treatment under the Mental Health (Compulsory Assessment and Treatment) Act 1992 (the Mental Health Act). We are happy to provide this information to you in accordance with the Official Information Act 1982.

As requested, this information has been provided for the years 2011, 2012, and 2013 by Māori and non-Māori, and district health board (DHB).

In addition, graphs of the rate-ratio between Māori and non-Māori for 2011, 2012 and 2013 have been provided to give greater context to DHB comparisons. The 99 percent confidence intervals assist to make allowances for the different sized DHB populations.

It is important to note that these figures do not account for the different demographic structures of DHB populations. To do this, the rates per 100,000 for each DHB would need to be agestandardized. This is a project we intend to undertake in early 2015.

I appreciate your interest in this issue. Reducing the disparity of Māori mental health outcomes is a priority for the Ministry. Analysing the data is a good step towards gaining a better understanding of Māori over-representation under the Mental Health Act. It is my hope that sharing this information will further underline the need for the mental health sector to engage in meaningful action to address the disparity of mental health outcomes for Māori in New Zealand.






