Official information request relating to Sefita Hao'uli

Thank you for your Official Information Act request received on 3 January 2023.

Your request refers to Sefita Hao'uli's citation for his appointment as a Member of the New Zealand Order of Merit in the New Year Honours List 2023. You have requested the following information:

Can you please let me know what is the term of reference of your "Arts Board" with Creative New Zealand. Also who sit on the art board besides Mr Sefita. The pay rate of your board member.

Creative New Zealand was established as a Crown entity under the Arts Council of New Zealand Toi Aotearoa Act 1994, replacing the Queen Elizabeth II Arts Council of New Zealand. A copy of the 1994 Act is available online at NZLII: http://www.nzlii.org/nz/legis/hist-act/aconztaa19941994n19395/

Under the 1994 Act, a seven-member Arts Council was constituted to fund and direct the policy of two boards; an Arts Board, with responsibility for the funding and promotion of all non-Māori arts, and Te Waka Toi, the equivalent for ngā toi Māori (Māori arts). A Pacific Islands Arts Committee was also established, to advise the Arts Board and fund Pacific arts.

On establishment, the Committee's roles and responsibilities were to:

- promote Pacific Islands arts and culture in New Zealand
- encourage access, participation and excellence in the arts
- advise and inform the Council and Boards on Pacific Island arts and cultural issues and report [to] the Arts Board on a regular basis
- allocate funding to Pacific Island arts, artists and community arts groups in accordance with the strategic objectives of Creative New Zealand's Strategic Plan
- collect, collate and disseminate information on Pacific Islands artists communities and organisations
- disseminate information on accessing resources available through other nationally and locally funded programmes of the Arts Council
- foster exchanges across cultures both nationally and internationally
- promote the unique relationship between the Pacific Islands communities/cultures and Tangata whenua.

The Chair of the Pacific Islands Arts Committee was an ex officio member of the Arts Board.

Mr Sefita came in as the Committee's Chair in August 1996 and remained Chair until September 1997, so most of his time fell within the 1996/97 financial year.

Our current Annual Reports contain information on Creative New Zealand's governors and the total value of their remuneration received in the relevant financial year. Unfortunately, older Annual Reports (including for the financial year to 30 June 1997, which covers most of Mr Hao'uli's time on the Arts Board and Pacific Islands Arts Committee) do not include this level of detail. We therefore decline this part of your request under section 18(e) of the Act, on the grounds that the information requested cannot be found, despite reasonable efforts to locate it. For your interest, the total expenditure on Council and Board fees for the year ended 30 June 1997 was \$110,000.

The 1994 Act was ultimately replaced by the Arts Council of New Zealand Toi Aotearoa Act 2014. Under the 2014 Act, the Arts Council, Arts Board (including the Pacific Islands Arts Committee) and Te Waka Toi were consolidated to form a single, unitary, 13-member Arts Council, with a statutory Māori committee to advise on ngā toi Māori (Māori arts). These governance arrangements remain in place today.
