Thank you for your email of 30 January 2023 to Oranga Tamariki—Ministry for Children (Oranga Tamariki), requesting information around ministerial appointments. Your request has been considered under the Official Information Act 1982 (the Act).

I have addressed each of your questions below.

A list of vacancy (ministerial appointment only, e.g. board member, Lay member, Trustee etc) that the nomination period has been closed but still under consideration by the Oranga Tamariki—Ministry for Children or relevant Minister.

In your list, can you please included the date that vacancy been advertised, what method you have used to publicly advertise the position, how many applications you have received and when the vacancy has been closed as well.

Each Care and Protection or Youth Justice residence has in place a grievance procedure as set out in the Oranga Tamariki (Residential Care) Regulations 1996. The grievance procedure provides a forum for young people or rangatahi to articulate their concerns and to have their complaints dealt with fairly to ensure that Oranga Tamariki meets its legal obligations to provide a safe and rehabilitative environment for young people or rangatahi. Every child and young person placed in a residence has the right to access the grievance procedure to lodge a grievance and the right to advocacy.

A Grievance Panel is appointed to oversee grievances lodged as part of this procedure. Each panel member is appointed by the Minister for Children on the nomination of the Chief Executive of Oranga Tamariki, following consultation with the Principal Youth Court Judge, the Principal Family Court Judge, and the Children’s Commissioner. Each panel also includes a tangata whenua member from the area in which the residence is situated.
