 Provisional 2023 quality-linked terminal dues
rates

Dear Sir/Madam,

This circular is issued pursuant to articles 29, 30 and 31 of the UPU Convention and concerns the calculation of the provisional 2023 quality-linked terminal dues rates for small (P) and large (G) letter-post items, and for bulky (E) and small packet (E) letter-post items (hereinafter referred to as E format letter-post items).

I. Provisional 2023 quality-linked terminal dues rates in accordance with articles 30 and 31 of the Convention

Articles 30.5 and 31.2 of the Convention and article 31-107 of the Convention Regulations provide that the payment of terminal dues for the exchange of P/G format letter-post items will be based on 70% of the charges, exclusive of VAT or other taxes, for a 20-gramme small (P) and for a 175-gramme large (G) priority letter-post item in the domestic service, in force on 1 June of the year preceding the calendar year to which the terminal dues rates apply.

The terminal dues rates for E format letter-post items are calculated on the basis of articles 30.5 and 31.2 of the Convention by tilting the P/G format line at 375 grammes, exclusive of VAT or other taxes. These are the applicable terminal dues rates for E format letter-post items, except for those flows where the E format rates have been self-declared in accordance with article 29 of the Convention (see sections II and III).

Other than the terminal dues rates applicable to E format letter-post items that have been self-declared pursuant to article 29, the provisional 2023 quality-linked terminal dues rates of P/G, E and undifferentiated format in Tables 1.1 to 1.4 in Annex 1 apply to the following mail flows:

Table 1.1 contains the provisional 2023 quality-linked terminal dues rates applicable to mail flows between DOs of member countries in the target system prior to 2010.

Table 1.2 contains the provisional 2023 quality-linked terminal dues rates applicable to mail flows between DOs of member countries in the target system as of 2010 and 2012, as well as between those operators and the DOs of member countries in the target system prior to 2010.

Table 1.3 contains the provisional 2023 quality-linked terminal dues rates applicable to mail flows between DOs of member countries in the target system as of 2016, as well as between those operators and the DOs of member countries in the target system prior to 2010, or as of 2010 and 2012.

Table 1.4 contains the provisional 2023 quality-linked terminal dues rates applicable to mail flows to, from and between DOs of transition system countries.

The terminal dues rates of P/G and E formats have been calculated by taking into consideration the domestic reference charges for 20-gramme small (P) and 175-gramme large (G) priority letter-post items as notified to the International Bureau (IB). The domestic reference charges are presented in Table 1 of Annex 2 for ease of reference and transparency.⁴

Other parameters used to calculate these rates are as follows:

- For P/G format, the base rates applied for 2023 were subject to the following minimum and maximum rates:
 - For mail flows between DOs in the target system prior to 2010, the maximum rates of 0.399 SDR per item and 3.114 SDR per kilogramme were applied (article 30.8.2 of the Convention);

- For mail flows between DOs in the target system as of 2010 and 2012 and between those DOs and DOs in the target system prior to 2010, the maximum rates of 0.372 SDR per item and 2.905 SDR per kilogramme were applied (article 30.12.2 of the Convention);
- For mail flows between DOs in the target system as of 2016 and between those DOs and DOs in the target system prior to 2010, or as from 2010 and 2012, the maximum rates of 0.351 SDR per item and 2.738 SDR per kilogramme were applied (article 30.13.2 of the Convention);
- For mail flows to, from and between DOs of transition system countries, the maximum rates of 0.329 SDR per item and 2.573 SDR per kilogramme were applied (article 31.5.2 of the Convention);
- For all mail flows, the minimum rates of 0.292 SDR per item and 2.280 SDR per kg were applied (articles 30.10.2 and 31.6.2 of the Convention);
- For E format, the base rates applied for 2023 were subject to the following minimum and maximum rates:
 - For all mail flows, the maximum rates of 0.950 SDR per item and 2.136 SDR per kilogramme were applied (articles 30.9.2 and 31.7.2 of the Convention);
 - For all mail flows, the minimum rates of 0.711 SDR per item and 1.599 SDR per kilogramme were applied (articles 30.11.6 and 31.8.2 of the Convention);
- Concerning mail flows between DOs from countries in the target system, the increases to the terminal dues rates for P/G and E format items were furthermore subject to a maximum annual revenue increase of 13% for a letter-post item in P/G format of 37.6 grammes and in E format of 375 grammes, compared to the revenues calculated at respectively the same weights for the year 2022 (article 30.7 of the Convention).
- The increases to the terminal dues rates for P/G format items sent to, from and between DOs from countries in the transitional system were subject to a maximum annual revenue increase of 15.5% for a letter-post item in P/G format of 37.6 grammes and 13% in E format of 375 grammes, compared to the revenues calculated at respectively the same weights for the year 2022 (article 31.3 of the Convention).

In accordance with article 31-107 of the Convention Regulations, for those DOs that did not communicate their domestic charges to the IB by 1 June 2022, the charges used for the calculation for the year 2022 were applied. Where no domestic charges were communicated in previous years, the rates provided for in articles 30.10.2 and 31.6.2 of the Convention will apply for P/G format, and those in articles 30.11.2 and 31.8 for E format.

Separate rates have been calculated only for those territories whose information is available to the IB through the consultation provided for in article 2 of the Convention concerning the existence of a distinct DO.

II. Provisional 2023 quality-linked terminal dues rates applicable to mail flows to DOs that self-declared their E format rates other than those flows to which paragraphs 7 and 9 of article 29 of the Convention apply

Article 29 of the Convention provides for the payment of self-declared terminal dues rates of E format letter-post items. In accordance with article 29.1, DOs could notify the IB by 1 June 2022 of a self-declared rate per item and per kilogramme that applies for the payment of terminal dues for E format letter-post items in 2023 for their inbound mail flows, except for:

- E format letter-post flows from countries in the transitional system to countries in the target system, and between countries in the transitional system, if mail flows do not exceed 100 tonnes per year (article 29.1.6 of the Convention). The rate of 6.729 SDR per kilogramme will apply instead (article 31.11.2 of the Convention);
- E format letter-post flows between countries in the target system as from 2010, 2012 and 2016, and from those countries to countries in the target system prior to 2010, if mail flows do not exceed 25 tonnes per year (article 29.1.7 of the Convention). The terminal dues rates in Tables 1.2 and 1.3 for undifferentiated format will apply instead.

For mail flows to DOs that self-declared their E format rates pursuant to article 29 of the Convention (other than those flows to which paragraphs 7 and 9 of article 29 apply), the provisional 2023 quality-linked terminal dues rates relevant to the direction and volume of the mail flow apply, as illustrated in the table below:

Tables 2.1 and 2.2 in Annex 1 provide the self-declared rates for E format letter-post items with effect from 1 January 2023 as notified to the IB in accordance with article 29 of the Convention, except to the extent that the self-declared rates in section III apply, i.e. self-declared rates applicable to mail flows under article 29.7 of the Convention, or reciprocally under article 29.9.

Table 2.1 contains the provisional 2023 quality-linked terminal dues rates for E format letter-post items of the 37 DOs that self-declared their E format rates by 1 June 2022 in accordance with article 29 of the Convention. The self-declared rates were converted into SDR values by the IB on the basis of the average monthly exchange rate of the period from 1 November 2021 to 31 March 2022. For each DO whose self-declared rates for E format letter-post items are provided in Table 2.1, the self-declared rates meet the following conditions of article 29 of the Convention:

- At the average weight of 0.158 kg for an E format letter-post item, the revenue calculated for such an item on the basis of the self-declared rates in local currency did not exceed either the revenue calculated at the country-specific ceiling rates (article 29.1.2 of the Convention), or the revenue calculated on the basis of the rates in article 29.1.3 of the Convention, whichever was higher;
- At the average weight of 0.158 kilogramme for an E format letter-post item, the revenue calculated for such an item on the basis of the self-declared rates did not exceed the respective revenue in 2022 for an E format item increased by 16% (article 29.2.3 of the Convention);
- The ratio between the self-declared item rate and kilogramme rate did not change by more than five percentage points upwards or downwards compared with the ratio of 2022 (article 29.3 of the Convention).

Table 2.2 contains the provisional 2023 quality-linked terminal dues rates for letter-post items of undifferentiated format (i.e. terminal dues rates applicable to unsampled mail flows or mail flows below the relevant sampling thresholds) of those DOs that self-declared their E format rates in accordance with article 29 of the Convention. In

accordance with articles 29.1.1.6 and 30.11 of the Convention, this table also provides for the total base rate of 6.729 SDR per kilogramme for mail flows from and between countries in the transitional system below 100 tonnes.

The self-declared rates notified in either local currency or SDR are provided in Table 3 in Annex 2. Table 3 also presents the country-specific ceiling rates determined by a linear regression of 11 points corresponding to 70% of the priority single-piece tariffs of equivalent domestic services for 20-gramme, 35-gramme, 75-gramme, 175-gramme, 250-gramme, 375-gramme, 500-gramme, 750-gramme, 1,000-gramme, 1,500-gramme and 2,000-gramme E format letter-post items, exclusive of any taxes and in effect on 1 June 2022 (article 29.1.2 of the Convention).

For the determination of the ceiling rates, the domestic single-piece tariffs of equivalent domestic services for E format letter-post items corresponding to the aforementioned weight points apply the conditions defined in article 29.1.2 of the Convention and are provided for ease of reference and transparency in Table 2 in Annex 2. The table also includes information on whether specific service features such as tracking, signature and insurance services are included in the domestic service for which tariff information is provided, as well as the corresponding domestic supplemental rate, if available.

In accordance with article 29.1.2.4, where the reference charges apply to domestic services that include the aforementioned service features across all 11 weight steps, the lesser amount of the corresponding domestic supplemental rate, the supplemental or the suggested guideline charge in the Acts of the Union has been deducted from the domestic tariffs prior to the determination of the country-specific ceiling rates. Where applicable, the total deduction for all additional features did not exceed 25% of the domestic tariffs.

III. Provisional 2023 quality-linked terminal dues rates applicable to mail flows to DOs that self-declared their E format rates where paragraphs 7 and 9 of article 29 of the Convention apply

Article 29.7 of the Convention states that, with effect from 1 July 2020, and notwithstanding paragraphs 1 and 2 of article 29, a DO of a member country that received total annual inbound letter-post volumes in 2018 in excess of 75,000 tonnes may self-declare rates for bulky (E) and small packet (E) letter-post items, other than for the letter-post flows referred to in paragraphs 1.1.6 and 1.1.7 of article 29, unless the sending DO of the latter flows decides to self-declare its E format rates on the basis of the provisions in article 29.9 of the Convention. On a reciprocal basis, the DOs applying the conditions in paragraphs 7 and 9 of article 29 have the right not to apply the maximum revenue increase limits set out in paragraph 2 of article 29 for mail flows to and from their country. These conditions are referred to below as the accelerated implementation clause.

Additionally, article 29.7 of the Convention states that, where a DO of a member country invokes paragraph 7, all other corresponding DOs may do likewise with respect to the aforementioned DO. The only exception concerns those flows referred to in paragraphs 1.1.6 and 1.1.7, where the sending DO has decided not to pay and receive self-declared E format rates on a reciprocal basis.

This accelerated implementation clause was invoked by the DO of the United States of America through a formal notification to the IB, given that it had received total annual inbound letter-post volumes in excess of 75,000 tonnes in 2018.

In accordance with Convention article 29.7, where a DO of a member country invokes paragraph 7, all other corresponding DOs, other than those with the flows referred to in paragraphs 1.1.6 and 1.1.7, may do likewise with respect to the aforementioned DO. The DOs with flows referred to in paragraphs 1.1.6 and 1.1.7 may apply self-declared E format rates on a reciprocal basis. Table 3.1 indicates those DOs that apply or waive the provisions in paragraphs 1.1.6 and 1.1.7.

Where E format rates were self-declared by 1 June 2022 with effect from 1 January 2023, including those pursuant to paragraphs 7 and 9 of article 29 of the Convention, the mail flows described in paragraphs 1.1.6 and 1.1.7 of article 29 will not be subject to the payment of those self-declared rates unless the sending DO of those flows referred to in paragraphs 1.1.6 and 1.1.7 decides otherwise.

- In principle, mail flows below 100 tonnes sent by countries in the transitional system will instead be subject to the payment of a base rate of 6.729 SDR per kilogramme (article 31.11 of the Convention) unless the sending DO decides to apply self-declared E format rates (consequently, the DO of the United States may do likewise and apply self-declared rates, including on the flows referred to in article 29.1.1.6 of the Convention);
- Mail flows below 25 tonnes sent by countries in the target system as from 2010, 2012 and 2016 will instead be subject to the payment of the terminal dues rates in Tables 1.2 and 1.3 for undifferentiated format unless the sending DO decides to apply self-declared E format rates and, consequently, the DO of the United States may do likewise and apply self-declared rates, including on the flows referred to in article 29.1.1.7 of the Convention;
- Where appropriate, the rates in Tables 3.1 and 2.2 will be replaced by those in Tables 1.1 (for mail flows from the United States to countries in group I), 1.2 (for mail flows from the United States to countries in Group II), 1.3 (for mail flows from the United States to countries in group III) or 1.4 (for mail flows from the United States to countries in group IV), in cases where the country of destination does not self-declare its E format rates.

Table 3.1 contains the provisional 2023 quality-linked terminal dues rates for E format letter-post items of the DOs that self-declared their E format rates by 1 June 2022 for flows to which paragraphs 7 and 9 of article 29 of the Convention apply. Where the self-declared rates were notified in local currency, the IB converted these rates into SDR values on the basis of the average monthly exchange rate of the period from 1 November 2021 to 31 March 2022. For each DO whose self-declared rates for E format are provided in Table 3.1, the self-declared rates meet the following conditions of article 29 of the Convention:

- At the average weight of 0.158 kilogramme for an E format letter-post item, the revenue calculated for such item on the basis of the self-declared rates in local currency did not exceed the higher figure of the revenue calculated at the country-specific ceiling rates (article 29.1.2 of the Convention) and the revenue calculated on the basis of the rates in article 29.1.3 of the Convention;
- The ratio between the self-declared item rate and kilogramme rate did not change by more than five percentage points upwards or downwards compared with the ratio of 2022 (article 29.3 of the Convention).⁹

The self-declared rates for these flows are not subject to the maximum annual increases in paragraph 2 of article 29.

Table 3.1 also contains the provisional 2023 quality-linked terminal dues rates for letter-post items of undifferentiated format (i.e. terminal dues rates applicable to unsampled mail flows or mail flows below the relevant sampling thresholds) of those DOs that self-declared their E format rates in cases where paragraphs 7 and 9 of article 29 of the Convention apply, except for those of the United States, which are provided in Table 3.2.

Table 3.2 contains the provisional 2023 quality-linked terminal dues rates for letter-post items of undifferentiated format (i.e. terminal dues rates applicable to unsampled mail flows or mail flows below the relevant sampling thresholds) of mail flows to the

rates on a reciprocal basis in accordance with article 29.9 of the Convention (including those whose outbound flows are optionally eligible for exemption under article 29.1.6). Table 3.1 provides a column which indicates whether a DO in group IV applies or waives the protection mechanism in article 29.1.6 of the Convention, i.e. whether it applies self-declared rates on a reciprocal basis with the DO of the United States in the event that the outbound volume to the United States does not exceed the 100 tonne threshold. Should a DO from group IV have indicated that the protection mechanism in article 29.1.6 applies, then the rates in Table 1.4 are applicable on the reverse flow, i.e. the flow from the United States to the country classified in group IV.

United States according to the different groups of the terminal dues classification system.

IV. Quality of service link to terminal dues (QS Link)

Quality-linked terminal dues are mandatory for all countries and territories, including those in the target system and the transitional system. However, “participation in the QS Link” implies that a country or territory has informed the IB that it has put in place a GMS-compliant measurement system that provides the performance results used in the calculations of the quality-linked terminal dues.

In Annex 1, the terminal dues base rates were adjusted according to quality of service by using the following information:

- Quality of service results for 2021, where available;
- Quality of service targets for 2023.

The principles of article 31-109 of the Convention Regulations were applied in the following way:

- As an incentive for the participation in the quality link, the DOs received an increase of 5% over the country-specific terminal dues base rates;
- For the purpose of the *provisional* quality-linked terminal dues rates, where the 2021 quality of service performance did not meet the quality of service targets, the terminal dues rates were subject to a penalty of one third of 1% of the terminal dues for each percentage point under the performance target;
- In no case did the penalty exceed 10% and, given the 5% incentive for participation, the maximum penalty did not lead to remuneration any lower than 95% of the terminal dues base rates;
- Where terminal dues rates were calculated in accordance with articles 30.5 and 31.2 of the Convention, the IB ensured that the provisional 2023 quality-linked terminal dues rates would not be any lower than the minimum rates defined in articles 30 and 31.

The terminal dues rates of countries joining the QS Link in 2023 have not been adjusted to their respective quality of service results owing to the unavailability of full-year validated quality of service results, meaning that their 2023 provisional rates are the same as their terminal dues base rates. Nonetheless, the final 2023 quality-linked terminal dues rates will be adjusted to reflect the quality of service results.¹⁰ These conditions apply to the DOs of the following countries and territories:

- Armenia (from 2023);
- Georgia (from 2023);
- Moldova (from 2023);
- Mauritius (from 2023);
- Senegal (from 2023);
- United Arab Emirates (from 2023).

Designated operators that do not put in place a GMS-compliant measurement system are considered as “not participating in the QS Link”; as such, they should receive base terminal dues but pay other countries and territories participating in the QS Link their quality-adjusted terminal dues rates, which may range from 100% to 105% of their base terminal dues rates, depending on their quality of service performance results.

Pursuant to article 31-109.4 of the Convention Regulations, the DOs of the following member countries and territories notified total annual inward mail volumes below 100 tonnes in the most recent year:

- Barbados;
- Bosnia and Herzegovina – Pošte Srpske Banja Luka;
- Bosnia and Herzegovina – Hrvatska pošta d.o.o. Mostar;
- Caribbean part of the Netherlands;
- Comoros;
- Cuba;
- Curaçao;
- Djibouti;
- Fiji;
- Jordan;

Note – calculation of terminal dues rates undifferentiated by format

For mail flows undifferentiated by format or below the thresholds set out in Convention, the per-kilogramme and per-item components are to be converted into a total rate per kilogramme on the basis of a worldwide average composition of one kilogramme of letter mail containing 9.42 items (source: 2018 IPK study), in which P and G format items account for 3.97 items weighing 0.14 kg and E format items account for 5.45 items weighing 0.86 kg (article 30.14 of the Convention).

Example 1 (based on the minimum rates per item and per kilogramme):

In 2023, the minimum rates per item and per kilogramme for small (P) and large (G) letter-post item rates are 0.292 SDR per item and 2.280 SDR per kilogramme, and for bulky (E) and small packet (E) letter-post items the minimum rates are 0.711 SDR per item and 1.599 SDR per kilogramme.

The total rate per kilogramme is calculated as follows:

(P/G format items in one kilogramme x rate per P/G format item) + (P/G format item weight in one kilogramme x rate per kilogramme of P/G format items) + (E format items in one kilogramme x rate per E format item) + (E format item weight in one kilogramme x rate per kilogramme of E format items):

$$(3.97 \times 0.292) + (0.14 \times 2.280) + (5.45 \times 0.711) + (0.86 \times 1.599) = 6.729 \text{ SDR per kilogramme}$$

When applying country-specific rates in cases where the rates per item and per kilogramme are above the minimum rates, the country-specific rates per item and per kilogramme should be used instead of those used in the example above.

Example 2 (based on different sets of E format rates):

In this example, a designated operator from group II self-declared its E format rates in accordance with article 29, including separate self-declared E format rates for mail flows referred to in paragraphs 7 and 9 of article 29. The table below shows examples of the calculation of the total rate per kilogramme for undifferentiated/unsampled mail flows *below the relevant thresholds* sent by a country in group II (flow below 25 tonnes subject to the payment of terminal dues of E format in accordance with articles 29.1.1.7 and 30 of the Convention), a country in group I (flow below 50 tonnes subject to the payment of self-declared E format rates in accordance with article 29 of the Convention) and the United States (flow below 50 tonnes subject to the payment of self-declared E format rates on the basis of paragraphs 7 and 9 of article 29).
