I refer to your request received on 3 February 2023, which has been considered under the Official Information Act 1982 (OIA), for the following information:

On 3/02/2023 you announced funding of a one-off \$3 million investment to support the Waitangi Treaty Grounds.

Under the OIA please provide the following:

All correspondence including but not limited to, emails, texts and records of phone calls relating to the funding, inclusive of when and who requested the funding, when the funding was approved and by whom.

Before responding to your request, it is important to provide context about how this funding came to be. As you will see from the attached material, the nationally significant Waitangi Treaty Grounds are located on the Waitangi Estate. The grounds are managed by the Waitangi National Trust Board under the provisions of the Waitangi National Trust Board Act 1932.

While the grounds are normally self-sufficient, COVID-19 posed a serious risk to the Trust's management of the grounds, and affected the Trust's operations. The Government provided operational funding to the Trust post-Budget 2020 to support the Trust to achieve financial sustainability. This year's one-off allocation to the management of the Waitangi Treaty Grounds came from reprioritised funding from unspent allocations supporting the cultural sector through COVID-19, as part of the Vote Arts. Culture and Heritage appropriation.
