*I also seek any information you might hold on whether PSC believes the preponderance of political comments by a Crown Entity board member may create an impression of political partisanship even if any one comment is excusable".*

### **Our Response**

At the time of your request, Te Kawa Mataaho Public Service Commission (Commission) did not hold any information regarding the application of the Code of Conduct for Mr Steve Maharey. Accordingly, I have refused your request under section 18(e) of the Official Information Act 1982 on the grounds that the information requested does not exist.

However, on 6 March 2023 the Minister for the Public Service requested the Public Service Commissioner's (Commissioner) advice on the appropriateness of Mr Maharey's opinion pieces and any other similar public commentary by him and asked what, if any, action might be taken.
