# Rates Remission and Postponement on Māori Freehold Land

A remission or postponement of all or part of the general and targeted rates (excluding those for water supply, sewerage disposal and refuse collection) may be granted on Maori Freehold Land that is being developed, or is inaccessible, unoccupied, unproductive and complies with the objectives of Schedule 11 of the Local Government Act 2002.

## Water by Meter

Properties with a metered water supply with an annual consumption exceeding 320 cubic metres will receive a separate invoice for the water consumed in excess of 320 cubic metres.
