Thank you for your email of 6 June 2023 to the Ministry of Business, Innovation and Employment (the Ministry) requesting, under the Official Information Act 1982 (the Act), information about the Immigration Advisers Authority (the IAA).

Responses to your questions are set out below.

1. How are the registration and renewal fees for immigration advisers determined?

The licensing application fees and levies are prescribed in the Immigration Advisers Licensing Regulations 2008, which can be found at: Immigration Advisers Licensing Regulations 2008 (SR 2008/82) (as at 11 June 2009) Contents – New Zealand Legislation.

2. In comparison to other professions that require registration, why does the IAA consider these fees to be reasonable?

As referred to in the response to question 1 above, fees and levies are prescribed in the Immigration Advisers Licensing Regulations 2008 and the IAA must charge the fees prescribed accordingly.

3. What were the registration and renewal fees received in the fiscal years 2020-2023 and where were these fees spent?

Financial statements related to the funding of the Immigration Advisers Authority are published within the Ministry's Annual Reports. Below are links to the annual reports:

Please note that the annual report for fiscal year 2022/2023 is not yet available, but it will be published online like the previous annual reports. Therefore, this part of your request is refused under section 18(d) of the Act, as the information will soon be publicly available.

4. What services are provided to immigration advisers regarding CPD learning other than webinars?

The Immigration Advisers Authority was set up to promote and protect the interests of people receiving New Zealand immigration advice and is the regulatory body for the industry. The IAA Continuing Professional Development (CPD) component is a mandatory component to ensure Licensed Immigration

Advisers meet the minimum standards of competence for licensing and entry to the scheme. Information about the role of the Immigration Advisers Authority can be found on the IAA website at: https://www.iaa.govt.nz/about-us/what-we-do/ and includes:

- issuing licences to people who are fit and competent to give immigration advice
- maintaining competency standards and a code of conduct for immigration advisers
- investigating people giving immigration advice without a licence or exemption
- receiving complaints from people who have received poor immigration advice.
