- a. An Entrepreneur Work Visa may be granted for a total period of up to 3 years, encompassing an Entrepreneur Start-Up stage and Entrepreneur Balance stage. Only one fee and one immigration levy will be charged for an Entrepreneur Work Visa.
- b. The Entrepreneur Start-Up stage is the first 12 months of the Entrepreneur Work Visa (though a business immigration specialist may extend the Entrepreneur Start-Up stage under <u>BB4.5.5</u>). During the Entrepreneur Start-Up stage, the holder of the Entrepreneur Work Visa is expected to establish and commence the operation of an agreed business in New Zealand.
- c. If the holder does not meet the requirements in BB4.5(a) during the Entrepreneur Start-Up stage, the visa expires at the end of the Entrepreneur Start-Up stage.
- d. If the holder does meet the requirements in BB4.5(a), the visa will be valid for the balance of the 3 year period. This is the Balance stage of the Entrepreneur Work Visa.
- e. A further Entrepreneur Work Visa (also known as a Renewal) may be granted beyond the 3 year period, if the conditions at BB4.10 are met, the application is approved by a business immigration specialist, and the prescribed fee is paid.

  - iii.other documents, evidence and information the business immigration specialist considers may demonstrate the transfer of investment capital to New Zealand through the banking system.
- b. Evidence of reasonable steps taken to establish and operate a business may include but is not limited to:
  - i.documents evidencing the constitution of the business (e.g. certificate of incorporation)
  - ii.audited accounts
  - iii.GST records
  - iv.other tax records
  - v.property purchase or lease documents relating to the business' site
  - vi.invoices for business equipment and supplies
  - vii.other documents, evidence and information a business immigration specialist considers may demonstrate reasonable steps taken to establish or invest in a business (e.g. employment agreements, bank statements, utility company invoices, sales agreements, contracts to provide products or services).

#### **BB4.5.5 Further Entrepreneur Start-Ups**

- a. A business immigration specialist may extend the Entrepreneur Start-Up stage, in cases where they are not satisfied that the requirements of BB4.5(a) have been met, but are satisfied that the holder may be able to meet these requirements within a spec fied time, to allow the holder to take further steps to establish and operate their business.

  - v. the principal applicant and any partner or dependent child/ren accompanying them have not drawn on the New Zealand welfare system (see BB2.1.5(c)); and
  - vi. the principal applicant and any partner or dependent child/ren accompanying them meet health and character requirements for residence (see A4 and A5); and
  - vii. the applicant continues to meet fit and proper person requirements set out at BM1.

Note: Applicants can only be granted one further Entrepreneur Work Visa beyond the initial 3 year work visa. If they still wish to run their business beyond the period of the further (or renewed) Entrepreneur Work Visa, they will need to make a new application under the Entrepreneur Work Visa instructions, or any other applicable category, in force when they apply. #### **BB6.1.15 Definition of self-employment**

- a. Self-employment is lawful full time active involvement in the management and operating of a business which the principal applicant has established or purchased, or in which the principal applicant has made a substantial investment.

- b. Applicants who have operated a business for six months must provide evidence:
  - i.of how their investment funds have been invested in their business and how this has benefited the business or increased its value; and
  - ii.that any jobs created meet the definition of full time employment at <u>BB6.1.25</u>, as shown by employment contracts, wage and salary records, or evidence of business turnover.
  - iii.If they have not done so previously, the principal applicant must provide evidence the investment capital, as stated in the business plan, has been transferred directly from the holder's bank account(s) through the banking system to New Zealand.

#### BH2.5 Compliance with emp oyment and immigration law

- a. Businesses established in New Zealand must comply with all relevant employment and immigration law in force in New Zealand. Compliance with relevant New Zealand employment and immigration law includes but is not limited to:







The land designated 244 Georges Road, comprises 19.4600 ha, and has a narrow strip of land running along the side of the 246 Georges Road parcel (9.28 ha) for legal access. # IRRIGATION



Gallery Reservoir

Water for irrigation is sourced from a gallery located on the lower terrace adjacent to the Waipara River. Water from this source is pumped and stored in a 20,000m3 reservoir. From here water is able to be utilised for irrigation and frost fighting purposes. All vines are dripper irrigated.

Water is drawn from the gallery under two current Resources consents (CRC 145925 and CRC145964). Water is able to be extracted at a rate not exceeding 12.5 litres/second, or 1080m3 per day, between 1 June and 30 September each year, utillising both resource consents. Water is able to be extracted at a rate of 2.99 litres/second, not exceeding 258m3 per day between 1 October and 31 May each year, utillising both resource consents. Total annual annual water take must not exceed 194,940m3 between 1 July and 30 June.

# DOMESTIC AND GENERAL WATER

Water for domestic and general use is sourced from the Hurunui Rural water supply scheme. There is a 4,500 litre storage tank.

Your work visa is multiple entry so that if you leave New Zealand, you will be able to return during the period to work on a self-employed basis in the same business.

#### Further visa

We will consider issuing you a further work visa for the "balance of 3 year period" on receiving evidence to show that you have transferred your investment capital for the proposed business to New Zealand, and taken steps to establish your venture. The policy requirements are outlined in the Appendix.

#### Notes:

1) You will need to show that your investment capital for the proposed business, as stated in the business plan, has been transferred direct from your own bank account(s) through the banking system to New Zealand. Other methods of transferring the funds to New Zealand are unacceptable.



- 2) Examples of the appropriate types of evidence to show the bank funds transfer are provided in the Appendix.
- 3) You will need to show reasonable steps have been taken to establish or invest in the business as set out in the business plan. Examples of the appropriate types of evidence are in the Appendix.
- 4) A benefit proposed is to create employment. In terms of the criteria given in the instructions for the Entrepreneur Work and Residence categories, a business may be considered to benefit New Zealand if it promotes New Zealand's economic growth through creating employment for New Zealand citizen/s or resident/s. Please note that, for the purposes of the instructions, the employment of non-New Zealand citizens or residents will not be accepted as an example of a business benefiting New Zealand.
- 5) Businesses established in New Zealand must comply with all relevant employment and immigration law. This includes:
- 1. paying employees no less than the appropriate minimum wage or other contracted industry standard, and
- 2. meeting holiday and special leave requirements and other statutory criteria, e.g. health and safety obligations, and
- 3. employing people who have the authority to work under the Immigration Act 2009.

#### **BB2.1 Entrepreneur Work Visas**

- The Entrepreneur Work Visa is a category of temporary entry class visa with conditions that allow selfemployment in New Zealand.
- 2. Applicants for an Entrepreneur Work Visa may be approved, if they meet the following conditions:
  - a minimum capital investment of NZ\$100,000, excluding working capital (as defined in BH6.1.50), unless this requirement is waived under BB3.5.1(b); and
  - 2. meeting or exceeding the pass mark (as set out in BB3.10) on a scale which awards points for factors relating to the likely success of the proposed business and its value to New Zealand.
- Applicants and any partner or dependent child/ren accompanying them must meet health and character requirements for residence as set out at <u>A4</u> and <u>A5</u>.
- Applicants and any partner or dependent child/ren accompanying them must also meet all requirements under Generic Temporary Entry Instructions.

#### **BB2.1.1 Currency of Entrepreneur Work Visas**

- An Entrepreneur Work Visa may be granted for a total period of up to 3 years, encompassing an Entrepreneur Start-Up stage and Entrepreneur Balance stage.
- 2. The Entrepreneur Start-Up stage is the first 12 months of the Entrepreneur Work Visa (though a business immigration specialist may extend the Entrepreneur Start-Up stage under BB4.5.5). During the Entrepreneur Start-Up stage, the holder of the Entrepreneur Work Visa is expected to establish and commence the operation of an agreed business in New Zealand.
- 3. If the holder does not meet the requirements in BB4.5(a) during the Entrepreneur Start-Up stage, the visa expires at the end of the Entrepreneur Start-Up stage.
- 4. If the holder does meet the requirements in BB4.5(a), the visa will be valid for the balance of the 3 year period. This is the Balance stage of the Entrepreneur Work Visa.
- A further Entrepreneur Work Visa (also known as a Renewal) may be granted beyond the 3 year period, if the conditions at BB4.10 are met, the application is approved by a business immigration specialist, and the prescribed fee and immigration levy is paid.

#### BB2.1.5 Conditions of Entrepreneur Work Visas

- The conditions specified on an Entrepreneur Work Visa will include the following conditions relating to work:
  - 1. As: Self-employed
  - 2. For: (Business type and trading name of business)
  - 3. At: (Location of business)
- 2. The travel conditions on the visa will give permission to travel to New Zealand for multiple journeys.
- 3. Entrepreneur Work Visas and any other temporary visas granted to the holder of an Entrepreneur Work Visa's partner or dependent child/ren are subject to the condition that the holder must not apply for and be granted welfare assistance under the Social Security Act 1964 while in New Zealand during the currency of their Entrepreneur Work Visas or any visa gained through their relationship with a holder of an Entrepreneur Work Visa.

#### **BB4 Stages of Entrepreneur Work Visas**

#### BB4.1 During the Entrepreneur Start-Up stage

If an application for an Entrepreneur Work Visa has been approved, holders of Entrepreneur Work Visas must establish and commence their proposed business in New Zealand during the first 12 months (the Entrepreneur Start-Up stage).

#### BB4.5 Requirements at the end of the Entrepreneur Start-Up stage

- 1. Towards the end of the Entrepreneur Start-Up stage, the holder must provide evidence sufficient to satisfy a business immigration specialist that:
  - the investment capital for the proposed business, as stated in the business plan, has been transferred directly from the holder's bank account(s) through the banking system to New Zealand; and
  - 2. reasonable steps have been taken to establish or invest in the business as set out in the business plan.

#### BB4.5.1 Evidence of reasonable steps taken to establish and operate a business

- 1. Evidence of transferring investment capital to New Zealand through the banking system may include but is not limited to:
- 1. telegraphic transfer forms
- other documents, evidence and information the business immigration specialist considers may demonstrate the transfer of investment capital to New Zealand through the banking system.
- 3. Evidence of reasonable steps taken to establish and operate a business may include but is not limited to:
  - 1. documents evidencing the constitution of the business (e.g. certificate of incorporation)
  - 2. audited accounts
  - 3. GST records
  - 4. other tax records
  - 5. property purchase or lease documents relating to the business' site
  - 6. Invoices for business equipment and supplies

I note the earlier application wasn't in fact approved as an "exception" but rather in terms of the specific instruction at BB4.5.5a. So we're now at the stage set out at BB4.5.5b. i.e. the "expiry of that second period" is the deadline of 07 Feb 2019.

Our records show that in this case PA originally claimed 50 qualifying points based on his proposed capital investment of \$500,000+; and s6(c)

#### Untested Developer Picked Wrong Time, Wrong Place and Wrong Neighbors

Standing beside one of the two waterfalls he had built into his duplex condominium on West 15th Street in Manhattan, Colin Rath smiled. The waterfalls feed a narrow koi pond that runs the length of the living room and was scooped out in the shape of a scale replica of the Yangtze River in China.

"It's so peaceful in here," he said.

What he wanted to do next door, however, is another story, one Mr. Rath, 52, has now told in a self-published book. Whether it was a case of tremendous misfortune or terrible miscalculation is hard to say. What the episode does reveal is the remarkable excesses that prevailed a decade ago, and perhaps again today, across New York City.

"We went to hell and back I don't know how many times," Mr. Rath said, reflecting on the two decades he spent on the block in the Chelsea neighborhood, half of them trying to build his "green dream," an eight-story boutique condominium building.

Meant to be ahead of its time, employing every luxury and technology imaginable, the project instead pulled its creator in over his head. In 2010, he walked away with nothing but 27 debtors clamoring for absent millions, and friends and relatives who had soured on the enterprise.

Mr. Rath and his wife, Pamela Harvey-Rath, were outsiders in the cutthroat world of New York development: He had helped run his father's direct-mail business in Stamford, Conn.; she was a gallerist and former model who had once posed with Fabio Lanzoni for the covers of romance novels.

After their success building their quixotic condo at 121 West 15th Street, with its curved ceilings and comic-art wallpaper, they were ready to give it all up and sail around the world. Instead, they decided to buy the single-room occupancy building next door. In 2003, they bought 123 West 15th Street for \$1.6 million so they could gut it, connect it to their home, build and sell condos above, and eventually use the rental income from their double-wide unit to fund their journey.

The book, titled "It Is What It Is," recounts not only the people Mr. Rath believes wronged him, but also the wrongs he committed; it is candid, confident and, at times, condescending.

From the outset, the Raths encountered problems. There were nine S.R.O. tenants in place, most all of whom required buyouts that totaled \$525,000. With the building finally emptied in 2006, demolition began.

The designs for the building called for geothermal wells and a rotating garage platform for three cars — Mr. Rath was frustrated by having to leave his Porsche on the street.

The most striking or startling, feature proposed was graved three control to an alien pod. Objections spread from the block to the community board and even to Christine C. Quinn, who was then speaker of the City Council and represented the neighborhood. Their complaints led to multiple rounds of city reviews, and eventually a reduction in the building's height to seven stories.

The Raths struggled to find financing for the project, even during the years of profligate real estate investing, and had to turn to a lender on Long Island that offered an interest rate of 13 percent, roughly \$5,000 per day.

When he began excavating the foundation, the jittery neighbors at 125 West 15th Street came by, requesting \$20,000 to pay an architect and engineer to look over the work for them. Mr. Rath described it in the book as a shakedown. (The neighbors declined to comment.)

Yet the neighbors may have had the right idea.

On a rainy day in November 2006, a construction crew was working beneath the foundation, built in 1853, when a portion of it collapsed, nearly crushing a worker, who suffered a broken leg.

Mr. Rath learned that the new pilings meant to hold up the old foundation and the planned penthouse had not been set deep enough, and he had to spend an additional \$3 million redesigning and rebuilding everything.

He got no further than erecting the steel frame before Lehman Brothers imploded, dragging down the project, along with so many others, as the credit market dried up.

In the book, Mr. Rath spends a good deal of time accusing various contractors and creditors of fraud while questioning the mental states of certain neighbors who attacked the project. Robert Boddington, head of the block association, was "seriously unbalanced" and "diagnosable," and is accused of screaming at Mr. Rath's children.

"His book," Mr. Boddington said last week in an interview, "appears to be built on lies, just like his buildings."

Mr. Rath said he was unconcerned about charges of libel, having taken out media insurance. "Besides," he said, "you can't be sued over the truth."

He spent the next two years fending off one creditor after another, hoping to find a way to salvage his project. He eventually surrendered the property to the lender in 2009. Within a year, a six-story rental building was completed, looking very much like a traditional limestone townhouse, one that Mr. Rath found "uninspired."

"If you look around, all the work we were doing, in sustainability, cantilevered construction, everything we were ridiculed for, it's everywhere now," Mr. Rath said.

Ultimately, Mr. Rath lost millions, a good deal of which was borrowed from his father. He is hoping the sale of his condo, which is now on the market for \$3.1 million — down from an initial \$4.1 million — could help cover some debts.

He did manage to baye one stroke of very good luck: The Xen rillion mortgage he had taken out on his waterfall-adorned condo to help finance the adjacent development was erased in court.

The lender, Bank of America, had tried to foreclose after Mr. Rath stopped paying, but amid the craziness of the mortgage meltdown, it could not prove it was entitled to the property. Despite the bank's pleas that Mr. Rath was seeking a "windfall," a judge nullified the debt last year.

Mr. Rath has been renting out the condo for \$10,000 a month since moving his family in 2010 to Connecticut, where they have taken up sailing full time. After spending this past winter in the Caribbean, the family is planning to sail to Europe this summer on a 55-foot Hanse 545 racing cruiser, before circumnavigating the globe.

The yacht is named Persevere, a reminder of all that came before.

"We're thinking of settling in New Zealand," he said. "This is not the America I knew."





#### BB3.5.10 Recognition of capital investment

Capital investment includes all nominated funds used in the establishment and operation of the approved business, except those used for:

- a. passive or speculative investment(s), such as reserve funds or term deposits; or
- b. the purchase of items for the personal use of the applicant(s), such as personal residences, cars or boats; or
- c. remuneration paid to the applicant(s) or their immediate family; or
- d. investment in residential property, except where the development of residential property meets the requirements of BB6.1.50 and formed part of an applicant's business plan.

#### BB4.5 Requirements at the end of the Entrepreneur Start-Up stage

- a. Towards the end of the Entrepreneur Start-Up stage, the holder must provide evidence to satisfy a business immigration specialist that:
  - the investment capital for the proposed business, as stated in the business plan, has been transferred directly from the holder's bank account(s) through the banking system to New Zealand; and
  - ii. reasonable steps have been taken to establish or invest in the business as set out in the business plan.
- b. A business immigration specialist must also be satisfied the applicant continues to meet the fit and proper person requirements set out at <u>BM1</u>.

#### BB4.5.5 Further Entrepreneur Start-Ups

- a. c. Further Entrepreneur Start-Ups will not extend the maximum length of the Entrepreneur Work Visa, which will still be for a period of up to 3 years (that is, the maximum duration remains up to 3 years from the date the Entrepreneur Work Visa was granted).
