Your request for Official information, reference: HNZ00024747

Thank you for your email on 5 July 2023, asking for the following under the Official Information Act 1982 (the Act). Please find our response to each part of your request below.

"During an interview on News Hub published on the 3rd of June 2023, you stated "Since the Government came into power in 2017, a new graduate nurse's starting salary has gone up by 40.7 percent. A salary for registered nurses at the top of their scale has risen by 49.2 percent when you add together the pay equity increases and collective bargaining increases, according to Dr Verrall." (NewsHub, 2023)

Could you please provide the following information to prove the validity of your claims below:

- 1) since Labour came into government in 2017 a new graduate nurse's salary has gone up by 40.7%.
- a) Please supply the following information
- i) New Graduate Registered Nurses' MECA hourly rate and annual salary as of Oct 2017."

As of Oct 2017, New Graduate Registered Nurses' MECA hourly rate was \$23.70 and annual salary was \$49,449.

"ii) Current New Graduate Registered Nurses' MECA hourly rate and annual salary as of 3rd July 2023 (current paid rates, Not proposed)."

The current annual salary from Mar-22 is \$66,570 and the hourly rate is \$31,90.

Proposed pay equity salary (backdated to Mar-22) is \$69,566 and the hourly rate is \$33.35

"iii) Supply the percentage increase between the 2017 MECA rates and current paid rates."

On current rates the percentage increase is 35%. On proposed pay equity rates the increase is 40.7%.

"2) What is implied as a RN at the top of their scale"

In 2017 there were 5 steps in the Registered Nurse pay scale. In 2018 two additional steps were introduced to create greater earning potential for Registered Nurses. There are currently 7 steps in the Registered Nurse scale.

"a) Please supply the following information

(i) MECA Pay rate for a Registered Nurse "at the top of their scale" in Oct 2017 - (hourly and annual for 1FTE)."

The annual salary in Oct 2017 was \$66,755 and the hourly rate was \$32.00.

"(ii) State what pay step you are describing in 2.a.i and what the 2023 equivalent step is (example - if stating step 5 is top of scale in 2017, step five is the same pay bracket for years' experience in 2023)."

Top step in 2017 was step 5 - \$66,755 annual salary. Step 5 in 2023 current pay rates - \$89,868. Step 5 in 2023 proposed pay rates - \$93,912.

"iii) Registered Nurses' current pay rate in 2023 at the step described in the quote above (the step equivalent to the top step in 2017 e.g. same years' experience)."

Top step in 2017 was step 5 - \$66,755 annual salary. Step 5 in 2023 current pay rates - \$89,868. Step 5 in 2023 proposed pay rates - \$93,912.

"iv) The percentage increased between the 2017 top rate (as described above) and it's 2023 equivalent step (same years' experience for step)."

Current pay rates (step 5) - 35%. Proposed pay equity rates (step 5) – 40.7%.

"3) Please supply further information regarding
