# Determining English language requirements

<b>Logical</b>	link between evidence & instructions	<b>Evidence</b>	To support your statement
<b>Complete</b>	All instructions & alerts assessed.	<b>Comment</b>	Concluding statement

<b>Well written</b>	Structured and Concise	<b>Statement</b>	State area of concern and / or instruction

# Assessing applications

- Review data in AMS as you would for an approval application.
- Open the WHS Portal - <http://workingholidays/>

IF:

- No health/character issues declared but information needs to be requested due to issues identified in the AMS checks; or
- Health or character issues are declared and further information is required to make a full assessment

Then:

- Determine if a formal PPI is required or an email requesting information is appropriate.
- Review E7.15 Potentially prejudicial information.




# Straight to Residence visa pathway


