



Resource Consent

Pursuant to the Resource Management Act 1991, the Northland Regional Council (hereinafter called "the Council") does hereby grant a Resource Consent to:

FAR NORTH HOLDINGS LIMITED, PO BOX 7, OPUA 0241

To occupy and use space in the coastal marine area with a jetty and pontoon facility at the Kororipo-Kerikeri Basin, Kerikeri, at or about location coordinates 1687661E 6102356N.

- 1 This consent applies only to the jetty and pontoon facility identified on NRC Plan No. **4301A attached**.
- 2 The Consent Holder shall mark the pontoon facility with the number **5770** in black lettering on a white background clearly displayed and in such a manner as to be clearly visible from land and sea.
- 3 The Consent Holder shall keep the coastal marine area free of debris resulting from the Consent Holder's activities.
- 4 The Consent Holder shall maintain the structure covered by this consent in good order and repair, including, but not limited to the paint coatings and surface matting.
- 5 The Consent Holder shall ensure that no activity, boat maintenance related or otherwise, that could involve contaminants entering the coastal marine area, is undertaken on or directly adjacent to the facility.
- 6 No vessel shall berth alongside the pontoon for more than 30 minutes. Signage shall be erected on the pontoon clearly stating, "Maximum berthing 30 minutes".
- 7 The vertical surfaces of the pontoon, the white painted kerbing and hand railing to the jetty and the aluminium surfaces of the gangway between the jetty and the pontoon shall be colour matched to Slate Brown HC 40 09 Resene Heritage Colours from the early colonial range of colours 1840-1870 and a non-slip matting of the same colour range shall be placed to cover the entire upper horizontal surface (deck) of the pontoon.

Advice Note: *The above colour scheme is intended to provide a linkage with the modern bridge and to not introduce a new colour palette into the Kerikeri Heritage Basin.*

8 The Consent Holder shall, for the purposes of adequately monitoring the consent as required under Section 35 of the Act, on becoming aware of any contaminant associated with the Consent Holder's operations escaping otherwise than in conformity with this consent:

- (a) Immediately take such action, or execute such work as may be necessary, to stop and/or contain such escape; and
- (b) Immediately notify the Council by telephone of an escape of contaminant; and
- (c) Take all reasonable steps to remedy or mitigate any adverse effects on the environment resulting from the escape; and
- (d) Report to the Council's Monitoring Manager in writing within one week on the cause of the escape of the contaminant and the steps taken or being taken to effectively control or prevent such escape.

With regard to telephone notification, during Council opening hours the Council's assigned monitoring officer for these consents shall be contacted. If that person cannot be spoken to directly, or it is outside of Council opening hours, then the Environmental Hotline shall be contacted.

Advice Note: *The Environmental Hotline is a 24 hour, 7 day a week, service that is free to call on 0800 504 639.*

9 The Council may, in accordance with Section 128 of the Resource Management Act 1991, serve notice on the Consent Holder of its intention to review the conditions annually during the month of August for the following purpose:

- (a) To deal with any adverse effects on the environment that may arise from the exercise of the consent and which it is appropriate to deal with at a later stage.

The Consent Holder shall meet all reasonable costs of any such review.

Advice Note: *The Council may, in accordance with Section 128 of the Resource Management Act 1991, serve notice on the Consent Holder of its intention to review the conditions any time for the following purposes:*

- (i) *To provide for compliance with rules relating to minimum standards of water quality in any regional plan that has been made operative since the commencement of the consent; or*
- (ii) *To provide for compliance with any relevant national environmental standards that have been made; or*
- (iii) *Where there are inaccuracies in the information made available with the application that materially influenced the decision on the application and where the effects of the exercise of consent are such that it is necessary to apply more appropriate conditions.*

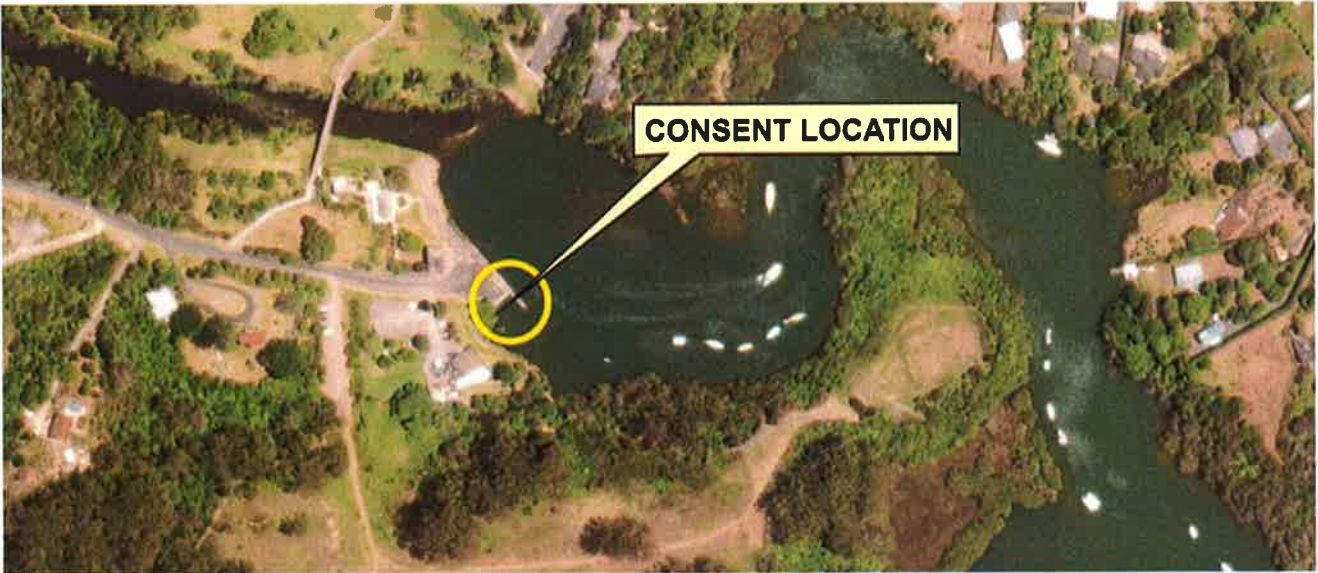
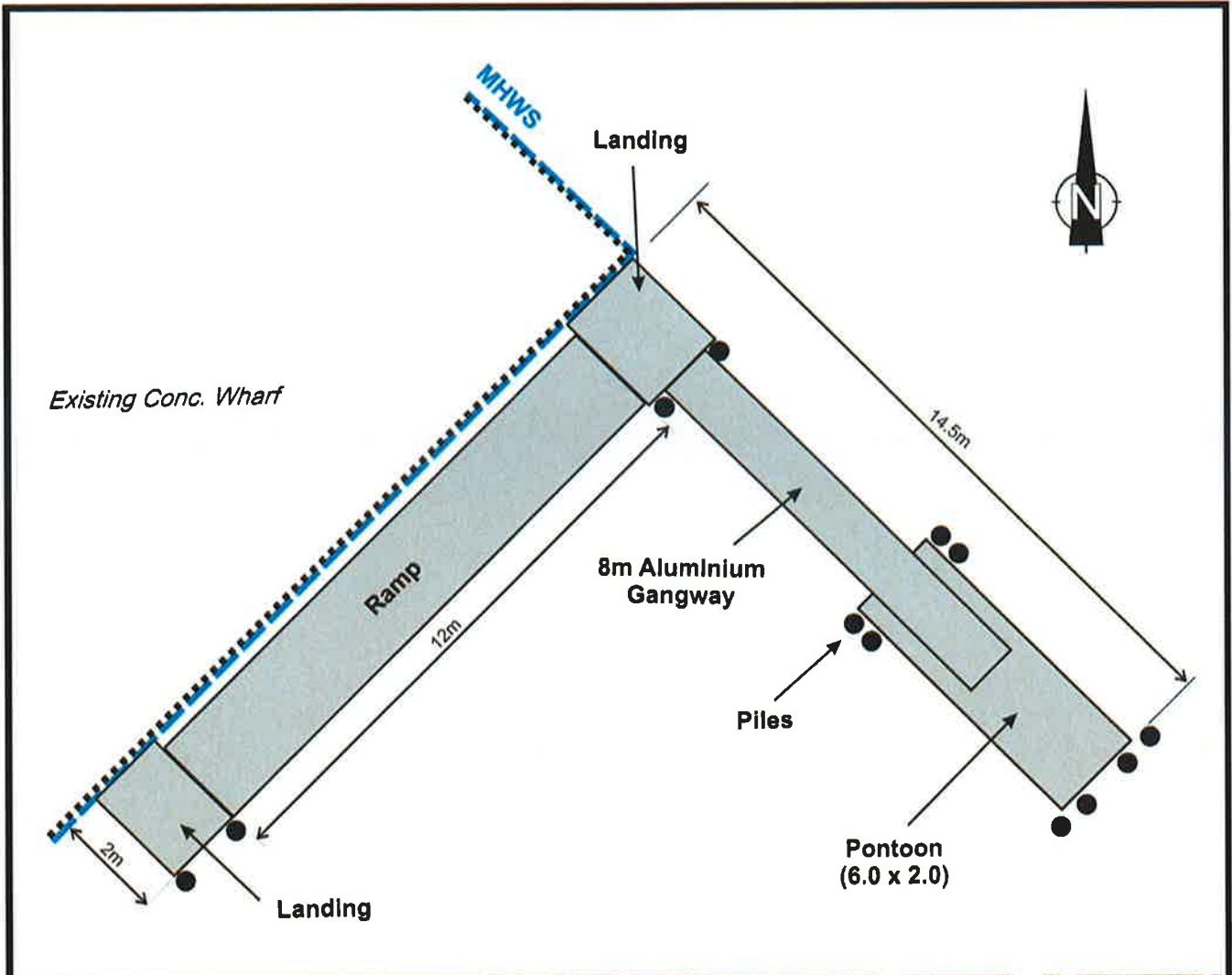
- 10 Prior to the expiry or cancellation of this consent the Consent Holder shall remove all structures and other materials and refuse associated with this consent from the consent area and shall restore the consent area to the satisfaction of the Council, unless an application for a replacement consent has been properly made beforehand.
