## Request made under the Official Information Act 1982

Thank you for your email of 20 December 2012 requesting the following information under the Official Information Act 1982:

- 1) The names of everyone or every company who has "streamlined" access to the motor vehicle register and can access information on people who have advised the registrar that they do not want their name and address disclosed
- 2) How many times each user has accessed the register
- 3) What data may be disclosed i.e. name, address date of birth, etc
- 4) For each streamlined customer a copy of their application and your notes/emails/meeting minutes etc that show why the decision was made and justifies the decision that their request always outweighs the rights of the individual

To provide background to your request, historically the Motor Vehicle Register (MVR) was a public register and the NZ Transport Agency (NZTA) was obliged to release the name and address of a registered person whenever these details were applied for. This meant that there was no visibility as to why information was being released and how that information was being used. This concerned the NZTA and many members of the public. Subsequently, on 1 May 2011, the Land Transport Act 1998 (LTA) was amended to significantly restrict access to information of registered or previously registered persons.

The LTA (under section 237) now permits the release of information in relation to a specified motor vehicle if:

- the person requesting the information is the person to whom the information relates;
- the disclosure of the information is required for one of the purposes of the MVR:
  - enforcement of the law;
  - maintenance of the security of New Zealand;
  - collection of charges imposed or authorised by an enactment; and
  - administration and development of transport law and policy;
- the information is disclosed according to an authorisation given under section 241 of the LTA; or
- the information may be disclosed under an enactment.

Any person may request information about a registered or previously registered person under section 236 of the LTA, but the Registrar is only permitted to release that information if the information request falls within one of the categories described above.

## NZTA's streamlined application process

The NZTA's streamlined application process was established by the NZTA to facilitate applications for MVR information by certain organisations that make a high number of applications falling under the Official Information Act 1982 (OIA). Rather than requiring these organisations to repeatedly make individual applications for information based on the same grounds, the streamlined process enables the NZTA to consider the organisation's grounds for access to the information up front. Once the NZTA has determined that the information may be released under the OIA on the basis that the public interest in disclosure outweighs the individual's right to privacy, the organisation will be given streamlined access to information falling within the scope of the approved application on an ongoing basis.

In response to your first request, please see attachment one.

In response to your second request, please see attachment two which provides the requested information since 1 May 2011 as you have not specified a date period.

In response to your third request, the type of personal information that may be disclosed according to an approved streamlined application includes the name and address about a person registered or previously registered in respect of a motor vehicle. **Please note:** There are a number of subscribers to the NZ Transport Agency online service, Motochek, who use an interface to their own websites. These are CarJam, Motorweb, Motor Trade Finance, Veda Advantage and Lemon Check.

Applications for access to registered person information must be made by the individual/company who is going to request the information. These companies have then chosen to retrieve the information through one of the interfaces. I have colour coded which applicants use the interfaces:

CarJam = applicants highlighted in purple
Lemon Check = applicants highlighted in orange
Motorweb = applicants highlighted in yellow
Motor Trade Finance = applicants highlighted in green
Veda Advantage = applicants highlighted in blue

In attachment 2 we have supplied the total number of queries for registered person details that have been made through these interfaces. You will see that the approved applicant does not appear, rather the interface user (e.g. Motorweb) as this is who is retrieving the information.
