Our goal is to bring together Heads of State and Government, as well as leaders from the tech industry and the Call's civil society Advisory Network for a plenary session to determine our next steps and strengthen our collective efforts in tackling the abuse of the Internet by terrorists and violent extremists.

A save-the-date will be sent out shortly – followed by a formal invitation from our respective leaders.

In the spirit of the multi-stakeholder approach of the Call, New Zealand and France intend to convene a series of high level discussions in the lead up to the virtual Summit on key areas of thematic focus. The outcomes of these discussions will be reported back to leaders during the plenary session.

Attached to this email you will find a **first draft concept note** which provides additional details on our ambitions for the Summit and areas we believe need additional focus in the future. I hope that you are doing well amidst it all. My reason for writing is a big one, and I hope of direct interest to you and New Zealand colleagues. It relates to the planning for a commemorative event related to 22 July in Norway at the end of August 2021; please find the attached the draft Concept Note here. With respect to place, we envision a hybrid event at the University of Bergen (for some colleagues able to travel there), which will also ensure event security – including digitally. 9(2)(a) and would hope to be able to be there in person. We're awaiting final confirmation on the location in Norway, but many key participants have all informally said yes. Likewise, I'm proud to report that the event planning is being led by Norwegian pals 9(2)(a), a Fellow at CARR, and 9(2)(a) who of course you know via the 9(2)(a) I take the liberty of copying both of them in here).

I should note that we're still at the discussion stage, so you and colleagues' feedback would be invaluable. Above all, we are confident that this can be a major event to push forward the aims of the Christchurch Call, including some kind of statement of commitment from GIFCT, EUIF, and the big tech firms (Facebook and Google have confirmed, and we're waiting on word from UNCTED). By all means please do share with key stakeholders, although we're still not ready just yet to announce things publicly. But above all I hope very much that you can take part, and trust that you think the plan looks alright thus far. A 3-day event to be held at UiB's International Centre, Bergen, Norway

25 - 27 August 2021

The heart-breaking attacks in Oslo and Utøya shocked the world and took the lives of 77 Norwegians, mostly children. They were killed because of a transnational radical right ideology, which was digitally disseminated on the day of the murder by the self-directed terrorist. Norway's darkest day destroyed lives and communities. It also raised searching questions about online radicalisation – and even 'broadband terrorism' - and the destructive power of a lone actor motivated by right-wing extremism.

How can we support those who are still marked by this cowardly act? What lessons have been learned in the ten years since? And what can we do better in order to stop extremist radicalisation and terrorist content, especially online? Drawing upon the pivotal 'Christchurch call', issued in the wake of a more recent lone actor attack killing 51 innocents, this landmark 3-day event will address these questions, while looking to the future for robust, dynamic and workable solutions.

Hosted at the University of Bergen and led by Norwegian scholars and survivors, this 3-day event also features key global stakeholders in the fight against terrorism and radical right extremism.

- Like you we are all too familiar with the feeling of shock, grief, and loss

- A livestream designed to maximise exposure, to revictimize families, and to spread a message detailed in a manifesto citing Utoya as an inspiration
- The immense online impact of the Christchurch attack was like nothing we'd seen before,

- The outpouring of solidarity across New Zealand, and from our friends around the world was something we took as inspiration
- Like Norway we were looking for a way to respond to an unprecedented situation drawing on the values that we hold dear – our manaakitanga (or solidarity and generosity of spirit)
- The Christchurch Call first arose from conversations with partners in Norway, and elsewhere on how to use the moral imperative we felt from these events to achieve lasting positive change
- It drew from our commitment to protect and uphold human rights, and to preserve a free, open, and secure internet as a force for good
- It also drew on an understanding that lasting and meaningful change would require Governments and Tech Companies to work hand in hand with civil society
- Over the past two years, the Christchurch Call has created a community dedicated to

making progress against violent extremist and terrorist content online

- That community includes Norway, and 9(2)(a) and 9(2)(a) and so many others in the room with us today
- It has made important progress
- A Global Internet Forum to Counter Terrorism as a restructured entity with dedicated resources and an independent staff
- Better policies and approaches to extremist content, and
- dedicated systems for responding to viral content in the wake of an attack
- Earlier this year we laid out an ambitious programme of work for the future
 - To grow our community, to speak with a more diverse range of communities and user groups. Just as the internet is a technology that connects the whole of society, violent extremism is a problem that impacts on all of us – marginalised groups most of all so hearing their voices and involving them in solutions is absolutely crucial.
 - To engage our community and make the most of their expertise to help further our goals. Governments cannot and should not come up with solutions to issues on the internet by themselves. A multistakeholder approach is crucial – but of course it's not enough just to get everyone in a room. We have to find ways to meaningfully engage and create space for people to contribute
 - To better understand the role that the online environment plays in radicalisation, so that we can more effectively disrupt and intervene. With a growing number of attacks stemming from people who have found their ideological foundations in the online space, we need to better understand what the crucial factors are, and what – if any – role the user interface and the algorithms that recommend content can play in helping us to prevent that.
 - To improve our crisis preparedness – we've put some important systems into place to help manage the impact of viral content following a major incident. As the toolkit of terrorists violent extremists change we need to ensure we're staying ahead of those changes and that our response is timely and minimises harm while respecting important human rights and due process protections.
 - To improve transparency from Governments as well as online Service Providers about how we do all of that;
- More effective action and resourcing will be key to achieving these goals, and it's heartening to hear the commitment and determination from those who have spoken today
- As more and more of the world we live in is digitised, we will have an ongoing task in finding ways to uphold our values and principles – to create environments where manaakitanga can triumph
- I am very confident that this community can provide some of the answers;
- Thanks again to the organisers, we look forward to contributing to a successful conference

The Bergen Plan of Action

August 27, 2021

Introduction

Terrorism is a human problem, costing human lives, tearing real families apart. This year marks the tenth anniversary of the horrific attack on Norway on the 22nd of July 2011. The terrorist claimed 77 lives. Ten years later we are barely starting to understand the scope of the long term impact of this attack on the survivors, bereaved families and society as a whole.

It is with the lives impacted on the 22/7 2011, and all the lives around the globe that have been impacted by terrorism in mind, we come together now to stake out the future and renew our commitment to our joint global efforts to combat terrorism in all its forms.

The recommended actions outlined in this document are the outcome of the conference “22 July at Ten: Commemoration and Commitment” hosted at the University of Bergen and organized in collaboration with the Centre for Analysis of the Radical Right and the Khalifa Ihler Institute who in collaboration with conference participants and the wider global community of stakeholders will seek to implement the recommended actions.

The objective of this plan of action is not to replace, but to build upon, embed and enact decades worth of collaborative work, of the establishment of global networks, collaborative institutions and policies striving towards the goal of combatting global terrorism in a manner that is respectful of the Universal Declaration of Human Rights.

Central to the Universal Declaration of Human Rights are the rights to life, dignity and liberty. These rights must be nurtured, defended, and built upon in our approaches to countering the spread of violent extremism and terrorism.

We acknowledge the ongoing joint efforts, international collaboration, and previous steps taken to address this major global issue, including in the United Nations Global Counter-Terrorism strategy, and in its 7th, and previous reviews. As we bring together public and private sector, academia and civil society we also build towards the meaningful implementation of the objectives set out in New Zealand's [Christchurch Call](#) as signed by companies and governments alike.

Online platforms, governments, transnational organizations and civil society groups have a shared and interdependent responsibility to the users and citizens in governing our online public spaces. In governing these spaces the policies determined by private sector companies impacts more individuals than the policies of any single government in human history.

The ways in which terrorists and violent extremists abuse our shared online spaces is manifold. On platforms of mass communication the issue ranges from the spread of misinformation, conspiracy theories and outright propaganda such as terrorist manifestos, to the live streaming of attacks to vast audiences. Other platforms facilitate coordination among terrorists and their supporters while others may contribute in providing the infrastructure for financing terrorist activities. Through these services and networks online spaces have become central to how terrorists and violent extremists operate.

The objective of this plan of action is to address head-on the conceptual, ethical and practical challenges posed by violent extremists and terrorists through the online spread of harmful materials, and to establish novel mechanisms to counteract the global impact of local terrorist attacks. The aim is to find concrete and actionable solutions to these global challenges through collaborative international efforts across a number of sectors.

Actions

We call on the organizers and participants in the Bergen Conference as well as the wider community of nations, corporations, civil society organizations and individuals to:

1. **Invoke and apply** a tougher and more comprehensive approach to invitement of violent extremism and terrorism rooted in principles of universality. This necessitates a whole-of-society approach, inclusive of individuals, governments, the corporate sector, and civil society organizations providing a wide spectrum of experience, insight and oversight in questions of global governance.
2. **Establish a college of moderators** to increase transparency and accountability surrounding the practice of moderation of violent extremist content with the objective of upholding human rights. Training in recognizing terroristic and violent extremist content in a multitude of languages, and cultural contexts, as well as the mental health and well-being of human moderators is key in ensuring the quality of moderation. To accomplish this a robustly-resourced, independent and interorganizational consortium of moderators is urgently needed.
3. **Establish a rapid response taskforce** to support local authorities in limiting the disastrous impact of terrorist attacks and activities. Such a task force of unaffiliated, independent advisors should advise on media, social media, legal proceedings, law enforcement & security, counselling and mental health, and support in developing long-term strategies, as well as working with relevant leaders in the state or territory under attack to limit the scope of damaging impact. A rapid-response taskforce would not supersede existing protocols (such as GIFCT Crisis-Incident Protocols, the EU Crisis Protocol, and national emergency-services' response), but would streamline, coordinate and assist with crisis-response across sectors through an expert team of experienced and trusted specialists.

4

4. **Establish a global hub for providing support for civil society organizations** and their efforts in contributing to a safer internet through efforts targeting all stages of online radicalization and deliver on the desired objectives and outcomes as stated in the 7th review of the UN Global Terrorism Strategy while holding government and the corporate sector accountable to the principles of the Universal Declaration of Human Rights. This shall be supported by a network established for the sharing of knowledge and best practice for civil society organizations directly engaged in preventing the terroristic misuse of our shared online platforms.
5. **Establish a tech innovation fund** to produce technologies rooted in 'best practice' research and analysis, with the goal of supporting the four aims above. This fund would also enable a better understanding of threats posed by the possible misuse of new technologies and ensure an updated understanding of techniques, methodologies and modus operandi used by terrorists and violent extremists to disseminate their content.

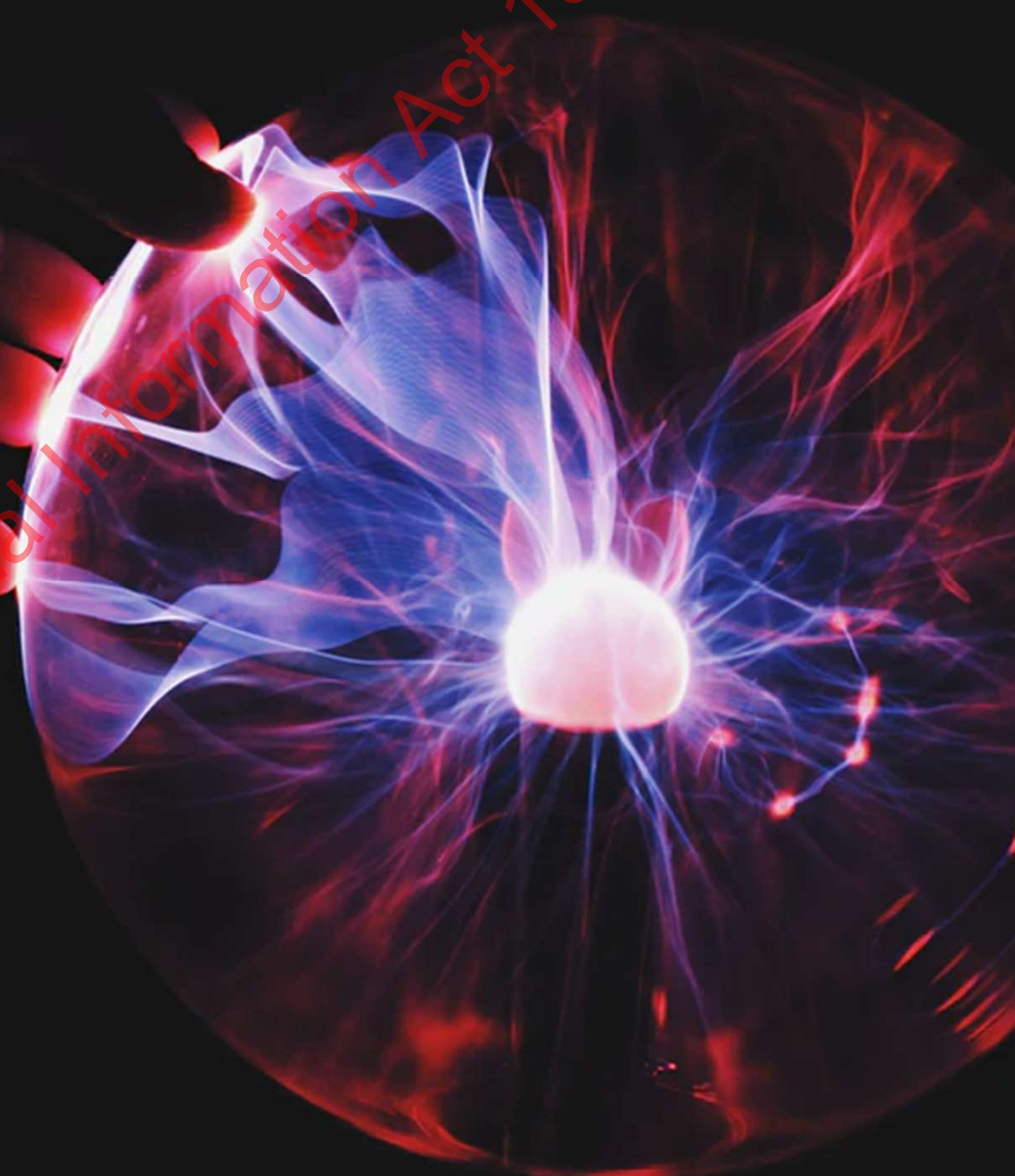

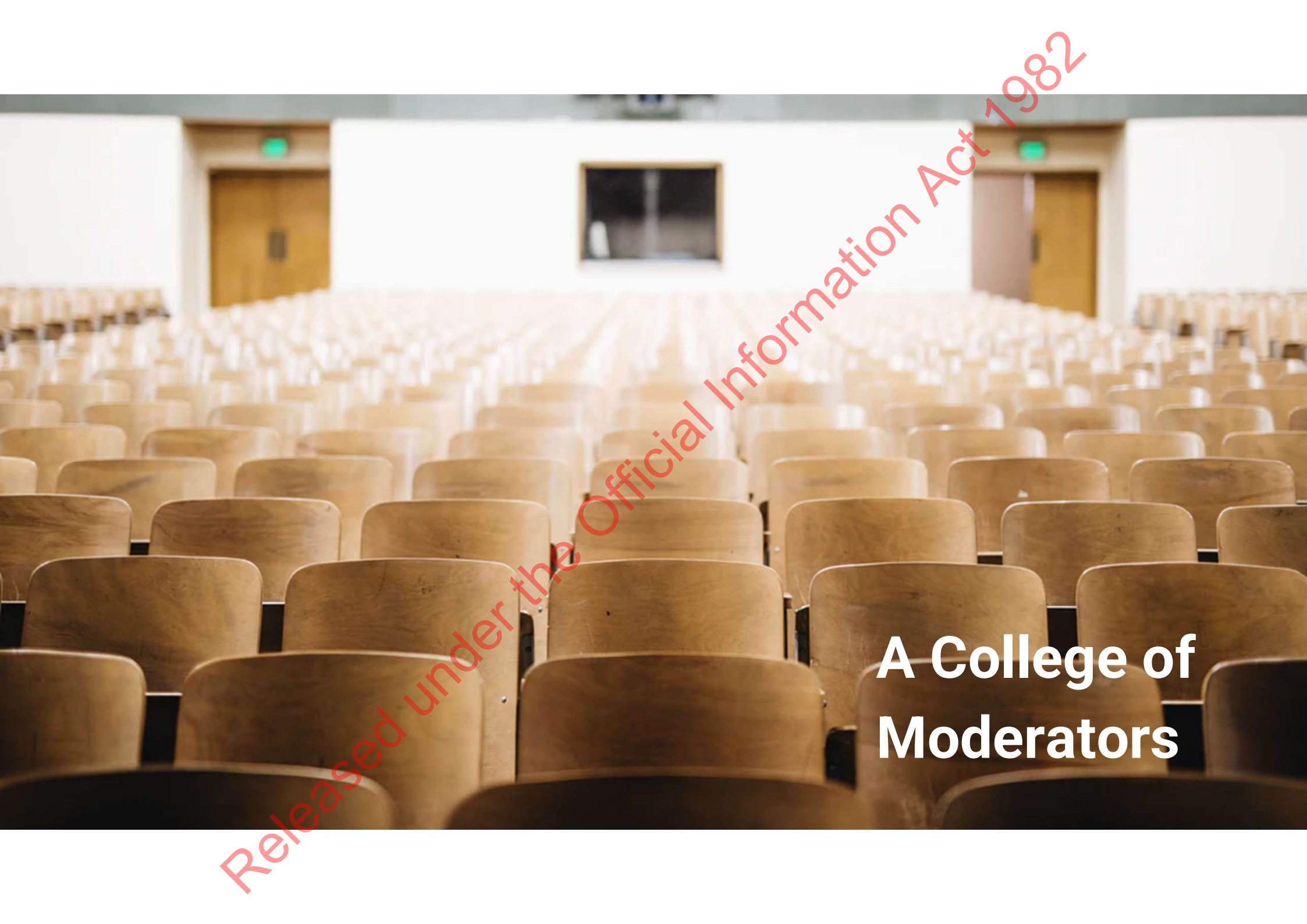

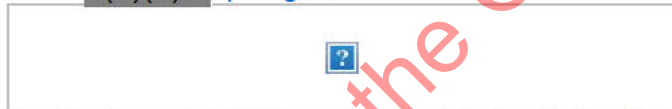
