Tēnā koe AP,

Thank you for your request of 15 March 2024, requesting the following under the Official Information Act 1982 (the Act):

"I request any information held relating to the appointment of Simon Bridges as Chair of the New Zealand Transport Agency. For the avoidance of doubt, this request includes:

- *Advice from the Ministry provided to the Minister regarding this appointment.*
- *Any other correspondence between the Minister and the Ministry concerning the appointment.*
- *Any papers taken to Cabinet regarding the appointment".*

Ten documents fall within the scope of your request and are detailed in the document schedule attached as **Annex One**. The schedule outlines how the documents you requested have been treated under the Act.

Certain information is withheld under the following sections of the Act:

- 9(2)(a) to protect the privacy of natural persons
- 9(2)(f)(iv) to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials
- 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty

With regard to the information that has been withheld under section 9 of the Act, I am satisfied that the reasons for withholding the information at this time are not outweighed by public interest considerations that would make it desirable to make the information available.

You have the right to seek an investigation and review of this response by the Ombudsman, in accordance with section 28(3) of the Act. The relevant details can be found on the Ombudsman's website www.ombudsman.parliament.nz

NEW ZEALAND TRANSPORT AGENCY BOARD - PROCESS FOR APPOINTING A NEW CHAIR

Purpose

Confirm next steps for appointing a new Chair of the New Zealand Transport Agency (NZTA).

Key points

- Dr Paul Reynolds and Patrick Reynolds resigned from the NZTA Board on 6 December 2023. You have sought advice following this decision on the process for appointing a new Chair by early March 2024.
- To achieve the Chair's appointment by this date, the Ministry recommends seeking nominations through public advertisement commencing this week, and targeted searches. The proposed approach involves contacting several experienced Chairs within the transport portfolio and approaching candidates to ascertain their interest.
- We will also be interested in receiving any nominations from yourself or your caucus and coalition colleagues.
- We recommend that appointment of a new board member be carried out separately, after the Chair appointment. This enables the new Chair to be involved in the selection of the new board member, a key factor in achieving the best mix of skills for the board as a whole. This approach will also enable a full appointments process to be undertaken for board members instead of the accelerated process for appointing the new Chair.

NEW ZEALAND TRANSPORT AGENCY BOARD - PROCESS FOR APPOINTING A NEW CHAIR

- 1 Leading the NZTA Board is a challenging and time-consuming endeavour given the breadth of functions of the Agency, the trade-offs that the Board needs to make to give effect to those functions, and the Agency's impacts across New Zealand.
- 2 Successful leadership from the Chair requires:
 - 2.1 political nous
 - 2.2 an understanding of considerations that need to be made at a central and local Government level, and the ability to navigate those interests and influence decisions
 - 2.3 commercial acumen; and
 - 2.4 an ability to take responsibility for the actions of the Board and organisation, and provide considered responses to the range of opinions New Zealanders have about the use or utility of certain modes of land transport.
- 3 A position description is attached as **Appendix One** for your approval.
- 4 While there is a limited pool of suitable individuals who will be interested and available to chair the Board for the fee available (\$78,540 per annum), there are a range of skills and attributes that we can explore further to help determine who should be taken forward for consideration. We will look to discuss these further with you in the New Year as nominations are received and potential candidates are identified.

It is possible to appoint a new Chair by early March 2024, but it will require early agreement with coalition partners


- 5 You have indicated to the Ministry that you would like the Chair appointed by early March 2024. Such a timeline is ambitious and achieving it requires early identification of candidates and efficient coalition consultation. Consultation timelines will also have to be very short.
- 6 A draft timeline for your consideration is outlined in Table One below. This timeline assumes a Cabinet meeting is possible in late February, and that you are comfortable deciding on a short list for consultation with coalition partners in the week beginning 22 January 2024.
- 7 A key dependency for achieving this timeline will be an early signal of comfort by your coalition partners.
- 8 We recommend deferring member vacancies until a new Chair is appointed, but you may wish to also make decisions on the reappointment of incumbent members.

Position Description | Chair, New Zealand Transport Agency

On behalf of the Minister of Transport, the Ministry of Transport is searching for a high-calibre candidate to Chair the Board of the New Zealand Transport Agency (NZTA).

NZTA is a Crown agent under the Crown Entities Act 2004, with responsibility for financial investments in, and the management and regulation of, the land transport system. It is governed by a Board of seven to nine members who are appointed by the Minister of Transport under the Land Transport Management Act 2003.

Competencies sought

The Board requires a full range of competencies across members to be effective. To be considered, candidates must be an experienced Board Chair and possess competencies which complement those of existing Board members. They must bring an understanding of the complexity of operating within a modern transport system.

Section 30(2) of the Crown Entities Act 2004 sets out the criteria for disqualification from membership of a Crown entity board.

You will need to be able to demonstrate most, if not all, of the following qualities and competencies as Chair of the NZTA Board:

- **strategy and culture** – contribute to and drive strategy formulation, direction, implementation and communication and ensure development of organisational culture based on the vision and strategy
- **leadership** – can demonstrate experience in taking responsibility for the effective operation of a Board, ensuring that the Board sets a purpose or vision and articulates organisational values. You should also be able to demonstrate the ability to ask the right questions of management, distinguish between governance and management, and the levels of oversight and leadership required across NZTA's operations
- **experience in the inner workings of Government** – this includes the ability to work with the Minister to problem solve, and navigate issues between the political environment and agency's functions. You should also have an understanding of the political context and relationships within which central and/or local Government is required to operate. Understanding of and agreement to implement the Government's National Policy Statement for Land Transport.
- **able to navigate complex operating environments to deliver results** – this includes being able to manage competing and/or challenging priorities, as well as political and public policy factors
- **judgement and critical thinking** – demonstrated experience of exercising judgement

and critical thinking, preferably within a regulatory environment. In addition, you should be an active listener, open thinker, and be able to draw from your own personal experiences to contribute towards discussions at the Board table

- **able to work collaboratively to reach consensus** – demonstrated understanding of the individual and collective duties Boards possess (particularly within a Crown context), and an ability to reach a collective decision as a Board while respectfully and constructively evaluating each other's personal views on a matter. Accepts the need for collective responsibility for the final decision reached.

In addition, the Minister of Transport expects the Board as a whole to possess the following competencies. Candidates will be expected to demonstrate experience or understanding of one or more these competencies:

- **engineering, planning and delivery** – experience in overseeing and delivering major infrastructure projects particularly as a lead contractor or part of an alliance/public private partnership model. The successful candidate must be able to demonstrate knowledge of the lifecycles of large infrastructure assets, their resilience and security, and their ability to respond to population needs over time; as well as low-carbon construction methodologies. A qualification and experience in engineering or a related discipline is desirable
- **finance (investment and funding)** – deep understanding of funding mechanisms, investment funding models and debt management, including a strong understanding of how funding works. In addition, you must be able to demonstrate an awareness of how organisations should perform effectively and prudently within a given funding envelope
- **procurement** – experience of contract management of large-scale construction contracts on time and on budget
- **governance and strategy** – experience in governance, preferably in both the public and private sectors, with the ability to ask the right questions of management, distinguish between governance and management, and understand and perform governance functions. The successful candidate will be able to engage with a range of stakeholders, deliver on Government policy and direction and have a clear understanding of the role of a governor
- **regulation** – a strong understanding of regulatory functions and powers including senior experience in either a regulated industry or as a regulator. A deep understanding of the fundamentals of a modern regulator and the impacts of regulation is required

NZ TRANSPORT AGENCY BOARD: SHORTLIST FOR CHAIR

Purpose

Confirm the shortlist of candidates to interview for the role of Chair of the New Zealand Transport Agency (NZTA) Board.

Key points

- In OC231034, you directed the Ministry to conduct a call for nominations for the NZTA Chair's role. In response, the Ministry received 55 nominations. Your office has been supplied with a list of all nominees.
- Through our assessment of these nominations, the Ministry of Transport has developed a longlist of potential candidates for the NZTA Chair's role. This list is outlined in **Annex One** and has been developed in consultation with Jo Brosnahan, Chair of Maritime New Zealand who has agreed to support the appointments process.
- From the longlist, we have identified a shortlist of five candidates who we consider best align with the competencies sought on the position description, as well as offering the leadership attributes needed for the role. We recommend these candidates are progressed for interview.
- The Ministry considers that the successful candidate will need to demonstrate:
 - strong collaborative leadership, and the capacity to navigate the wide range of stakeholder relationships the entity possesses;
 - the ability to effectively set the strategic direction, and drive high standards of service delivery;
 - a commitment to focusing on productivity and value for money; and
 - political nous and commercial acumen.

Conflicts of Interest

2. Many of the longlisted candidates have conflicts of interest, which requires exploration to ascertain whether they are manageable should they be appointed to the role.

3. It is important for Chairs to be clear on their understanding of conflicts of interest, as they will be responsible for day-to-day management of Board member conflicts of interest. Crown agents such as NZTA are required to adhere to the requirements of the Crown Entities Act 2004, as well as guidance for managing conflicts of interest in the public sector. This includes the Public Service Commission's Code of Conduct for Crown entity board members and the Office of the Auditor-General's (OAG) Guidance on managing conflicts of interest in the public sector.
4. In recent years, stronger attention has been paid to perceived conflicts of interest – particularly the benefits that could be derived from an individual being privy to the strategic discussions within an entity.

Next Steps

5. Given the short timeframe for this appointment process, we recommend that you consult with your coalition partners on the shortlist for the Chair. Below is the timeline for the Chair's appointments – extra time was built into the shortlisting process for consultation.
6. Once your direction has been received, we will interview the shortlisted candidates as soon as possible and provide further advice on a recommended appointment in early-mid February 2024.

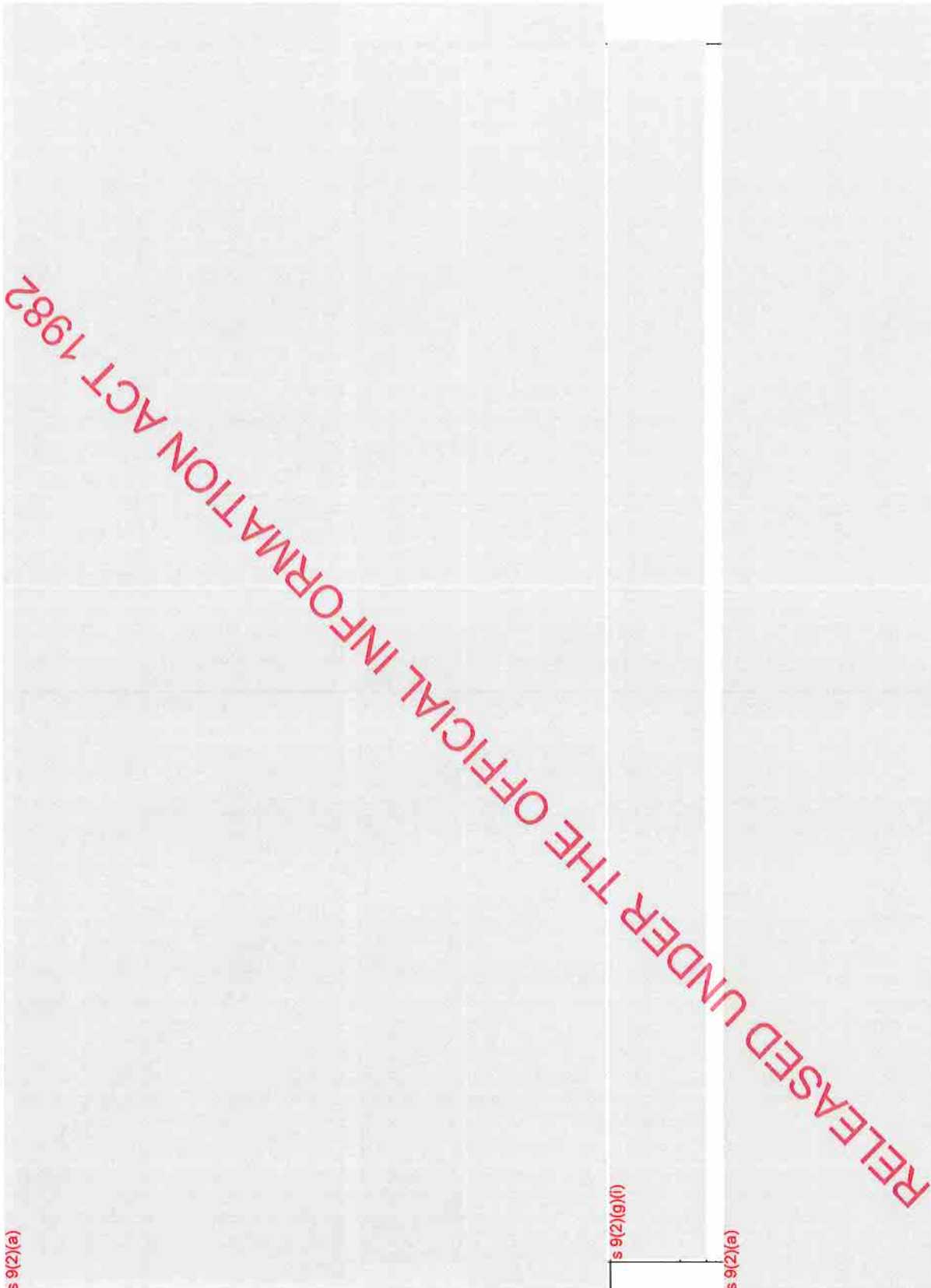

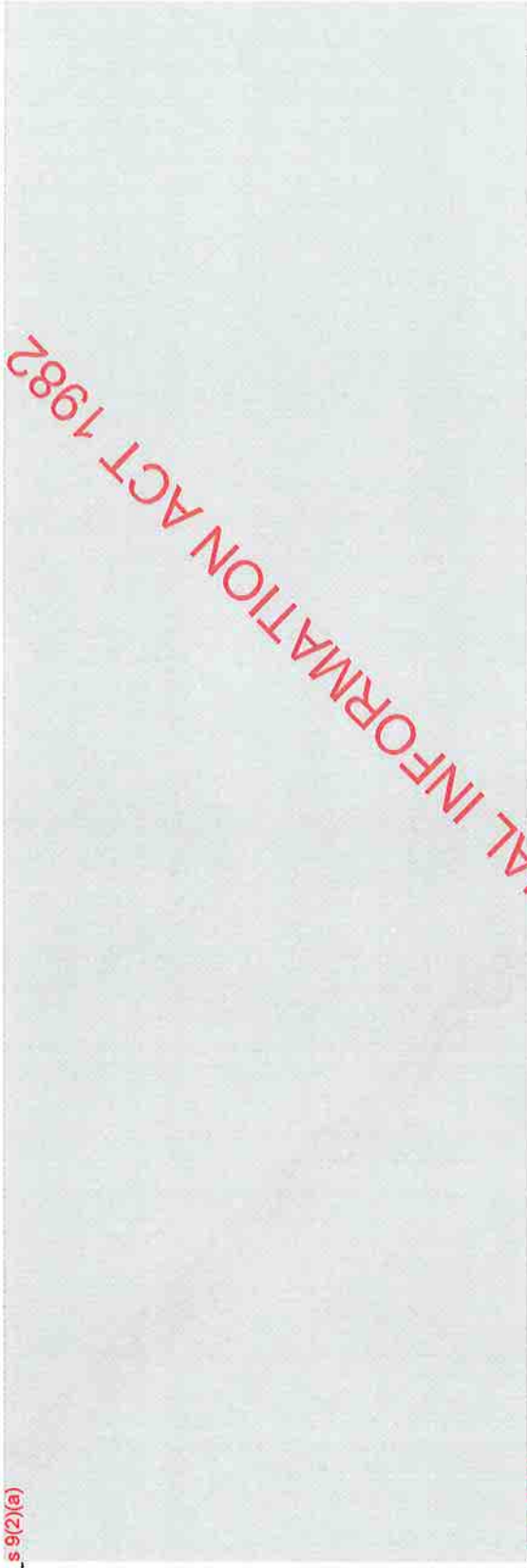

- The candidates would bring different strengths and qualities to the Board. The selection of a preferred candidate will be materially influenced by your priorities for NZTA. In summary:

- 2 A panel comprising David Wood (Deputy Chief Executive, Investment and Monitoring), Harriet Shelton (Manager, Crown Entity Monitoring), and Jane Reid (Principal Adviser, Crown Entity Monitoring) interviewed s 9(2)(a), Hon Simon Bridges, s 9(2)(a) for the NZTA Board Chair role on Friday 2 February 2024.
- 3 The panel considered the competencies identified in the position description, as well as the priorities you communicated in discussions with officials. Each interview focussed on the following themes:
 - 3.1 leadership and vision;
 - 3.2 relationships and influence; and
 - 3.3 how they will get the best out of the Agency – particularly around organisational culture, delivery and achieving value for money in investments.
- 4 The following themes also emerged during the interviews:
 - 4.1 the ability of an incoming Chair to 'hit the ground' running for the effective delivery of Government priorities;
 - 4.2 the extent of change the incoming Chair will look to deliver, and the impacts that will have for the organisation; and
 - 4.3 how the Chair manages key relationships – particularly with yourself, fellow Board members, the Agency's Chief Executive and management, the Ministry and local government.
- 5 Three possible candidates were identified for progression. The choice of a preferred will be significantly influenced by the leadership attributes you prioritise, as well as the degree of change to the Agency focus, operations and culture you are seeking.

10 Hon Simon Bridges is a former Cabinet Minister whose current roles include Chief Executive of Auckland Business Chamber, Chair of National Road Carriers' Chief Executive Advisory Board, and the Chair of the Northern Infrastructure Forum. He is familiar with the operations of the Agency from his time as Transport Minister and considers that he has sufficient capacity (in terms of time) to serve as Chair.

11 Mr Bridges demonstrated a strong focus on collaborative leadership and the economic development opportunities offered by the Agency. He has a strong public service ethos and work ethic.

12 The Panel considers that Mr Bridges is appointable based on his prior transport experience and leadership attributes. He is likely to bring a collaborative style of leadership to the Board. He may, however, take more time to come up to speed with the demands of the Chair role compared to the other appointable candidates. He doesn't possess the same depth of governance expertise and experience leading the board of a large organisation, though he is a quick study and has the capacity to master his brief. He is well placed to navigate the statutory roles played by the Board and you, as Minister of Transport, under the Land Transport Management Act.

13 Mr Bridges advises that he intends to resign from his roles on National Road Carriers and Northern Infrastructure Forum if appointed. Potential conflicts arising from his role as Chief Executive of the Auckland Business Chamber were discussed in detail. Based on the information provided, officials consider that there are no direct conflicts

of interest. This is because the Auckland Business Chamber has a strong delivery rather than policy focus, with advocacy on transport being led by the Northern Infrastructure Forum and the EMA. We noted the Chamber was an active advocate on transport issues during the tenure of Mr Michael Barnett, but Mr Bridges advised us this has not continued under his tenure. The Chamber doesn't have a work programme on transport issues. If appointed to the NZTA Board, Mr Bridges has committed to refrain from making any public statements on transport in his capacity as Chamber Chief Executive. Mr Bridges has yet to discuss his candidacy with the Chamber's Board, but he anticipates they will be supportive.

- 14 While the Ministry accepts the conflict with Mr Bridges Chamber role is more a matter of perception than substance, consultation with land transport representative groups on his potential appointment could see this conflict flagged as an issue. Should he be selected as the preferred candidate we will actively monitor the reaction of industry groups on this and any other potential conflicts, and advise you of any matters of concern.

Proposal

- 1 This paper outlines my intention to appoint the Honourable Simon Joseph Bridges as a member and Chair of the New Zealand Transport Agency (NZTA or the Agency) Board, for a three-year term commencing on the date of appointment.

Background

- 2 NZTA is a Crown agent under the Crown Entities Act 2004 and established by the Land Transport Management Act 2003 (the Act). Its core functions are:
 - 2.1 planning land transport networks
 - 2.2 investing in land transport
 - 2.3 managing the State highway network
 - 2.4 providing access to, and use of, the land transport system.
- 3 The Agency's statutorily independent functions are to:
 - 3.1 determine whether certain activities should be included in the National Land Transport Programme
 - 3.2 approve activities as qualifying for payment from the National Land Transport Fund
 - 3.3 approve procurement procedures for land transport activities
 - 3.4 issue or suspend any land transport document or authorisation
 - 3.5 enforce any provisions relating to its functions.
- 4 Under section 98 of the Act, the NZTA Board must have at least seven, but no more than nine members appointed by the Minister of Transport. Under Schedule 5 of the Crown Entities Act 2004, the responsible Minister may appoint one of the members as Chairperson.
- 5 There are currently seven members of the NZTA Board, following the resignation of Dr Paul Reynolds and Patrick Reynolds on 6 December 2023. A list of the current membership is attached.

Comment

- 6 I intend to appoint the Honourable Simon Joseph Bridges as a member and Chair of the NZTA Board.
- 7 Mr Bridges replaces Dr Reynolds, who previously served as Chair of NZTA. Deputy Chair Cassandra Crowley has acted in the Chair's role since Dr Reynolds resignation, and I thank her for her service in that role during this period.
- 8 Simon Bridges is a former Cabinet Minister whose current roles include Chief Executive of Auckland Business Chamber, Chair of the National Road Carriers' Chief Executive Advisory Board, and the Chair of the Northern Infrastructure Forum.
- 9 I consider that he will bring a collaborative style of leadership to the Board, as well as a strong public service ethos and work ethic. As a former transport Minister, he is familiar with the issues faced by the Agency as well as the work required to lead the Agency in its delivery of Government priorities. He is also adept in networking and building professional relationships and is excited about the economic development opportunities that can be created through the Agency.
- 10 Mr Bridges advises that he intends to resign from his roles on National Road Carriers and Northern Infrastructure Forum if appointed. He has also committed to refraining from making any public statements on transport in his capacity as Chamber Chief Executive and has agreed strategies with the Chamber's Board to manage perceptions of any conflict of interest.

Representativeness of appointment

- 11 I am satisfied the appointment of the Honourable Simon Bridges as Chair will provide for a well-balanced Board in terms of gender, ethnicity, age, geographic representation, and an appropriate mix of skills and experience.
- 12 The appointment of Mr Bridges will result in the board having an equal split of male and female members, a range of ages between mid 40s and early 70s, and two members who identify as New Zealand Māori. Five members are based in urban centres and three members are based in regional towns. Only one member, however, is based in the South Island.
- 13 The collective experience across the Board also covers central and local government knowledge, funding, audit and risk, regulation, land transport engineering, and community perspectives.

Remuneration

- 14 The Board is classified as a Group 3a Level 1 Governance Board under the Cabinet Fees Framework. The current fee for the Chair is \$78,540 per annum, which is consistent with the Fees Framework.

Appointment process and consultation

15 I can confirm an appropriate process has been followed in selecting the proposed appointee, in terms of the Te Kawa Mataaho Public Service Commission's *Board Appointments and Induction Guidelines*. In summary, that process included:

15.1 public advertising of the Chair role, including a detailed position description, on the Ministry of Transport's website, LinkedIn and The Treasury's Board Appointments Database

15.2 seeking nominations from a variety of sources including the Ministry for Women, Te Puni Kōkiri, Ministry for Pacific Peoples, Ministry for Ethnic Communities, Office for Disability Issues, Public Service Commission, caucus colleagues and other networks

15.3 identifying suitable candidates and undertaking due diligence interviews, referee and other background checks, as well as consultation with coalition partners.

16 In addition, section 98(2) of the Act requires that "the responsible Minister must not appoint a board member unless he or she has consulted with the persons, representative groups within the land transport sector or elsewhere, government departments, and Crown entities that he or she considers appropriate." In accordance with this section, the Ministry of Transport will consult the following parties on my behalf following this meeting:

19 Simon Bridges is currently Chief Executive of the Auckland Business Chamber, Chair of the National Road Carriers' Chief Executive Advisory Board, and the Chair of the Northern Infrastructure Forum. All present conflicts of interest to various degrees.

20 Mr Bridges has advised that he will resign from his roles on the National Road Carriers Advisory Board and Northern Infrastructure Forum if appointed.

- 21 Potential conflicts arising from his role as Chief Executive of the Auckland Business Chamber were discussed with Ministry of Transport officials. Based on the information provided, I am satisfied that there is no direct conflict of interest. This is because the Auckland Business Chamber has a strong delivery focus rather than a policy focus, with advocacy on transport being led by the Northern Infrastructure Forum and the Employers and Manufacturers Association. Ministry of Transport officials noted the Chamber was an active advocate on transport issues during the tenure of Mr Michael Barnett, but Mr Bridges advised that this has not continued under his tenure. The Chamber doesn't have a work programme on transport issues.
- 22 If appointed, Mr Bridges has committed to refrain from making any public statements on transport in his capacity as Chamber Chief Executive. He has discussed his candidacy and proposed mitigations with his Board, who are supportive.
- 23 The NZTA Board has strategies in place to manage any conflicts of interest which may arise, including relevant Board members withdrawing from discussions where appropriate. Any conflicts which may arise can be managed in accordance with NZTA's existing practices.

Timing and Publicity

- 24 A media statement may be issued if the appointment is confirmed, and Hon Bridges has been notified. Hon Bridges's appointment will also be published in the *New Zealand Gazette* as per the requirements of the Crown Entities Act 2004.

Recommendation

- 25 It is recommended the Committee notes my intention to appoint The Honourable Simon Joseph Bridges as a member and Chair of the NZTA Board for a three-year term of office commencing on the date of appointment, subject to satisfactory background checks.

Appointment as Chair of the New Zealand Transport Agency

I am pleased to appoint you as a member and Chairperson of the New Zealand Transport Agency (NZTA or the Agency) Board, for a term commencing on 11 March 2024 and ending on 28 February 2027. Please confirm your acceptance of this appointment in writing as soon as possible.

Your appointment is made under section 98 of the Land Transport Management Act 2003 and section 28(1)(a) and Schedule 5 of the Crown Entities Act 2004. A copy of the notice appointing you, which will appear in the *New Zealand Gazette*, is attached for your information.

Responsibilities and Conflicts of Interest

The main legislation relevant to your role is the Land Transport Management Act 2003, the Land Transport Act 1998 and the Crown Entities Act 2004 and I encourage you to familiarise yourself with this legislation. A key element of your obligations is the need to maintain confidentiality with regard to the Board, and Board committee, discussions, and decisions.

As per section 26 of the Crown Entities Act 2004, you must comply with the Board's collective duties (described in sections 49 to 52), your individual duties as a member (sections 53 to 57), your duties as a Chair (Schedule 5) and any directions applicable to the Board under section 103. You are accountable to me for performing your duties as a member and Chair of the NZTA Board.

Your appointment is made on the basis that you have certified that you are not disqualified from being appointed and that you do not have any unmanageable conflicts of interest. I note that the following disclosures have been made in respect of your appointment:

- You disclosed your roles on the National Road Carriers Association and Northern Infrastructure Forum as a conflict of interest, and that you will resign from these roles upon appointment.
- Your role on the Auckland Business Chamber has also been identified for the perceptions of conflicts that arise. To manage this, you will refrain from making statements on transport in your capacity as Chief Executive of the Auckland Business Chamber. You have also advised that you have discussed your appointment to NZTA and proposed mitigations with the Chamber's Board, who are supportive of you undertaking this appointment.

Giving effect to this arrangement will require all parties to act in good faith and in compliance with their agreements and obligations. This includes ensuring there are appropriate internal assurance mechanisms.

Directors are required by law not to place themselves in a position of a conflict of interest other than to the extent allowed under the Companies Act 1993 and the Crown Entities Act 2004. I expect you to follow the NZTA Board's standard processes of declaring and managing any conflicts of interest that may arise during your tenure.

The Government expects a no surprises approach is taken. Should you find yourself in a position where you have, or are likely to be subject to, negative media scrutiny, legal proceedings or any other event that may reflect negatively on yourself, NZTA, or myself, I expect you to inform the Ministry of Transport and I immediately.

Code of Conduct

As a member of a Crown Entity Board, you are expected to comply with the *Code of Conduct for Crown Entity Board Members*, issued by the Public Service Commissioner under section 17(3) of the Public Service Act 2020. The Code of Conduct outlines the principles and behaviours expected from individuals to ensure our entities retain the trust and confidence of New Zealanders. These principles include acting in the spirit of service; acting with honesty and integrity; as well as acting impartially, lawfully and in a politically neutral manner.

I expect you to have read the Code of Conduct, and to comply with it in the course of your duties. A copy of the Code of Conduct is provided with this letter.

Continuation

As per section 32(2) of the Crown Entities Act 2004, you may be reappointed to the NZTA Board. Section 32(3) and Schedule 5 enables you to continue in office as Chair and member despite the expiry of your term until you are either reappointed, or a successor is appointed to your position, or you are informed by written notice that you will not be reappointed, and no successor will be appointed.

Resignation

As per section 44 and Schedule 5 of the Crown Entities Act 2004, should you wish to resign from office prior to the end of your term, you will need to provide written notice to me with a copy to NZTA. The resignation would be effective on my receipt of the notice, or at any later time specified in the notice.

Removal

As per section 36 and Schedule 5 of the Crown Entities Act 2004 I may, at any time and entirely at my discretion, remove you as Chair and member of the NZTA Board. The removal would be made by written notice to you, with a copy to NZTA.

Remuneration

As Chair of the Waka Kotahi Board, you will receive an annual fee of \$78,540. You are also entitled to be reimbursed for any expenses incurred from attending meetings or undertaking any other agreed work. The Board's secretariat will be able to assist you with claims and any taxation matters.

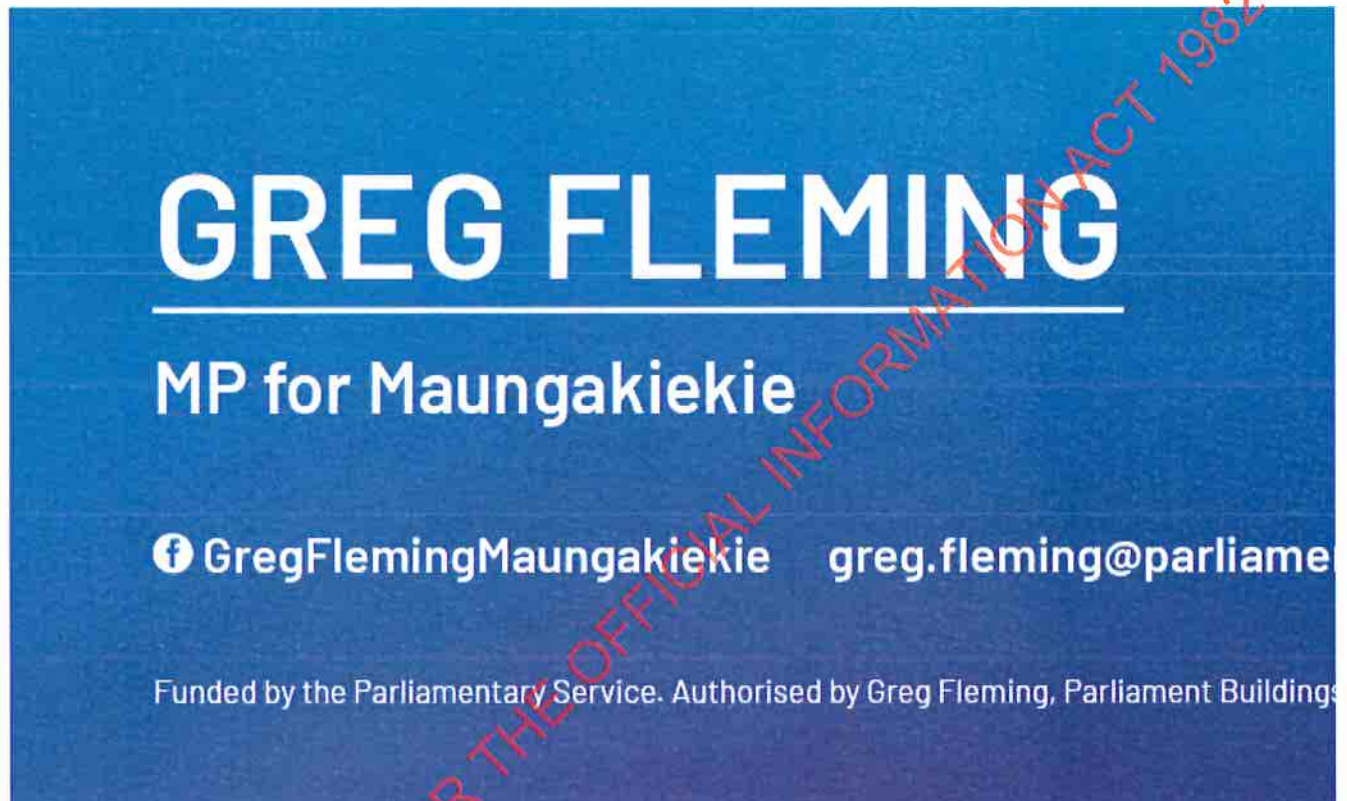

I am writing to seek nominations for the Chair of the New Zealand Transport Agency (NZTA), as part of the search process underway for a new Chair.

A copy of the position description is enclosed with nominations closing at 9am on 15 January 2024.

Background

NZTA is a Crown agent under the Crown Entities Act 2004, with responsibility for financial investments in, and the management and regulation of, the land transport system. The Board has the below responsibilities (a full list of functions is available under section 95 of the Land Transport Management Act 2003):

- setting the strategic direction for NZTA to ensure that it has the right capability to effectively deliver its core roles and functions
- appointing the Chief Executive and holding management to account for the delivery of Government priorities and the organisation's core functions
- providing oversight of NZTA's operational activities to support the efficient operation of the land transport system, including management and maintenance of the State highway network
- providing oversight and management of the land transport investment system, including providing stewardship and oversight of the National Land Transport Fund (NLTF)
- developing the National Land Transport Plan (NLTP) to give effect to the Government's transport priorities set through the Government Policy Statement on Land Transport (GPS)
- giving effect to the responsibilities as a regulator of the land transport system to ensure that NZTA operates as a modern, risk-based regulator that is effectively targeting risk across the land transport system, including regulation of commercial transport operators, rail, vehicle certification, driver licensing and speed management.
- appointing the Director of Land Transport
- ensuring NZTA has robust risk and assurance processes across the delivery of NZTA's core functions and activities, including delivery undertaken by its contractors, suppliers and approved organisations

- making significant planning, investment, and funding decisions
- influencing and contributing to the land transport sector, including supporting urban development, regeneration, and land use planning
- overseeing the development and delivery of major land transport infrastructure.

Competencies Sought

To be considered, candidates must be an experienced Board Chair and possess competencies which complement those of existing Board members. They must bring an understanding of the complexity of operating within a modern transport system.

I would like the successful Chair to be able to demonstrate most, if not all of below qualities and competencies. The Chair will also possess skills relevant to NZTA's core functions.

- **strategy and culture** – contribute to and drive strategy formulation, direction, implementation and communication and ensure development of organisational culture based on the vision and strategy
- **leadership** – can demonstrate experience in taking responsibility for the effective operation of a Board, ensuring that the Board sets a purpose or vision and articulates organisational values. You should also be able to demonstrate the ability to ask the right questions of management, distinguish between governance and management, and the levels of oversight and leadership required across NZTA's operations
- **experience in the inner workings of Government** – this includes the ability to work with the Minister to problem solve, and navigate issues between the political environment and agency's functions. You should also have an understanding of the political and social context and relationships within which central and/or local Government is required to operate. Understanding of and agreement to implement the GPS.
- **able to navigate complex operating environments to deliver results** – this includes being able to manage competing and/or challenging priorities, as well as political and public policy factors
- **judgement and critical thinking** – demonstrated experience of exercising judgement and critical thinking, preferably within a regulatory environment. In addition, you should be an active listener, open thinker, and be able to draw from your own personal experiences to contribute towards discussions at the Board table
- **able to work collaboratively to reach consensus** – demonstrated understanding of the individual and collective duties Boards possess (particularly within a Crown context), and an ability to reach a collective decision as a Board while respectfully and constructively evaluating each other's personal views on a matter. Accepts the need for collective responsibility for the final decision reached
- **an understanding of the role The Treaty of Waitangi plays in the transport sector.**

Appointment term, meeting schedules and fees

Board members are appointed for a term of up to three years. The Board meets monthly from February to December, and the three Board committees meet every two to three months. Board Chairs are expected to work approximately 50 days a year.

Board fees are set according to criteria in the Cabinet Fees Framework. NZTA is classified as a Group 3a Level 1 General Governance Board, with the Chair receiving an annual fee of \$78,540.

If you wish to provide me with nominations for the NZTA Board, please let me know me by 15 January 2024. I also intend to consult with coalition partners further as part of shortlisting, and then of my preferred nominee. It is my intention that this appointment is made in late February / early March 2024.

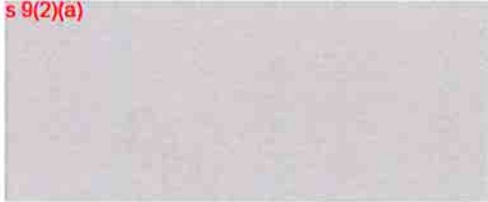

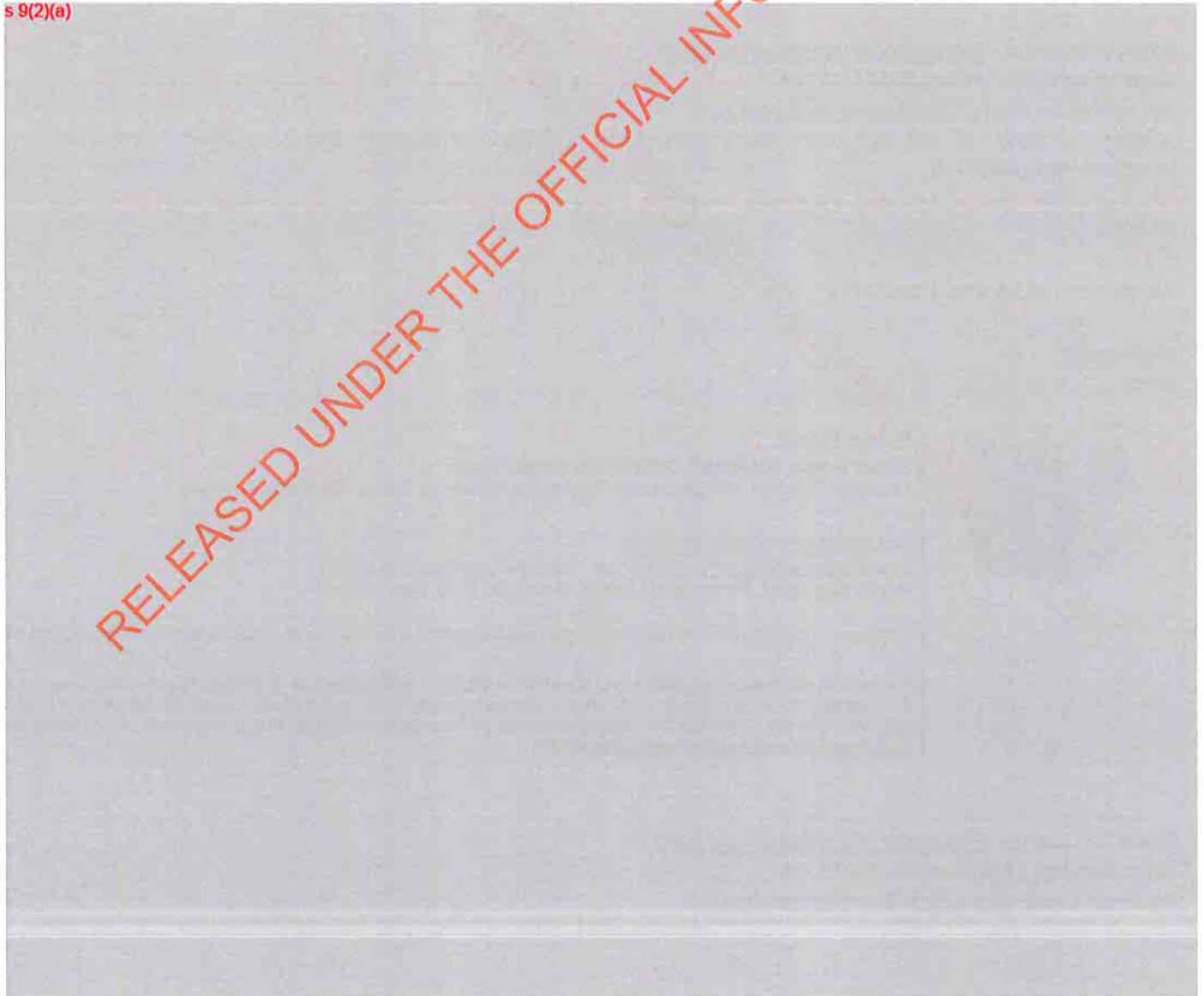

Attached (and linked below) for review and comment is a copy of the draft briefing as well as my interview notes. Hopefully it goes a good way towards meeting the brief of what you are looking for – apologies in advance for any typos/poor sentence construction from tired writing.

I ended up making a few tweaks to the structure from early discussions to put in a few dot points about our post interview deliberations, particularly about the pace someone could take on the role. I haven't written as much on risks, although happy to do so if you want.

I also reflected further on Simon's interview and his description with the Chamber, and think we may still need to do a bit of work to be fully comfortable. The challenge we did not discuss is the potential for the Chamber's Board's strategic direction to change and how it could conflict with NZTA's role. That may never fully absolve him for a conflict and, even if the role is okay now, could provide challenges at a later date. It might be best to also get legal to do a read on Monday morning and I can approach Annelies if needed (she helped a lot with the ALR conflicts).

- **When we communicate the decision to the Acting Chair and then NZTA:** both will need to be prepared for Hon Bridges to take office, and we would like to give an appropriate window of notice that does not pre-empt Cabinet's decision making authority. Because of the statutory consultation process, we propose informing the Chair in advance of that process and then informing select staff in the Agency of the decision following APH. We will also look to inform unsuccessful candidates before industry consultation.
- **Timing of the appointment and announcements:** We will need to have a date for the Gazette notice. We are proposing that the appointment commences on 11 March as this gives the Minister a week to finalise any announcements for the appointment. The appointment can commence as early as 5 or 6 of March pending finalisation of the Cabinet minute and Ministerial availability to sign the letter and Gazette notice.
- **Whether you would like officials to be available for the APH meeting.**

The Cabinet paperwork will be provided with a caveat that the appointment is subject to satisfactory background checks being complete. This is likely to take approximately 10 working days to complete.

You asked for more details on the driving offence that was identified in the background check for the Honourable Simon Bridges.

A copy of the report is attached. Mr Bridges was convicted of one speed related offence in February 2018 for exceeding the 100 km/h posted speed limit. That particular demerit level is received for exceeding the speed limit by more than 20 km/h but not more than 30 km/h.

Demerit points remain active on an individual's licence record for a period of two years from the date of the offence, and an individual needs to accumulate 100 or more active demerit points for their license to be suspended. Further details are available on NZTA's website here: <https://www.nzta.govt.nz/driver-licences/driving-offences-and-penalties/demerit-points/>

Not progressing an individual for appointment on the basis of their driving record is ultimately a judgement call for a Minister. Ministry advice on this matter would balance the following considerations – the repeated nature of offences, and how the offences appear against the Minister's role in stewarding a safe land transport system.

The offence identified in the check is not active on Mr Bridges record, and there hasn't been any record of offences since that time. Mr Bridges did disclose in the interview that he had received one speeding ticket several years ago but that was on the only offence for a long time. We can seek further details from Mr Bridges if required.

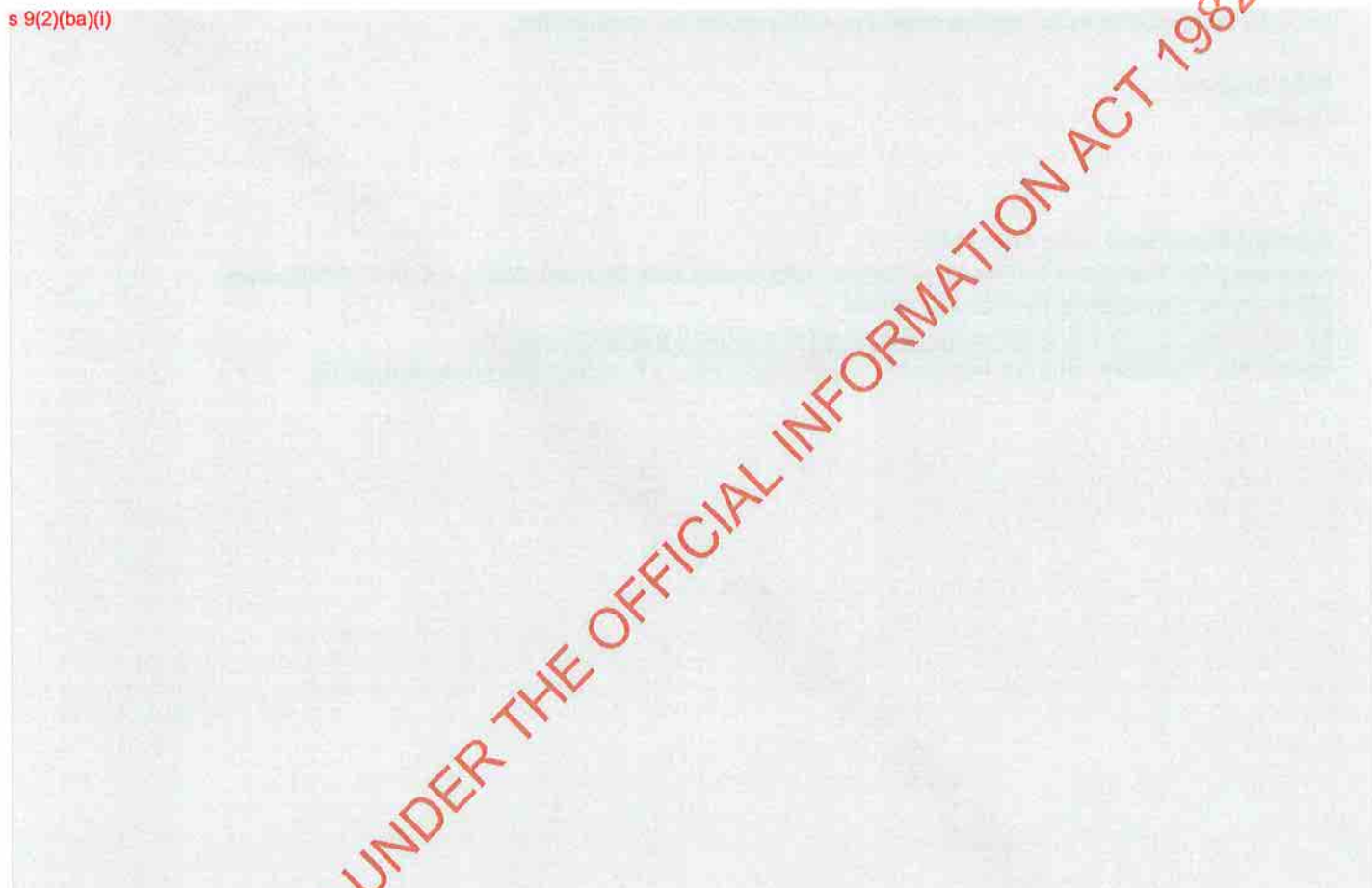

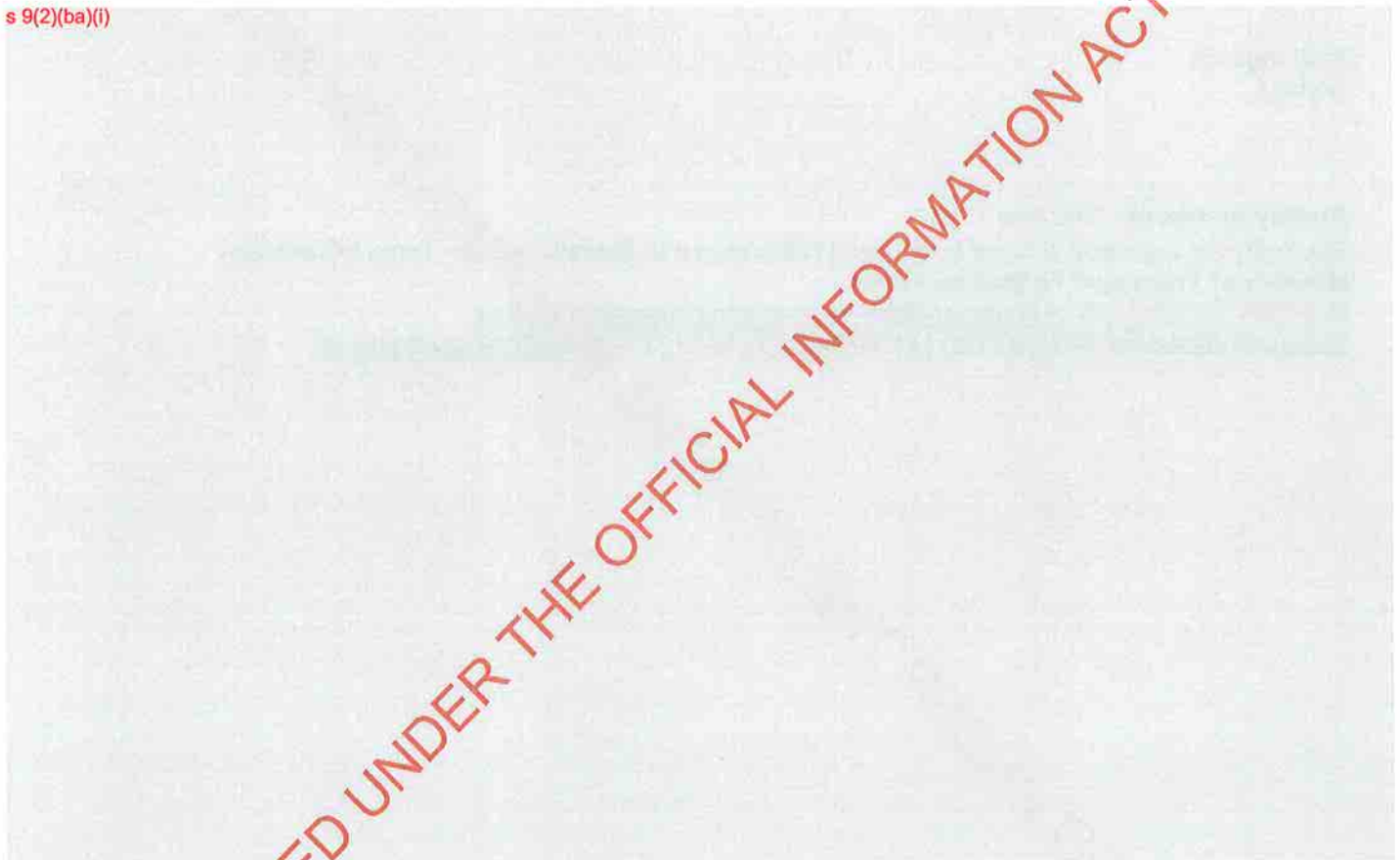
