Thank you for your correspondence of 16 April 2015 requesting, under the Official Information Act 1982 (OIA):

copies of any and all relevant correspondence by or on behalf of the Minister, their office and officials, concerning negotiations and discussions with parliamentary parties, regarding the implementation of the recommendations provided to the Minister of Justice in the 29th October 2012 Report of the Electoral Commission on the review of the MMP voting system.

Inclusive of any responses received, or representations made to, or by, or on behalf of, any representative of a parliamentary political party or their staff regarding the implementation of any or all of the report's recommendations.

I have interpreted this as relating to the period for which I have been Minister of Justice. There has been no such correspondence regarding the recommendations of the review of MMP or the implementation.

Your request is therefore refused under section 18(e) of the OIA as the documents alleged to contain the information do not exist.
