#### Official information request regarding the He Whenua Taurikura National Centre of Research Excellence

I refer to your request for information under the Official Information Act 1982 (the Act) dated 21 September 2024:

# **1.3 Part time roles: Are they employed in other roles at the University and get a separate pay for those. (Double Dipping or two separate work agreements? )**

The Director is employed full time by the university but is on secondment from another role in the University. The Director works 0.8 FTE at He Whenua Taurikura. The remaining 0.2 FTE is with the department from which the Director is seconded. The Centre Manager is employed part time by the university to work in He Whenua Taurikura.

### 2.1 What are their degrees in ? From BA to Post grad please.

Both post-doctoral fellows have degrees to PhD level in fields appropriate to their current research and the work of He Whenua Taurikura. Further information regarding the qualifications of employees is withheld in accordance with s9(2)(a) of the Act in order to protect the privacy of natural persons.

#### 2.2 If new to this area of a study What engagement have, they done to ensure they understand the field of Violent extremism and terrorism? Security? Policing ? talked to police for example. Sought out those academics for discussions? To ensure objectivity and not just write to an agenda.

Post-doctoral fellows were employed on the basis of their doctoral research which is of relevance to the work of He Whenua Taurikura. Post-doctoral fellows engage with other academics in the security, criminology, policing and other fields regularly.

# 2.3 Depending on the degrees above: preventing radicalisation is a major academic field of its own- anyone can see that in a google search and it clearly needs specialist field expertise. What are these two Post grads doing to ensure they obtain that ?

Radicalisation is not an academic field of its own. Both post-doctoral fellows have completed research in the domain of political activism which incorporates radicalisation.

It is anticipated that future policy briefs will be prepared by both He Whenua Taurikura staff and other academics at both VUW and other universities and organisations. He Whenua Taurikura is working closely with the Department of Prime Minister and Cabinet to identify academics from a range of universities to work on policy briefs and other research outputs.

Te Herenga Waka does not "dictate" research. It facilitates research, which is the role of all universities.
