I refer to your request for information dated 17 July 2024 made under the Official Information Act 1982 (the Act). You have requested information in relation to entry to the University of Otago's Health Sciences Undergraduate Professional Programmes in 2024 via the Health Sciences First Year (HSFY) category and the Graduate category, broken down by equity group.

Subject to the following comments, please see below our response to your request:

- With regards to the Bachelor of Oral Health (BOH), Bachelor of Dental Technology (BDentTech), and Bachelor of Radiation Therapy (BRT) programmes, please note:
 - Students in HSFY apply for these programmes via the 1 Year of Tertiary Study category, rather than the HSFY category. They receive an average GPA calculation. This category also includes applicants who have studied one year of a non-HSFY programme.
 - The calculations used for calculating scores for the admissions categories available for each programme are described on our <u>Guidelines for Admission to Health</u> <u>Sciences professional programmes</u> webpages.
- Selection for some of these programmes is determined by additional factors beyond what is
 used for others. For example, applicants are required to provide a CV or attend an interview
 for some programmes, when this may not be a requirement for others. Information about
 selection criteria can be found on the University's website. Due to the differing selection
 criteria across programmes and categories, the data listed below is not indicative of the
 sufficient criteria for an application to be successful for any programme.
- In the tables below, "SPP" refers to "Single Programme Preference". Where available, Single Programme Preference allows students to signal a strong commitment to a particular programme. The Admissions Committees for programmes which allow SPP applications will firstly select from those who apply under SPP. Thereafter if domestic places are still available, the Committee will select from the group of applicants that have applied to multiple Health Sciences Undergraduate Professional Programmes.
- On occasions where fewer than five students were admitted under a category and/or equity group, we have determined that it is necessary to withhold the admission score information for these students to protect their privacy and wellbeing pursuant to section 9(2)(a) of the Act. We consider that withholding this information is necessary to protect against the identity of these students being determined or inferred, and their personal information (i.e., their scores) being disclosed. In the tables below, information withheld will be indicated using "W/H", and "N/A" will be used where no applicants received offers.
