Dear Dan,

Your Official Information Act 1982 request reference OIA24-309

I am responding to your email of 23 July 2024 requesting the following under the Official Information Act 1982 (the Act):

"I request all advice you have received regarding the decision to reinstate polls on Māori wards in the Local Government (Electoral Legislation and Māori Wards and Māori Constituencies) Amendment Bill."

I am interpreting your request to be for the time period of 27 November 2023 (when Ministers were sworn in) to 23 July 2024 (when your request was lodged).

There are 14 documents that fall within the scope of your request. A list of these can be found in **Table one**.

I am partially releasing nine documents. Some information has been withheld under the following sections of the Act:

- 9(2)(a), to protect the privacy of natural persons;
- 9(2)(f)(iv), to maintain the confidentiality of advice tendered by Ministers of the Crown and officials:
- 9(2)(g)(i), to maintain the effective conduct of public affairs through the free and frank
 expression of opinions by or between or to Ministers of the Crown or members of an
 organisation or officers and employees of any public service agency or organisation
 in the course of their duty;
- 9(2)(h), to maintain legal privilege; and
- 18(d), as the information is or soon will be publicly available.

These documents are attached as Appendix A.

I am withholding five documents under section 18(d) of the Act as they are publicly available in the local government section of the Department of Internal Affair's proactive release website: www.dia.govt.nz/Proactive-Releases.

As is required by section 9(1) of the Act, I have given consideration to whether the withholding of information is outweighed by other public interest considerations which would make it desirable to make this information available. In this instance I do not consider this to be the case.
