Hi Andrew

I may have promised a bit too much in terms of a 'significant' block of analysis in the IPCC draft.

I attach CLASSIFICATION the draft chapter on energy systems (chapter 6), which includes studies on the role of nuclear power in climate change mitigation. It's brief though (mainly section 6.4.2.4). Also chapter 3, which takes more of a long-term integrated systems view, and includes an assessment of the relative contribution of nuclear power in different mitigation scenarios (noting that some scenarios deliberately exclude nuclear power). Just search for "nuclear" to get to the most relevant sections.

I hope this is at least a useful starting point. Note that this is obviously only a draft that might still be changed substantially, subject to global government and expert review. So do not cite or quote from this draft please, but you can certainly use it as an overview of (some of) the relevant scientific and technical literature on nuclear power in the context of climate change mitigation.

I hope this is useful – let me know of any follow-up questions please.
